



## **GLOBAL DEBT SOLUTION MEMBERSHIP NETWORK (GDSMN) AGREEMENT**

THE GDS MEMBER FURTHER UNDERSTANDS THE MEMBERSHIP NETWORK IS NOT A PARTNERSHIP, NOT A CORPORATION, NOR A BUSINESS VENTURE; AND THAT THE MEMBER IS COMPLETELY AND SEVERELY LIABLE FOR ANY USE AND APPLICATION OF ANY MATERIAL, KNOWLEDGE, OR INFORMATION GAINED OR SHARED THROUGH THE MEMBERSHIP NETWORK. IT IS FURTHER UNDERSTOOD, THAT SUCH KNOWLEDGE AND INFORMATION IS NOT TO BE MISCONSTRUED AS LEGAL ADVICE AND THAT OTHER MEMBERS OF THE NETWORK DO NOT CLAIM TO BE ATTORNEYS. THE GDS MEMBER REPRESENTS THAT HE/SHE IS NOT AN AGENT OF ANY GROUP OR ORGANIZATION THAT WILL PURPOSELY ATTEMPT TO SUBVERT THE GDS MEMBERSHIP NETWORK. THE GDS MEMBER WILL NOT USE, OR CAUSE TO BE USED THE INFORMATION SHARED AS A BASIS FOR ANY LEGAL OR SUBVERSIVE ACTION AGAINST THE GDS MEMBERSHIP NETWORK OR ANY MEMBERS FOR THEIR LAWFUL ACTIVITIES.

THE REFERRER UNDERSTANDS THAT AS A MEMBER IN GOOD STANDING, THEY ARE ELIGIBLE TO PARTICIPATE IN THE ACTIVITIES OF THE MEMBERSHIP NETWORK. THE GDS MEMBER AGREES NOT TO COPY AND/OR DISTRIBUTE, BY ANY MEANS, COPYRIGHTED DOCUMENTS WITH THE INTENT TO DEFRAUD GDS OR ANY OF ITS AFFILIATES OR ANY MATERIALS COPYRIGHTED BY GLOBAL DEBT SOLUTION AND OR ITS AFFILIATES. COPYING DOCUMENTS PROVIDED FOR SPECIFIED MARKETING PURPOSES IS ACCEPTED WITHIN THE SCOPE OF A WRITTEN APPROVAL FROM GDS.

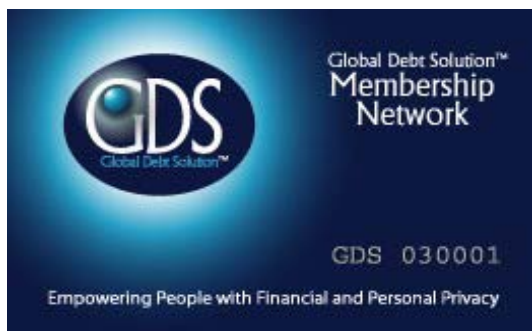
