The Libertarian Party of Ohio has selected its new leadership team in preparation for the millenium. State officers, elected at the annual convention in May, include Chair Jim Babka (Akron), Vice Chair Dena Bruedigam (Columbus), Secretary C.W. Parker (Dayton), and Treasurer Ronda Birr (Alexandria). All but newly elected Bruedigam retained their leadership posts from the previous year.

In his nomination speech for Babka, Chair Emeritus Jack Matheney (Riverside) expressed confidence that his reelection would continue the substantial membership growth and increased fundraising experienced under Babka's leadership. With cheers of approval, Babka was reelected by voice acclamation.

Babka, in his recent "State of the State Party" address, indicated his desire to build a candidate centered party. Achieving full party status in Ohio and recruiting candidates for office will be key to the party's success. Party leaders have set a goal of 100 Libertarians running for public office in the year 2000. "Imagine having 100 Libertarians running for office. How many people will hear these candidates or get their literature? One million Ohioans could be hearing or reading the Libertarian message, maybe for the first time ever," said Babka.

The LPO executive committee also made several reappointments in important leadership positions, including Matheney's selection as Development Director. Membership Director Frank Seipel (Gahanna), Information Services Manager Rob Logan (Cleveland), and Newsletter Editor Jules Smith (Grandview Heights) will also continue in their roles. In addition, Chairman Babka recently announced the leadership team had been enhanced by the new appointments of Legal Counsel Tony Siciliano (New Middletown), Campus Coordinator Brian Gomez (Cleveland), and Media Director Pearl Pullman (Streetsboro).

The Libertarian Party—known as the "Party of Principle"—champions all issues of freedom and advocates reduced government and taxes.
