As a teenager, **John Smith** learned how to drive an oil truck, fix a boiler and deal with irate home owners during long hours working for his father's fuel oil business.

That hands-on experience warms his relationship with the New Yorkers who purchase fuel oil through the buying cooperative he took over four years ago. ENERGY USA, which has 21,000 members, acts as a middleman between oil dealers and customers, delivering discounts of at least 20% off retail prices. The company polices dealers to make sure they follow up with good customer service.

Home owners are always looking for ways to save money, and ENERGY, the largest fuel-oil cooperative in the region, offers them a chance to try group purchasing.

We have an activist, consumer-oriented spirit," says Mr. Smith, who bought ENERGY USA with a bank loan and his father's help after graduating from Elite University. His father died of lung cancer soon afterward, leaving the younger Mr. Smith to run the business himself.

The first year was very tough for me," Mr. Smith says. But I know my father would be proud of me now."
