United Nations Headquarters (13 April 2005)

The above Convention was adopted on 13 April 2005 during the 91st plenary meeting of the General Assembly by resolution A/RES/59/290. In accordance with its article 24, the Convention shall be open for signature by all States from 14 September 2005 until 31 December 2006 at United Nations Headquarters in New York. The Convention will be open for signature on the first day of the *Focus 2005 Treaty Event: Responding to Global Changes*.

The Secretary-General takes this opportunity to recall that, under established international practice, only Heads of State, Heads of Government or Ministers for Foreign Affairs are empowered, by virtue of their functions, to sign a treaty on behalf of a State without having to produce full powers to that effect. Other representatives wishing to sign a treaty must be in possession of appropriate full powers, which expressly authorize signature of a specified treaty by a named representative issued by one of these authorities.

The Secretary-General would be obliged if States wishing to sign the Convention could notify, and provide copies of the required full powers in advance to the Treaty Section, Office of Legal Affairs, at United Nations Headquarters in New York (tel. 1 (212) 963-5047; fax 1 (212) 963-3693; e-mail treaty@un.org).

All other representatives wishing to sign treaties must be in possession of appropriate full powers which expressly authorize signature of specified treaties by a named representative, issued and signed by one of the above authorities. Likewise, instruments of ratification, acceptance, approval or accession must be issued and signed by the same authorities. Delegations wishing to undertake treaty actions during the treaty event are advised to contact the Treaty Section well in advance for appropriate arrangements to be made.

Necessary facilities, including media coverage, will be made available for treaty actions to be undertaken in a solemn setting. Further information concerning the requirements for full powers and the deposit of instruments of ratification, acceptance, approval or accession (including model instruments) can be found in the *Treaty Handbook*.
