Senepis Block (B1004, Map 1)

Group 'Bm' is logging in the natural forest without having any logging permit from the government.

Based on Forestry Law No.41 Tahun 1999, article 50 clause (3) point (e) everyone is prohibited to log or harvest forest products inside forest without having proper permit or license from the authorized government body.

Kerumutan Block (B4004, Map 2)

PT. Bina Duta Laksana posses License of Industrial Timber Plantation (IUPHHK-HT) issued by Head of District of Indragiri Hilir No.17.A/TP/VI/2002, on June 2002, which consist of 30,405 hectare. Eyes on the Forest field investigation found that the company logging operation is located inside productive natural forest.


Based on Government Regulation No.34/2002 article 30 clause (3) and Ministry of Forestry Decree No.21/Kpts-II/2001 of 31 January 2001 about Criteria and Standard of Industrial Timber Plantation or IUHPHHK-HT, industrial timber plantation can only be developed in bareland, grassland or shrubland. In addition, Kerumutan forest block also consists of more than 3 meters depth peat swamp.

Kuala Kampar Block (B3003, Map 3)

CV. Alam Lestari is logging in the natural forest under the license of Industrial Timber Plantation (IUPHHK-HT) issued by the Head of Pelalawan District on 30 January 2003. The Eyes on the Forest investigation confirmed that PT Riau Andalan Pulp and Paper (RAPP), a pulp subsidiary of Asia Pacific Resources International Holdings Limited (APRIL) in Riau, received and stored timber from the logging site of CV Alam Lestari (see CoC B3003)




Map 1. Senepis Block Chain of Custody






Map 2. Kerumutan Block Chain of Custody
