*** A new perspective - Internet Gambling - Legal or not? ***

Following my posting of the report by Michael G. Cohen, "Legality of Internet Gambling in the United States" (dated May, 2005), Mr Warren R. Markowitz from the Touro Law School (NY, USA), Class of 2005, contacted me.

He said "I am glad to see that someone other than me has taken the time to investigate and write about this issue...in case you would be interested in placing another perspective on the issue, I am enclosing my paper".

Warren has also compiled a very well-researched paper covering the issue of Internet Gambling within the United States. Completed in December 2004, it is titled "Internet Gambling - Legal or Not?" This also covers jurisdictions outside the US, land based gambling vs. online casino style gambling, a proposed regulatory framework, amongst other topics.
