If Advertiser is both a corporation, limited liability corporation, non-profit organization, partnership or sole proprietorship and an agency, direct buyer or buying service, both parties shall be jointly and severally liable for all payments. Payment for the above-mentioned services shall be due and payable within thirty (30) days from the date of invoice relating thereto.

Provider reserves the right to accrue interest at 1.5% per month on balances in excess of thirty (30) days outstanding. Payment terms are stated on the invoice.

Advertiser hereby authorizes The Dispatch Printing Company to provide Advertisers advertising in accordance with The Dispatch Printing Companys credit terms. The Dispatch Printing Company's sales personnel and/or account executives are not authorized to alter or negotiate credit terms, terms for payment of past due debts, or any other arrangements for payment.

Advertiser agrees to give the Credit Manager of The Dispatch Printing Company thirty (30) days written notice, by certified mail or registered mail, of any change in the ownership of the Advertiser and of any change in the proprietary interest or active participation in its business by any undersigned grantor.

Advertiser warrants that all advertisements submitted for broadcast or publication will be truthful, not libelous or slanderous, will not invade the privacy of others, and will comply with all federal, state, and local laws and regulations. Advertiser agrees to indemnify The Dispatch Printing Company and hold them harmless from any and all claims, actions, suits, proceedings, costs, expenses, damages, and liabilities arising out of, connected with, or resulting from any advertisement broadcast or published at Advertiser's request.
