#### **Governor Rendell Signs Common Law Marriage Bill**

On November 23, 2004, Governor Rendell signed into law HB 2719, abolishing common law marriage. The new law states that "[n]o common law marriage, contracted after January 1, 2005, shall be valid." The law further provides that it does not invalidate an otherwise lawful common law marriage contracted on or before that date. As a result, most, but not all of the issues presented by a series of court decisions relating to common law marriage have been resolved.

The principal issue remaining is how courts will treat common law marriages entered into after September 17, 2003 and before January 2, 2005. On September 17, 2003, the Pennsylvania Commonwealth Court, in PNC Bank Corp. v. Workers' Compensation Appeal Board, purported to abolish common law marriage, asserting that "henceforth, this court will recognize as valid only those Pennsylvania marriages entered into pursuant to the Marriage Law procedures." Although the Commonwealth Court stated that its decision was to have "purely prospective application," it was unclear whether the court meant to abolish only marriages entered into after the date of its decision or the enforceability of all common law marriages, even those existing at the time of its decision, with respect to matters arising after the decision. It was also unclear whether the Commonwealth Court would be seen as having the authority to abolish common law marriages in Pennsylvania.

The question as to whether other courts would follow the Commonwealth Court's decision came into focus this spring when, in Bell v. Ferraro, the Pennsylvania Superior Court declined to treat common law marriage as abolished. More recently, in Stackhouse v. Stackhouse, the Superior Court specifically preserved the validity of common law marriages entered into on or before September 17, 2003. As to common law marriages contracted after September 17, 2003, the Superior Court was vague, stating that their validity may be questioned.

Thus, it is clear that common law marriages could be established in Pennsylvania on or before September 17, 2003 and that common law marriages may not be established in Pennsylvania after January 1, 2005. It remains to be seen whether the relatively bright line drawn by the new legislation will convince courts to recognize common law marriages entered into after September 17, 2003 and before January 2, 2005.

Comments. In light of these recent developments, we believe an employer with Pennsylvania employees should review its plan documents, communications, contracts, policies and administrative practices and consider how it will address issues relating to the establishment of common law marriages in Pennsylvania as they arise.
