That's a good question. I don't want to give you some cold marketing answer or polished corporate double-speak so let me answer in my own words.

I find many people think of armed uniformed SWAT guys when they see the word Anti-Terrorism but that is far removed from what CAG is involved in. Anti-Terrorism is a very broad field. Much more of the field is about preparedness, risk mitigation, architectural design, HAZMAT handling, business continuity, first responders, fire protection, industrial safety etc. etc.

The 9-11 commission strongly recommended that private business enterprise adopt NFPA 1600 as a model for businesses readiness. They effectively created this service market. (Here's a copy of NFPA 1600 online: http://www.nfpa. org/PDF/nfpa1600.pdf?src=nfpa) For a typical business client we would conduct a NFPA 1600 audit then work with them to bring their enterprise up to standard. This type of service is a rapidly growing field as more and more businesses come to realize their liability if they are non-compliant.

While involved in the audit, we identify all the areas that need to be addressed to really provide effective safety beyond the guidelines of the NFPA.

We them present a complete systems approach to overall security and safety and leave it to the client to decide what needs to be done. CAG does not accept any sales commission or gratuity from any vendor so our recommendations are based on the most effective solution rather than product specific advice.

Most importantly let me stress that we never provide any type of armed protection service. It is likely that in some projects we will identify the need for security officers as part of the overall systems approach to management but we will never provide those services.

What we do is valuable but not glamorous. I live in Tampa, Florida and have for the better part of 25 years. I'm a single Mom living with a ten year old son and an 8 year old precocious daughter. I love them dearly and feel that I should maintain a private life separate from work for their security and mine. No one has the right to snoop into our personal life.

Kathryn, woman to woman let's cut the

proverbial crap and get down to the heart of your suspicion of CAG; Jordan Sage-Thomas, a young highly educated woman with an overactive imagination. I had lunch with Jordan today and she confessed that she had been checking us out. She told me she emailed you about Top Cat and the relationship she assumed we had with the company.

There is no relationship between CAG and Top Cat. CAG, working with the Haitian National Police and Coast Guard, has delivered a comprehensive proposed solution to Haiti's totally ineffective Customs control and interdiction problems. In a country as desperately poor as Haiti, where 86% of it's lawfully imposed customs tariffs are lost to blackmarket smuggling through unregulated ports, our proposal would not only be self funding and self sustaining - it would generate 17 million dollars a year over the cost of implementation, maintenance and operations. The only mention ever made of Top Cat in our proposal is a recommendation that seven 31 to 34 foot speed boats, of a type similar to the specs for a Cobra brand Predator patrol boat, marketed by Top Cat Marine, be used as the water based enforcement option in our overall plan. We also recommended that the Haitian Coast Guard use US government, DEA funding to lease and operate a SeaWolf Amphibian Patrol Plane to detect smuggling operations and provide Search and Rescue assistance. We are not connected to Top Cat or SeaWolf; they just make great tools. The plan we submitted would greatly serve US interest by cutting the transnational shipment

of drugs through Haiti by 40 percent.

We never had these headaches before your blog. YOU created this unwelcome, unnecessary and undesirable publicity for us. We never had a web site before and don't need one now but 2 weeks ago you could Google CAG and find nothing. She's against democracy but of course she headed straight to the Miami from here. Puello was detained for questioning by Dominican authorities and her status is unclear. Both "ladies" agreed to give full access to their accounts and phones in order to fully confirm the extent of their treachery rather than be subject to further legal consequences. What were you thinking calling a foreign country on an open phone line? Caller ID is not just in the US and you have your number published on the Internet for everyone to see. BONUS TRACK: A LETTER TO A THIRD PARTY FURNISHED TO ME BY AN INTELLIEGNCE SOURCE

This is a confidential reply to your email. I'm going to break out the questions you posed and answer them one by one rather than comment on everything you've said. I'll keep it short as I am busy elsewhere and it's very late here.

1. NFPA 1600 Audits - We are not doing these in Haiti.

2. We are not working for any US government agency at this time. However we are actively pursuing DHS contracts in the US and USAID research projects overseas.

3. Whatever information you think you have on CAG is probably incorrect or fabricated if the source traces back to Dr Jordan Sage-Thomas, her Dominican girlfriend or Kathryn Cramer. Everything these three are circulating is bogus. Sage and her girlfriend are agent provocateurs for the terrorist group ADLN working to further destabilize and obstruct the painful election process in Haiti. Cramer is at best a foolish complicit dupe in that affair.

4. CAG is not involved in any type of interdiction services anywhere. I can't even guess where you

would come up with that.

5. CAG is not "schooling" any local nationals in Haiti. We may succeed in getting some US State Department funding for training the Haitian National Police but that is a very forward-looking possibility for 2007. The current PNH has essentially collapsed in on itself unable to make payroll and many of its patrol cars are parked in major intersections without gas.

6. We have a sub-contract under a Haitian firm for a reorganization study of the DGI (Haitian Customs) paid for by the Inter-American Development Bank. We have already presented a plan to restructure and resurrect that totally corrupt and ineffective organization and replace it with legitimate revenue generating tax and tariff collection agency that will replace 65% of the Haitian government's dependence on foreign financing to stay afloat. Currently 85% of all legitimate taxes wind up in the pockets of DGI officials.

<<CONFIDENTIAL>> We also have a prime contract with a South American military force to advise on "Multinational Joint Missions Activity Coordination" in their role within MINUSTAH. We are also actively involved in consultations to manage the flow and production of actionable intelligence against the criminal gangs that run much of the country now.

We are providing security intelligence for 2 multinational financial organizations as part

of a long-term sub-contract under an American firm.

Finally, we are working on a proposal to renovate Haiti's aviation services industry and the international airports in PAP and Cap Haitien. We are still doing the legwork and vulnerability assessments on this project but it looks rather good.

7. Peter Casini. I don't know the man and until Kathryn Cramer started accusing us of working with him I had no idea who he was. CAG likes their boats for the DGI project and we can get the same boats (if we have a buyer) from a Panamanian company that mimics their design. Top Cat has never been a vendor or partner with CAG or anyone in CAG.

I think I covered everything you asked about. Anything else?
