ALL-PARTY GROUPS IN THE HOUSE OF COMMONS: SUBJECT GROUPS

21st March 2006

Introduction

All-party groups are unofficial, and have a membership of backbench Members of the House of Commons, or of both Houses. They are classified either as **subject groups** (relating to a particular topic eg. forestry) or **country groups** (relating to a particular country or region). The groups tend on the whole to cover subjects which are not generally contentious in party terms. These groups flourish and wane according to the interests and enthusiasm of Members and with the topicality of various subjects. They reflect the interests of the day and therefore may change frequently. Over the years since 1945, it has been argued, less and less influence has been exerted by backbench Members in the formulation of government policy, and there has been insufficient consultation between backbenchers and Ministers. All-party groups can sometimes serve as a counterbalance to this. They have a liaison function and can, when necessary, exert pressure on a Minister to modify policy or influence legislation and further action in particular areas. They thus play a part in the flexible pattern of consultation that Governments nowadays employ in order to sound out views both inside and outside Parliament.

To sum up, all-party groups may draw attention to certain aspects of public affairs, may assist in keeping the Government informed of parliamentary opinion, and may act as pressure-groups to promote some particular cause. And as Peter Richards said (in *The Backbenchers*; Faber & Faber, 1974) ... *Non party activity is important, for it ensures that parliamentary life is not wholly dominated by party feeling. It helps Members to appreciate the qualities of their political opponents, and to establish yet more firmly an underlying consensus about the value of parliamentary institutions.*

Status of Groups

The Register of All-Party Groups exists as a result of a Resolution made by the House on 17 December 1985 which stated that:

"Commons officers in All-Party Groups, Parliamentary Groups, and Groups whose membership is open to Members of either House of more than one party, be required to register the names of the Officers of the Group, and the source and extent of any benefits financial or in kind from outside sources which they may enjoy, together with any other

relevant gainful occupation of any staff which they may have. Where a public relations agency provides the assistance, the ultimate client should be named".

In 1995, the Administration Committee conducted an inquiry into All-Party Groups; the report was published in session 1995/96 (HC 494) and provides useful background to how groups were set up and organised. The Approved List of All-Party Parliamentary Groups and Associate Parliamentary Groups, which is distinct from the Register, exist as a result of a Resolution made by the House on 31 October 1984. It is a means of regulating the use made by groups of the House's facilities and status. A group cannot be approved without first being registered. Groups may choose whether or not they wish to apply for inclusion on the Approved List but only groups which are on the List may enjoy the following privileges:

- use of the words *All-Party*, *Associate*, and *Parliamentary* in the group's title
- use of the All-Party Notices to advertise all meetings
- priority when booking rooms in the Palace of Westminster over groups which are not on the Approved List

For groups on the Approved List, where only Members of the House of Commons or Lords have voting rights, the group must include the words *All-Party Parliamentary Group* (shown in the text as APPG) in its title; otherwise it must include the words *Associate Parliamentary Group* (shown in the text as APG). Groups which are registered but not approved must omit the words *All-Party*, *Parliamentary* and *Associate* from their title (shown as neither an APPG nor APG in the text).

Before it can be included on the Approved List a group must give a written undertaking to comply at all times with the rules listed in the Declaration below.

DECLARATION

1. The group's membership is open to all Members of the House of Commons and Lords and its aims and constitution are parliamentary in character.
2. The group's membership will at all times include at least ten Members from the Government party, together with ten from the other parties (of which at least six must be from the main Opposition party); those numbers may include Members of the House of Lords.
3. The group will keep a record of every meeting so that, if challenged, it can demonstrate that: (1) present at every group meeting are one officer and two other members (each of those three must be a Member of either the Commons or Lords); and (2) the group meets at least twice per calendar year (the AGM may count as one meeting; the second meeting must take place on a day other than that on which the AGM is held).
4. The group will hold an AGM to elect its officers, who are all Members of either House, every 12 months from the date of its last registered AGM. This, and any other election of officers, must be announced in advance on the All-Party Notices. The group will register the result of any AGM by checking the group's Register entry, writing on it any additions or deletions required, and returning the entry to the Assistant Registrar. Where the only amendment required is to register the date of the AGM, the group will nevertheless sign and return the entry as proof that it is otherwise correct.
5. The group will notify the Assistant Registrar of any change (i.e. deletion or addition) required to its Register entry within 28 days of such a change occurring.
6. Members of either House may attend, speak and vote at any meeting (including the AGM) of any group that does not charge Members a subscription. Where Members are charged a subscription, Members of either House may attend and speak at any meeting (including

- the AGM) but voting rights may be restricted to paid-up members of the group. The subscription charged to Members of either House must not exceed £5 per year.
7. The group will observe the rules on booking rooms, and will maintain and guarantee the parliamentary nature of the occasion by ensuring the participation of Members of either House in any activity taking place within the precincts.
 8. The group will observe the rules on the use of original House stationery (including post-paid envelopes), especially if this is to be used to correspond with persons other than Members of either House.
 9. With the exception of those groups which receive funding from Her Majesty's Government, all groups cease to exist two calendar months after the first meeting of a new Parliament following a General Election unless they re-register within that two month period.

Administration of the Approved List and the Register

Both the Approved List and the Register are compiled and maintained by the Assistant Registrar (020 7219 0401) on behalf of the Parliamentary Commissioner for Standards. The Approved List is regulated by the Administration Committee and the Register is regulated by the Committee on Standards and Privileges.
