

PROPOSITION NO. 1

"Shall the County of Tulsa, Oklahoma, by its Board of County Commissioners, levy and collect twelve percent (12.0%) of a two-twelfths percent (2/12%) sales tax for the purpose of funding Juvenile Justice Center and Courthouse Complex renovations, improvements, furnishings and equipment, and/or to be applied or pledged toward the payment of principal and interest on any indebtedness, including refunding indebtedness, incurred by or on behalf of Tulsa County for such purpose, commencing October 1, 2006 and continuing thereafter for a period of five (5) years?"

PROPOSITION NO. 2

"Shall the County of Tulsa, Oklahoma, by its Board of County Commissioners, levy and collect twenty one percent (21.0%) of a two-twelfths percent (2/12%) sales tax for the purpose of funding capital improvements at each of the Tulsa County Parks, and/or to be applied or pledged toward the payment of principal and interest on any indebtedness, including refunding indebtedness, incurred by or on behalf of Tulsa County for such purpose, commencing October 1, 2006 and continuing thereafter for a period of five (5) years?"

"Shall the County of Tulsa, Oklahoma, by its Board of County Commissioners, levy and collect thirty two percent (32.0%) of a two-twelfths percent (2/12%) sales tax for the purpose of funding Phase Three of Expo Square's Master Plan, and/or to be applied or pledged toward the payment of principal and interest on any indebtedness, including refunding indebtedness, incurred by or on behalf of Tulsa County for such purpose, commencing October 1, 2006 and continuing thereafter for a period of five (5) years?"

"Shall the County of Tulsa, Oklahoma, by its Board of County Commissioners, levy and collect thirty five percent (35.0%) of a two-twelfths percent (2/12%) sales tax to be divided equally among the three County Commissioner Districts for the purpose of improving selected Tulsa County Roads, and/or to be applied or pledged toward the payment of principal and interest on any indebtedness, including refunding indebtedness, incurred by or on behalf of Tulsa County for such purpose, commencing October 1, 2006 and continuing thereafter for a period of five (5) years?"
