arrival I was briefed on the situation by Ofc. Yavello. He explained that they responded to check the welfare of the resident, Angela Dhingra, and found her deceased inside her secured residence. Ofc. Yavello added that Dhingra had attempted suicide earlier this month as well (03/03/06, DR#06-06272). Det Kirkham spoke with the RP, Euan Black. I entered the residence with CSS T. LaRoche #B1262 and observed the following: The residence was a two story, single family dwelling, with the front door facing east. The garage was on the northeast corner of the house, and there was a door from the garage to an interior hallway. There was a key broken off in the lock, that patrol officers had to remove to gain entry. I was informed that all doors were locked upon officers' arrival, and that two dogs were placed outside. The door entered into the hallway, which ran west into the living room and kitchen area, and south to the office, front door, and stairway to the second story. The landing for the stairway was in the center between the front door and the living room. The victim was lying on					
the floor, west of the stairway landing, along the south wall. The entire house was neat and orderly. There were no signs of a struggle, or anything out of place. There was a garbage bag located in the pantry that contained empty packaging for 115.5mg Xanax. (See photos for further). The body was located in the southeast corner of the living room, next to the landing of the stairway. There was a railing on the side nearest the living room. Below the railing was an overturned stool, just north of the body. The ceiling above contained 2 decorative hooks, and a hole were one of the hooks had pulled out. The third hook was located on a ligature around the victim's neck.					
The body was lying on the floor, on its side, with its head to the west. The body was clad in a blue long sleeve t-shirt and white "be be" shorts. There was a multi-colored, plaid, and cloth ligature tightly tied around the neck, with the decorative hook tied to the other end. There was a small abrasion on the right thigh that appeared to be post-mortem, possibly from when the body fell, striking the carpeted landing to the stairs. The face was discolored, and the tongue and lips were swollen. There was petechiae present in the eyes. There were no other obvious signs of trauma on the body.					
There was a partial note and card left for "Dearest Mom and Dad". It started off saying that she was sorry for "hurting both of you with what happened last Monday." I later spoke with Kapil Dhingra, the victim's brother, and none of the family knew what significance "last Monday" had. The note and card were faxed to family in Louisiana at their request. There was nothing else of significance discovered in the home.					
I prepared a yellow tag info card and contacted the Maricopa County Medical Examiner's office. Investigators responded and took possession of the body. The residence was turned over to the RP, Black, as there were no family members available and Black had access to the residence, with his set of keys. Black also stated that he would take care of the dogs.

DETAILS:

On 03/31/06 I responded to 7498 E. Christmas Cholla. Upon my arrival, I met with Officer O'Meara #681 and Detectives Nichols #748 and Kirkham #499. The victim was identified to me as Angela Dhingra, DOB W/F. I was also informed that this was going to be a Medical Examiner's case.

The residence was a two story located on the north side of the street. The entrance faced to the south. Upon entry into the home was a foyer area. There was an east/west staircase on the north side of the foyer. The north wall of the stairwell was open to the family room. The entrance to the family room was in the northeast area of the foyer.

Inside of the family room, there was an arcadia door (closed and locked) along the north wall. There were two wood table legs just south of the arcadia door. There was a magazine stand to the southeast of the door. The west wall had a built-in shelving unit. There was a TV, candles and picture frames on the shelves. There was a fireplace just south of the shelves. The victim was located in the southwest area of the room, on the floor. There was an upside down wood stool just east of the victim.

The victim was lying on the floor on the left side. The left arm was underneath the body and the right arm was bent towards the face. Both legs were bent and knees pulled close to the body. The left foot was on top of the right calf.

The victim was clothed in a pair of white shorts, with "BEBE" written across the backside, and a blue long sleeved tee shirt. The victim had (1) clear stone earring in each ear. There were ECG patches on the front of the right and left thigh and one on the upper left back. The victim had a black and blue tattoo of a cross and snake on the outer right ankle, approximately 2 x 3 inches in size.

There was red/green/blue plaid flannel belt (possibly from a robe) around the victim's neck. It was tied very tightly. There was a ceiling hook attached to the opposite end of the belt. The ceiling above the victim had a small hole (approximate size of hook) and a second ceiling hook still in place, but slightly bent.

The victim's eyes were open. There was petechial hemorrhaging in each eye. The victim's mouth was open. The tongue was swollen and protruding from the mouth. There was a post mortem abrasion on the upper right thigh approximately $1 \times 1 \frac{1}{2}$ inches in size.

Officer Yavello and I proceeded with the provided key to the front door of the residence. Officer Yavello used the key to unlock the front door. He attempted to open the door, but was blocked by a chain security device that prevented the doorway from opening more than about 3-4 inches. Both Officer Yavello and I were unsuccessful in attempted to unlatch the security chain. Through the partial opening we were only able to see a set of stairs (about 5 feet directly inside from the front door). Through an opening over the banister on the stairs I was able to see what appeared as a living room. I was able to see what appeared as a bar on the upstairs landing. No persons/bodies were seen and no answer to announcements of our presence occurred. I contacted Scottsdale Police Sergeant J. O'Meara #681 and notified him of the situation. On 3/31/06 at 0935 hours Ofc Koemer (875) and I were dispatched to 7498 E. Christmas Cholla Dr regarding a report of an Attempt Suicide. I was wearing my regulation patrol uniform and driving a fully marked SPD patrol car (#1909).						
On 3/31/06 at approximately 0948 hours I arrived at the house. While I waited for Officer Koerner to arrived I parked my car a short distance up the street to observe the house. The house appeared to be secured and all the blinds in the windows were closed. Officer Koerner arrived shortly after I did and we went to the house to make contact with Angela S. Dhingra (V), the resident of the house. Per Dispatch comments, Angela's boyfriend, Euan C. Black (RP2) was on his way to the house.						
Officer Koemer and I got to the house we saw all the doors and windows appeared to be closed and locked. The external garage door was closed and locked, as was the front door and all the windows. The blinds were closed in all the windows and I could not see into the house. I rang the doorbell twice and knocked on the front door twice. No one answered the door but I could hear a small dog barking inside.						
Officer Koemer and I walked into the backyard through a closed but unlocked g dog was alone in the yard and all the doors and windows were closed and locke closed.						
Officer Koemer and I walked back out to the front of the house and met with Euan, who had just arrived. Euan told me Angela tried unsuccessfully to commit suicide approximately three weeks earlier by carbon monoxide asphyxiation in the garage. Euan last spoke with Angela on 3/30/06 at approximately 1800 hours. He and Angela's best friend, Bibiana Baez (RP1), were supposed to talk to her on 4/1/06 at approximately 0900 hours. When they found that Angela was not at work, with either of them and was not answering her phone. They became worried and Bibiana called 991 while Euan drove to the house. Euan told us there were no weapons in the house and there should be no one else in the house. He had a remote control for the garage door and keys to the house. He opened the garage door with the remote and gave me the keys to the interior garage door. A maroon colored Hyundai Santa Fe SUV (165-KGS/AZ) was parked on the west side of the garage. Euan explained the vehicle was a rental and Angela's BMW was in the shop because of an accident. I tried to open the garage door but it was locked with a deadbolt lock. I tried to insert the key into the lock and saw another key was broken off inside the lock.						
Officer Koemer and I went to the front door, which was also locked, and I tried to unlock it with the key. I was able to but was only able to open the door approximately four inches due to a chain lock securing the door from the inside. I was unable to unlock the chain lock from the outside and Officer Koemer and I both identified ourselves as Scottsdale Police and called for Angela to come to the front door. We did not get a response. While looking through the front door I could see the entry way into the house and a stairway leading up to the second floor. A small terrier-type dog was on one of the steps of the stairs. I could not see any one in the residence and we notified our supervisor, Sgt O'Meara (681), of the situation of the stairs.						
While I was looking through the front door, Ofc Koerner called me and fold me he'd gotten the key out of the lock in the garage door. I closed and locked the front door and went into the garage. I unlocked and opened the garage door and entered the house. When I entered I saw the garage door opened into a hallway leading to the living room and kitchen, which were in the rear of the house. To my left was the entry way and two doors leading to an office. I only right was a door leading to a bathroom, which offe Koerner checked. Angela's hair was gathered into a pony tail on the top of her head with a grayish blue elastic band. I saw what appeared to be a silver colored metal earning in her right ear. The earning contained a single, clear stone. Angela was wearing a light blue t-shirt and a pair of white shorts with the word "Bebe" across the rear. Her shirt was pulled up above her waistband approximately 1/2" on her

A small, square shaped, four legged stool was upside down on the carpet next to Angela's feet.				
Ofc Koerner and I checked the rest of the house. We did not find anyone else in the house and did not find any weapons. While checking the house I saw that the heat was on and the inside temperature of the house was approximately 75 degrees Fahrenheit.				
Phoenix Fire Dept Engine 52 (C shift) and Rescue 615 (C shift) arrived while Ofc Koerner and I were inside the house. PFD Capt A Barajas (Engine 52) and Firefighters K. Yule and D. Gonzales (Rescue 615) came into the house. They attempted to take Angela's pulse. They could not find one and told us she was "cold". FF Yule and Gonzales hooked Angela up to a portable EKG machine for a pulse and heart rate. They checked her pupils for responsiveness and saw there was none. They also checked her for rigor morti and saw there was none. The EKG machine showed Angela had no pulse or heart rate and the firefighters determined she was deceased at approximately 1017 hours. They left an EKG pad on the front of each of Angela's thighs just above the knee, but otherwise packed their gear and left. They did not move the body at all.				
While the firefighters were checking Angela for signs of life I noticed what appeared to be a red, white and green plaid strip of fabric between Angela's back and the wall of the living room. When I looked closer I saw the fabric was wrapped around Angela's neck. The loose end of the fabric was attached to a white colored hook. I looked up at the ceiling and saw a small (approximately 1/2" diameter) hole in the southwest corner of the living room ceiling. I did not see anything further inside the house.				
While the firefighters were leaving Sgt O'Meara arrived at the scene and I told him what happened. I then went outside to talk to Euan, who was waiting outside. He told me the following:				
Euan lives at 7676 E. Softwind Dr in Scottsdale. He is in the process of a divorce that will be final on 5/5/06 and said Angela was "the other woman". He and Angela have known each other for approximately 1 1/2 years and have been dating since 7/2005. He said Angela moved into the house at 7498 E. Christmas Cholla Dr in January of 2006 and lived there alone.				
I asked Euan if Angela tried to commit suicide before and he told me she tried approximately three weeks earlier. I asked him how and he told me she wrote notes to himself, her parents, who live in Louisiana, and Bibiana, parked her BMW X5 suv in the garage, ran a hose from the tailpipe to the interior of the car, started the car and shut herself into it. Euan arrived at the house with SPD and SFD and was able to get her out before she died. She was transported to Mayo Hospital on E. 56th Street, where she recovered.				
Angela saw a Dr Seuss (no further information) about the suicide attempt and was prescribed Wellburin (She also swore" to the doctor, Euan and Bibiana that she would not try to kill or hurt berself ever again. Because of the previous attempt Euan and Bibiana made efforts to always be with Angela or stay in contact with her. On 3/29/06 Angela spent the night with Euan at his house. She left on the moming of 3/30/06 and Euangela documents.				
On 3/29/06 Angela spent the night with Euan at his house. She left on the morning of 3/30/06 and Euan called and spoke to her by telephone throughout the day.				
On 3/30/06 at approximately 1800 hours Euan talked to Angela by phone. He wanted her to come over and spend the night at his house but she told him she just wanted to spend the night alone and watch a movie. She told him she was going to a martial arts class and then work the next moming.				
On 3/31/06 at an unknown time in the morning Euan went to work. He tried to call Angela "a couple of times" but was unable to reach her. He thought she may be with Bibiana.				
On 3/31/06 at approximately 0915 hours Euan called Bibiana to see if Angela was with her. She was not and Bibiana thought Angela was with Euan. They both became womed and Bibiana called 911 while Euan drove to Angela's house and met myself and Ofc Koemer.				
Euan did not know why Angela chose to do that to herself. He said she had not talked about or tried to commit suicide since the las attempt. He had nothing further to add.				
I then spoke to Bibiana, who had arrived at the scene and she told me the following:
