- The Cornwall Record Office does not keep a stock of microfiche copies for sale; copies are made from the master fiche for each order and therefore the copying process can sometimes take several days to complete.
- Whilst every effort has been made to achieve the best copy available, some original registers are in poor condition, and a degree of clarity is always lost when filming. The Cornwall Record Office cannot therefore guarantee the legibility of individual registers. Please contact the Record Office if you are in any doubt as to the quality of the register before ordering so that the quality can be checked. We are unable to offer refunds.
