### 1. Regional Workshop on e-Governance to Enhance Reforms and Public Service Performance in Africa, Accra, Ghana, 22-25 November 2004

The workshop is being organized by CAFRAD and the Government of Ghana, as a follow-up to the "e-Africa 2002: Regional Workshop on Building e-Governance Capacity in Africa", Johannesburg, 28-31 October 2002, and the "e-Africa 2003: Consultative Meeting on e-Governance", held in Tangier (Morocco), 20-22 October 2003. These meetings were organized within the framework of the e-Africa Initiative for Good Governance: Building e-Governance Capacity in African Countries, in partnership with UNDESA/DPADM, and funded by the Government of Italy, under the banner of NEPAD.

The aim of the Accra meeting is to review the state of e-governance in African countries, examine the challenges and pave the way for new opportunities. It will be the occasion, like in the two first meetings on the same subject, to share knowledge and experiences and also, to determine means and ways of collaboration through regional, sub-regional and national networking.

Participants in the workshop are expected to be high officials in charge of designing, implementing and managing e-governance systems, and responsible policy makers for reforming. restructuring and modernizing public service and governance.

# 3. Restitution and Review Workshop on the study and proposal to establish a Public Sector Management Training Programme in Africa

From 21 to 22 September 2004, the Ag. Director-General of CAFRAD Dr. Simon Mamosi Lelo took part in the above mentioned workshop organised by the African Capacity Building Foundation (ACBF) on Public Sector Management Training. The aim of the workshop was to review and comment a study and a proposal commissioned by ACBF on the subject of the workshop. After two intensive works, a final draft program on Public Sector Management Training was adopted. The program will be implemented in some institutions to be selected. The duration of the program is estimated at 12 months for Master's degree level.

Participants to the workshop came from various countries and institutions in Africa and elsewhere

## 4. Follow-up of the International Workshop on Innovative Applications of ICTs for Local Governance in Africa

In preparation of the African Development Forum-ADF 2004, which focused on the subject of Governance for Progressing Africa, the International Development Research Centre (IDRC) and the United Nations Economic Commission for Africa (UNECA), in collaboration with the United Nations Capital Development Fund (UNCDF), convened "International Workshop on Innovative Applications of ICT for Local Governance in Africa" (7-9 June 2004).

The objective of the workshop was to initiate the move away from anecdotal analysis of strengthening local governance towards a more rigorous, evidence and outcome-based, analysis of developing trends and implementation of ICT in local governance.

The workshop, attended by about 60 participants from Africa and elsewhere, examined various aspects of ICT as a tool for strengthening local governance in African countries. In addition, the workshop analysed the links between local governance initiatives and national and regional ICT policies and plans, such as the African Information Society Initiative (AISI).

The workshop aimed at assisting African countries and stakeholders to implement the World Summit on Information Society (WSIS) Plan of Action and prepare for the WSIS 2005 in Tunis. In this regard, in addition to provide an inventory of the research

needs of practitioners working in the development field, the workshop discussed case studies of ICT applications in the context of local governance, together with a consideration of technological and governance issues affecting local governance in Africa.

Mr Gianluca Misuraca, Adviser in Governance and Public Administration at CAFRAD, was invited as Keynote Speaker to present the preliminary results of the Research on ICTs for Local Governance in Africa, that he is currently conducting for IDRC and UNECA, within the framework of the Acacia and Connectivity Africa Programme Dissemination Activities, part of the Partnership on ICTs for Africa - PICTA.

One of the main output of the workshop was the proposal of setting a Research Agenda for ICT and Local Governance in Africa. After identifying and categorizing research issues, it was proposed to establish a ofInstitutions Network and practitioners to develop and conduct a Research to analyse the impact of ICT Local governance, through evaluating projects and initiatives and producing case studies. It will also involve the definition of a monitoring and evaluation system and identification of guidelines (Road Map) for implementation of ICT Projects at local government level. In order to guarantee an effective coordination and high-level political dissemination of results, it was proposed that CAFRAD will lead and coordinate the activities of the Network.

5. Consultative Meeting on Public Sector Leadership Capacity Development in African Countries (Follow up to the Kampala Workshop) 27 September – 1 October 2004 Johannesburg, South Africa

The overall objective of the consultative meeting was to review the draft Program, finalize and submit it to the Chairperson of the Pan African Conference of Ministers of Civil Service. The specific objectives are as follows:

- Take advantage of the presence of Public Sector Human Resource managers in a Workshop on Public Sector Restructuring to:
  - (i) solicit and receive further input as well as build stronger consensus on the Program from the managers who will largely be responsible for its implementation;
  - (ii) put the draft Program into the context of Public Sector Restructuring and Human Resource Management efforts;
- Examine the draft Program (prepared by CAFRAD, UMI and UNDESA);
- Provide more detailed inputs on the Program, especially on programmatic activities;
- Work on various aspects of the implementation of the Program (timing, budget, etc).
- Develop a framework and a network for continuous activities in public sector leadership development in Africa

Between 11 and 15 October 2004, Mr Simon Mamosi Lelo, Acting Director General of CAFRAD, and Mr Gianluca Misuraca. Adviser Governance and Public Administration at CAFRAD, participated in the Fourth African Development Forum (ADF) on Governance for Progressing Africa. In addition to broad discussion on governance challenges in Africa, the Africa Governance Report (AGR) was UNECA/DPMD. presented bv CAFRAD contributed to the section of the AGR on Morocco.

Mr Misuraca, invited by IDRC and UNECA/DISD, within the framework of the Acacia and Connectivity Africa Programme Dissemination Activities, part of the Partnership on ICTs for Africa – PICTA, participated also in the Meeting on Africa's Preparation to the WSIS Phase II (12 October 2004). and the ADF IV ICT Focus Group Pre-Event Meeting and Meeting 12 and 13 October 2004). In this meeting, Mr Misuraca was Keynote Presenter on "Local governance perspective in Africa", also announcing the "Local governance and ICTs Research Network for Africa (LOG-IN Africa Research)", and contributing to the preparation of the recommendations and Focus Group Consensus Statement.

International Development Research Centre (IDRC). The e-Fez Project aims at developing a pilot e-Government system for the City of Fez that will allow citizens to request and receive governmental services in an easy and efficient way.

The workshop was attended by about 60 participants from national and international institutions.

Mr Gianluca Misuraca, Adviser in Governance and Public Administration at CAFRAD, was invited to participate the workshop and make "Using presentation on **ICTs** government reinvent services Morocco".
