Historic Meetinghouse Finds a New Home

Like a good thriller story, the tale of the Free-will Baptist Meetinghouse in Epsom, NH, had its share of chills, near misses, and heart-racing moments. In the end, however, perseverance paid off and this historic meetinghouse will not be demolished after all.

In the summer of 2005, a resident of Epsom called the National Trust's Northeast Office with concerns over the Meetinghouse's proposed demolition. The congregation had outgrown the building and had sold the site to Cumberland Farms, which needed the site cleared in order to construct a convenience store and gas station. Local efforts began to find alternatives to demolition.

Through the new shared field service program of the National Trust and the New Hampshire Preservation Alliance (NHPA), Maggie Stier provided the Epsom Meetinghouse Friends group with key support in fundraising and public relations. The NHPA also made two small grants to the project.

This past February, Epsom voters endorsed a plan for the town to acquire the 1861 structure and move it to a new location. This huge preservation success is the result of a multi-year effort that involved many groups including the Friends of the Epsom Meetinghouse, the NHPA, the New Hampshire Division of Historical Resources (NHDHR), the Town of Epsom and the National Trust's Northeast Office, and many, many others.

The tenacious Friends group worked tirelessly

to convince voters to accept the gift of the structure, and raised nearly \$100,000 to cover the costs of the move, which was coordinated by Christine and Charles Rankie. Cumberland Farms generously donated the building, as well as \$10,000 toward moving costs, and extended several deadlines to accommodate the fundraising schedule and the special town meeting.

The Meetinghouse traveled down NH State Route 4 in the wee hours of the morning of February 25th, finally coming to rest next to the new town library. This town of 4,500 people plans to use the building as meeting space and town offices. With an estimated \$900,000 yet to be raised for rehabilitation, the Epsom Meetinghouse story isn't yet finished, but its future is brighter.

Gibraltar Easement Amendment Up for Public Comment

After a lengthy 10-year effort, a plan is in place for the re-development of Gibraltar, the Hugh Rodney Sharp estate in Wilmington, DE. The proposal involves amending the easement the State of Delaware holds on the property in order to strengthen preservation of the outbuildings and garden, and allow an adaptive reuse of the site that is also economically viable.

As part of the review process, the Division of Historical & Cultural Affairs has initiated a 30-day public comment period for this request.
