Membership Agreement

The Textile Institute (TI) and The American
Association of Textile
Chemists and Colorists (AATCC) have made an agreement whereby each association will offer discounted membership in its organisation to people who are current members of the other organisation. The agreement took effect from 1 January 2007.

'Fashion and Textiles: Education means Business'











-TI Graduate Designers' Exhibition

The beautifully modernised historic HM Treasury building in Horse Guards Parade, London, UK, was for the second vear running the location for the 'Fashion and Textiles: Education means Business' event on 11 July 2007. organised by the Design Special Interest Group (SIG) under the chairmanship of Professor Clare Johnston, and with the help of The Lord Haskel, past World President of The Textile Institute. The event enabled some of the leading fashion and textile colleges and universities in the UK, all corporate members of The Textile Institute, to demonstrate to invited guests from industry and retail the range of the colleges fashion and textile programmes. Each college presented a profile, with contact names and addresses, and was represented by a member of staff with up to three recent graduates exhibiting examples of their work.

The participating institutions were Bolton Institute, Central St Martins College of Art and Design, Colchester Institute, De Montfort University, London College of Fashion, Loughborough University, Faculty of Art & Design Manchester Metropolitan University, Hollings Faculty Manchester Metropolitan University, Nottingham Trent University, the Royal College of Art, and the University for the Creative Arts at Rochester.

The event was a practical example of the support that The Textile Institute

gives to education, and particularly of the importance that the Institute places on design and the contribution of design education to the success of the textile industry worldwide. The Lord Haskel in his opening speech stressed the increasing economic value of what is now called the creative economy in the UK, and how fashion must work closely with technology, education and industry.

The event was opened by Lynne Burstall, Creative Director of Coast, part of the Mosaic Fashions Group. It was attended by over two hundred directors and executives from industry and retail, including many from small to medium sized enterprises (SMEs). The excellent method of presenting the work on a hanging system encouraged guests to circulate from college to college and engage in informal discussion with college staff and graduates. The links formed between individual companies and colleges were a gratifying outcome to the event, and equally there is no doubt that many graduates were able to boost their career prospects by making the right contacts.

The Institute is very grateful to the companies that sponsored the event: Alvanon UK, Coast, Gerber, and Hobbs. Each company had a display area in an adjoining room, where there was also a presentation of CAD developments for fashion and textiles in the secondary school sector.




















Manchester Metropolitan University

Bolton works closely with Skillfast-UK to ensure that its courses, particularly the foundation degrees, are relevant to the needs of employers in the sector.



Frank D Aspinall

ARIC CText FTI CCHEM MRSC

Ken Gregory died in Natal on 11 November 2006.

He started work at an early age in the Government Laboratory in Liverpool, and completed his ARIC course at the Widnes Municipal Technical College as a part-time student. He was elected an Associate of The Royal Institute of Chemistry in June 1953. He then moved to ICI Runcorn Research Laboratory. During this time he attended Manchester Municipal College of Technology, taking an advanced course in bleaching, dyeing and printing, which he successfully completed in 1956. He was admitted as an Associate of The Textile Institute in September 1959. In 1960 he was transferred to ICI Fibres in Harrogate.

Ken and his family emigrated to South Africa in September 1961, where he joined the Textile Development Division (TDD) of South Africa Nylon Spinners (SANS) in Bellville Cape. He was an active member of The Textile Institute and the Dyers and Finishers Association, and served on a South Africa Bureau of Standards Working Group where he participated in furthering the knowledge of textile processes. He became manager of TDD in the late 70s.

In 1978 he moved to Natal after having been selected to set up and manage the Textile Development Department to service the weaving trade. He began lecturing part-time at the Textile Section of Durban Tecnicon, where, on retiring from SANS in 1987, he took over the post of Director until his final retirement in 1991.

Ken was a very gentle person with a wealth of knowledge across the world of textiles, which he imparted to students at the Tecnicon. He was a strong, caring family man, always ready to take on responsibilities, with a firm desire to improve the knowledge of those who worked for him in the textile field.

On retirement Ken was able to give more time to the things he loved doing, such as gardening, creative wood-work of all kinds, bowling, tennis and church activities. He continued to be an active member of The Textile Institute and The Dyers and Finishers Association beyond retirement, and will be sadly missed.

He leaves his wife Doreen, son Andrew, daughter Johanna, son-in-law Chris, and two grandchildren, Lee and Susan, to whom we send our sincere condolences.

Mr H G Wiener

Mr J Harrison

CText ATI

Mr J Harrison died peacefully in Ilkley, aged 88, on 2 May, some five years after the death of his wife, Mildred, whom he had married in 1945 in Holmfirth

Born in the cotton town of Oldham, he moved to the Holme Valley at the age of 20, gaining experience in a woollen spinning mill there, and studying at night-school in Huddersfield for his textile technologist qualification, before obtaining a position in London in 1945. He joined The Textile Institute in 1943 and was awarded his CText ATI in 1944. He was also a long standing Fellow of the Royal Society of Arts.

He worked for over 35 years at the Patent Office in London, initially to check on textile inventions, and latterly used his skills and knowledge to represent the Patent Office in specialist High Court proceedings.

Mr Harrison had a leaning towards history and became fascinated by the interrelation between the early activities of the Society of Arts, founded to stimulate innovation, and the Patent system. In retirement, he brought to completion his research in this area and published a book last year Encouraging Innovation in the Eighteenth and Nineteenth Centuries, proceeds from the sale of which will go to the William Shipley Group of the Royal Society of Arts History Section, of which he was a founder member.

Ted Love

We much regret to report the death on 17 June of Edward Lawrence Love, a member of the Textile Institute staff for 22 years. He was aged 85.

In 1962, there was a mood of discontent among a large proportion of the Institute membership because of dissatisfaction with the Proceedings section of the Journal of The Textile Institute. Many members felt that this section, still in the formal appearance of a professional journal, was not sufficiently attractive and did not contain enough material of practical interest and value. Changes to the typeface and layout had been made for the Jubilee year of 1960, but these were mainly cosmetic, and the murmurings continued. Accordingly, after much discussion, Council decided that what was needed was a magazine-type publication edited by an experienced technical journalist. The editor appointed was Ted Love, who joined the Institute on 7 August 1962, and the magazine was The Textile Institute and Industry, which commenced publication in the following January.

From the start, Ted Love faced a huge challenge, which he met extremely successfully.

He had to produce a 'popular' publication and at the same time convince the more conservative elements among the membership that the Institute's high standards were not diluted. He did this so well that, within a very short time, TI&I (as it became familiarly known) had become firmly established as one of the world's leading textile publications.

With no textile background, Ted Love rapidly familiarised himself with the industry and its technology and terminology. A clear and incisive writer, he was able to provide crisp editorials and news items to go alongside the conference papers and technical articles obtained from contributors. His friendly and genial disposition made him popular with both members and fellow journalists.

When TI&I had reached Volume 19, it was felt that the time had come for a relaunch, and the magazine became Textile Horizons in September 1981. Ted Love continued to edit this until has retirement in 1984. His work for the Institute was recognised by the award of the Service Medal at Convocation in the same year.

Even after his retirement, Ted retained his association with the Institute, and he was one of a small team that oversaw the publication of Textile Horizons in the late 1980s, his responsibility being defined as 'Special Projects'. In this capacity, he continued to contribute to the magazine, particularly in relation to exhibitions and conferences. He also did much freelance work for over a decade, especially on Medical Textiles and African Textiles until health problems caused him to retire completely.

Ted Love was born at Rainsworth, near Mansfield, in September 1921, and educated at Nottingham High School. He served in the Royal Air Force throughout the Second World War and for most of that time was stationed at Darwin in Australia's Northern Territory, where he was engaged on signals work. After the War, he worked for a time at Boots, the pharmaceutical company headquartered in Nottingham, before going into journalism and was on the staff of Packaging Times in London immediately before moving to The Textile Institute.

Outside his work, of which he was clearly very fond, he was a man of many interests. In his young days, he was a keen racing cyclist, taking part in time trials and grass-track racing in the Nottingham area, and he retained his enthusiasm for cycling in later life. He was a great walker, very fond of the hills of Northern England. In the hot summer of 1976, he and his son walked the length of the Pennine Way. He was interested in most sports and had a wide taste in music, ranging from classical to jazz. He sang in the choir of St Paul's Church, Heaton Moor, Stockport, for many years. On coming to the Institute, he was initiated into playing Scrabble, which filled nearly every lunchtime for the senior staff. He became expert enough to qualify for the National Scrabble Championship in London one year. He did not win but enjoyed the experience. In retirement, he was active in the Probus organisation and chaired the local branch.

Ted Love was a friendly and cheerful colleague for 22 years, someone with whom one could share the pleasure of a particularly successful publication or a grumble at the shortcomings of printers or a decision made by those above us. He was popular with those who worked for or with him.

Our condolences go to his wife Christine, daughter Karen, son Mark and two grandchildren.
