NARRATIVE AREA

ON 9-20-07 AT 2110 HOURS, DET. RONNIE HOWARD AND I WERE STANDING IN FRONT OF THE DOWNTOWN BUS STATION AT 1000 MAIN STREET. DET. HOWARD AND I VOLUNTEERED TO STAY WITH SOME OF THE PEOPLE WAITING FOR THEIR BUSES TO ARRIVE TO TRANSPORT THEM TO THEIR HOMES OUT OF STATE. THESE PEOPLE WERE IN ALEXANDRIA IN REFERENCE TO THE JENA SIX RALLY. WE WERE APPROACHED BY MR. KAHN DOCKERY WHO TOLD US THAT A RED PICKUP TRUCK HAD JUST PASSED BY OUR LOCATION AND THAT THERE WERE HANGMAN NOOSES HANGING OFF THE BACK OF THE TRUCK. I TURNED AND WATCHED THE RED TRUCK TURN LEFT ON JACKSON STREET. APPROXIMATELY TWO MINUTES LATER WHILE DET. HOWARD WAS GIVING A DESCRIPTION OF THE RED TRUCK TO COMMUNICATION, I NOTICED THE RED TRUCK TURNING FROM JOHNSTON STREET ONTO MAIN STREET AND APPROACHING OUR LOCATION AGAIN. I STEPPED IN FRONT OF THE RED PICKUP TRUCK AND INITIATED A TRAFFIC STOP. THERE WERE TWO WHITE MALES IN THE RED FORD TRUCK. I ASKED THE DRIVER TO TURN OFF THE VEHICLE AND STEP OUT OF THE TRUCK. I NOTICED A HANGMAN'S NOOSE ATTACHED TO THE REAR OF THE TRUCK TIED TO THE BED RAIL. THE HANGMAN'S NOOSE WAS YELLOW IN COLOR. I ASKED THE DRIVER FOR HIS DRIVER'S LICENSE AND AS HE SPOKE TO ME I COULD SMELL THE ODOR OF AN ALCOHOLIC BEVERAGE OMITTING FROM HIS PERSON. I CALLED HEADQUARTERS FOR A UNIT TO BE IN ROUTE TO OUR LOCATION BECAUSE THERE WAS A CROWD OF APPROXIMATELY TWO HUNDRED PEOPLE AT OUR LOCATION. THE DRIVER OF THE VEHICLE WAS IDENTIFIED AS JEREMIAH MUNSEN. DET. HOWARD HAD THE WHITE MALE PASSENGER EXIT THE VEHICLE. THE PASSENGER WAS IDENTIFIED AS A JUVENILE. I ASKED THE DRIVER OF THE TRUCK IF I COULD SEARCH THE VEHICLE AND HE TOLD ME " GO AHEAD, KNOCK YOURSELF OUT". WHILE PATTING DOWN THE SUSPECTS FOR WEAPONS SOME OF THE PEOPLE FROM THE CROWD WALKED OVER AND TOLD US THAT ANOTHER TRUCK HAD PASSED BY AND IT ALSO HAD A NOOSE HANGING ON IT. THE TRUCK HAD LEFT THE AREA AND WE NOTIFIED HEADQUARTERS AND UNITS CHECKED THE AREA BUT WERE UNABLE TO LOCATE THE SECOND VEHICLE. UNIT 105 ARRIVED AND I ASKED OFC. MIZELL TO WATCH MR. MUNSEN WHILE I CONDUCTED A SEARCH OF THE VEHICLE. BEFORE I STARTED MY SEARCH MR. MUNSEN TOLD ME THAT THERE WAS A RIFLE BEHIND THE DRIVER'S SIDE SEAT AND THAT IT WAS NOT LOADED.

I FOUND A SAVAGE MODEL 64 .22 CALIBER RIFLE WRAPPED IN A BLANKET BEHIND THE DRIVER'S SIDE SEAT. IT WAS NOT LOADED. THERE WAS A SET OF BRASS KNUCKLES IN THE CUP HOLDER ON THE DASHBOARD. THE BRASS KNUCKLES WERE IN THE RIGHT SIDE OF THE CUP HOLDER CLOSEST TO THE PASSENGER. IN THE PASSENGER SIDE FLOORBOARD WAS A COORS LIGHT BEER BOX THAT HAD 3-12OZ. BOTTLES. THE BOTTLES WERE STILL COLD. I CONTACTED HEADQUARTERS AND ASKED THEM TO SEND A DWI UNIT TO OUR LOCATION. WHILE CONDUCTING THE SEARCH OF THE VEHICLE I NOTICED ANOTHER HANGMAN'S NOOSE THAT WAS TIED TO THE RIGHT REAR BED RAIL AND WAS VISIBLE TO ANYONE WHO COULD SEE THAT SIDE OF THE VEHICLE. THE CROWD, WHICH WAS PREDOMINATELY AFRICAN AMERICAN, WAS APPROXIMATELY 25 FEET FROM THE TRUCK AND COULD SEE THE HANGMAN'S NOOSE. MR. MUNSEN WAS PLACED UNDER ARREST FOR CONTRIBUTING TO THE DELINQUENCY OF A JUVENILE, READ HIS RIGHTS ACCORDING TO MIRANDA AND PLACED INTO UNIT 105 FOR TRANSPORTATION TO HEADQUARTERS FOR INTOXILIZER TESTING. THE JUVENILE WAS PLACED INTO UNIT 102 (OFC. DAVID KING AND OFC. VERN RENNIER) AND TRANSPORTED TO HEADQUARTERS. SGT. F.K. JOHNSON ARRIVED AND TOOK PHOTOS OF THE VEHICLE AND THE EVIDENCE THAT WAS FOUND IN THE VEHICLE. I GATHERED THE EVIDENCE AND PLACED IT INTO BAGS AND SECURED IT IN THE TRUNK OF MY TAKE HOME UNIT. RAY HYDE WRECKER SERVICE WAS CONTACTED AND THE TRUCK WAS TOWED TO THEIR FACILITY FOR STORAGE. DET. APRIL PAINTER WAS CALLED OUT IN REFERENCE TO THE JUVENILE. AFTER THE TRUCK WAS TOWED I WENT TO HEADQUARTERS TO TAG THE EVIDENCE AND RIGHT THE REPORT. THE JUVENILE WAS READ HIS RIGHTS ACCORDING TO MIRANDA WHILE SITTING IN THE LOUNGE AREA OF HEADQUARTERS. THE JUVENILE'S MOTHER WAS CONTACTED BY PHONE. WHILE SITTING IN THE LOUNGE THE JUVENILE SAID THAT HE HAD KKK TATTOOED ON HIS CHEST AND THAT HIS PARENTS AND KIN FOLK WERE INVOLVED WITH THE KKK. HE ALSO SAID THAT HE WAS THE ONE THAT HAD TIED THE HANGMAN NOOSES AND THAT THE BRASS KNUCKLES ALSO BELONGED TO HIM. THE JUVENILE ALSO ADMITTED TO DRINKING FIVE BEERS FROM THE BOX THAT WAS LOCATED ON THE PASSENGER SIDE FLOORBOARD OF THE TRUCK. MR. MUNSEN WAS ALSO CHARGED WITH DWI FIRST OFFENSE AND INCITING TO RIOT. HE WAS TRANSPORTED TO R.P.S.O. BY UNIT 105, CPL. RANDY LACHNEY AND OFFICER J.MIZELL, FOR FURTHER BOOKING. THE JUVENILE'S MOTHER ARRIVED AND DET. PAINTER ASSUMED THE INVESTIGATION AT THIS TIME. SEE CPL. SAMMY DAUZAT'S DWI ARREST REPORT IN REFERENCE TO MR. MUNSEN'S DWI. THE EVIDENCE WAS TAGGED AND PLACED INTO EVIDENCE LOCKER NUMBER 13. SEVERAL PEOPLE FROM THE CROWD SIGNED THEIR NAMES AND WANTED TO BE LISTED AS WITNESSES. SEE ATTACHED SHEETS. FBI AGENT RANDY DEATON WAS NOTIFIED IN REFERENCE TO THIS REPORT.
