108th Congress, Second Session

The 108th Congress wrapped up its work after another year marked by extreme partisan jockeying. The Republican controlled House and Senate schedules looked like Karl Rove's handbook for divisive politics. A constitutional amendment designed to bring out the hate vote by creating second-class citizenship for homosexual couples, a stealth assault on a woman's right to choose wrapped into the "Unborn Victims of Violence Act", and a repeal of the District of Columbia's Gun Ban are but a few of

the myriad of vile reactionary projects that this extremist regime raised before Congress this past year.

With the 109th Congress under way, the Republican leadership has begun implementing the right-wing extremist playbook. Everything we hold dear is up for grabs. ISSUES FOR 2005

President Bush and Republican leaders feel they have an opening to gamble with our Social Security through a privatization scam that will cost trillions of dollars, see a decline in benefits for everyone, and generally leave us all less secure when the time comes to collect on disability or retirement benefits. Proponents of this gimmick are going all out with a massive misinformation campaign painting the current system as being in "imminent danger" and saying that private accounts will save us all. Sounds quite a bit like their rationale for going to war in Iraq and is just a false. Let's rally around a great program and save it from the privatization crusaders.

Republicans are likely to try pushing yet another giveaway to the rich in the form of a tax cut. "When in doubt, cut taxes on the wealthy," seems to be the battle cry of every Administration economic plan. The country cannot survive in its current economic state and ADA joins you in fighting for sane economic policy.

Judicial nominations, environmentally disastrous oil exploration, and impeding a woman's right to choose are all top priorities for the Republican leadership.

Vote Descriptions

1. HR 3030. Community Service Block Grants Act - Unemployment Benefits Miller (D-CA) amendment to the Community Services Block Grants program adding 13 weeks of unemployment benefits for people who have exhausted their state jobless benefits. Adopted 227-179. February 4, 2004. (Y = +).

2. HR 1997. Unborn Victims of Violence Act
A bill making it a criminal offense to injure or kill a fetus during the commission of a violent crime, with criminal penalties (not including the death penalty) equal to those that would apply if the injury or death occurred to the pregnant woman, regardless of whether the perpetrator knew of the pregnancy. (Ed. NOTE: Although the bill states that it should not be interpreted to apply to consensual abortion or to a woman's actions with respect to her pregnancy, by granting legal status to the so-called "unborn child" at all stages of prenatal development, affording rights separate from, and equal to those of the woman, it is a step toward undermining a woman's right to choose.) Adopted 254-163. February 26, 2004. (N = +).

3. H CON RES 393. Fiscal 2005 Budget A resolution setting broad spending and revenue targets for the next five years. For fiscal 2005, the resolution provides \$821.3 billion in discretionary spending and \$50 billion additional to support military operations in Iraq. Mandatory spending would rise by 5 percent, defense spending by 7 percent, and homeland security by 12 percent. It calls for \$152.6 billion in tax cuts over five years; and, without specifying how, it also calls for cutting the budget deficit in half by fiscal 2009. Adopted 215-212. March 25, 2004. (N=+).

4. HR 4200. Fiscal 2005 National Defense Authorization Act - Abortion at Military Facilities. Davis (D-CA) amendment allowing overseas military facilities to provide privately-funded abortions for women who are in the military or are military dependents. Rejected 202-221. May 19, 2004. (Y=+).

5. HR 4200. Fiscal 2005 National Defense Authorization Act - Nuclear "Bunker Busters" Tauscher (D-CA) amendment transferring \$36.6 million from the Energy Department's Robust Nuclear Earth Penetrator (nuclear "bunker-buster") and Advanced Concepts programs to various intelligence programs that would improve conventional "bunker-busting" capabilities. Rejected 204-214. May 20, 2004. (Y=+).

6. HR 444. Back To Work Incentive Act - Job Training And Worker Services. A bill authorizing personal accounts and grants of up to \$3,000 for use by unemployed individuals for job training or job search services.

A bill authorizing \$25.7 billion in tax breaks over 10 years, \$18 billion in loan guarantees for a natural gas pipeline from Alaska; it also opens the Artic National Wildlife Refuge to drilling. It would require that gasoline sold in the United States contain an increased volume of ethanol. Makers of the gasoline additive MTBE are protected from liability, but are required to cease production of the additive by 2015. The bill also imposes reliability standards for electricity transmission networks and eases restrictions on utility ownership and mergers. Approved 244-178. June 15, 2004. (N=+).

8. HR 4568. Fiscal 2005 Department Of The Interior Appropriations - Tongass National Forest. Chabot (R-OH) amendment blocking the use of funds to plan or construct forest development roads in the Tongass National Forest in Alaska for the purposes of harvesting timber. Adopted 222-205. 9. HR 4520. American Jobs Creation Act - Corporate Tax Breaks. A bill revoking an export tax break for U.S. manufacturers that the World Trade Organization had ruled an illegal trade subsidy, while also providing about \$140 billion in (continued on Page 6)

Rejected 203-213. October 08, 2004. (Y = +).

1. S 1805. Protection of Lawful Commerce In Arms Act - Gun Liability - Gun Safety Devices
 Boxer (D-CA) amendment prohibiting the sale or transfer of handguns by a licensed manufacturer, importer or dealer unless a secure gun storage or safety device is provided for each handgun, with penalties of up to \$2,500 and license suspension or revocation. It exempts gun transfers to U.S. or state government agencies and law enforcement officials. It also provides civil liability exemptions for individuals who legally possess a handgun and use a secure gun storage or safety device. Adopted 70-27. February 26, 2004. (Y=+).

2. S 1637. Jumpstart Our Business Strength (JOBS) Act - Exporting

Federal Marriage Constitutional Amendment-Cloture** Motion to limit debate on a resolution proposing a constitutional amendment defining marriage as consisting only of the union of a man and a woman. It provides that the Constitution or any state's constitution could not be construed to require that marriage or any other constructs of marriage be conferred to any other union. Rejected 48-50. July 14, 2004. (N = +).

19. **S 2845. National Intelligence Reform Act - Foreign Subsidiaries** Collins (R-ME) motion to table (kill) a Lautenberg (D-NJ) amendment barring foreign subsidiaries of U.S. companies from doing business with countries considered sponsors of terrorism. Adopted 47-41. Sept 30, 2004. (N = +).

20. **S 2845. National Intelligence Reform Act** A bill reorganizing 15 U.S. intelligence agencies and creating a national intelligence director with power to freely transfer money among the CIA, National Security Agency and other defense and civilian agencies. It also creates a counter-terrorism center with operational planning capabilities and a Privacy and Civil Liberties Oversight Board to investigate use of intelligence powers and act as a watchdog for civil liberties concerns. The bill requires the Homeland Security secretary to develop and implement a comprehensive national transportation security plan and exempt certain "joint military programs" from the authority of the new director. Passed 96-2. Oct. 06, 2004. (Y = +).

Voting Record Notes:

(1) This voting record is offered only as a guide in judging the legislative performance of Members of Congress, and has several inherent limitations. It is no measure of a legislator's work in committee. It does not reflect the failure of Congress to deal with some major issues, or the individual's degree of responsibility. These judgments cannot be expressed in percentages.

(2) Liberal Quotient (LQ) is the rating of a Member of Congress as determined by the percentage of votes cast in support of liberal policies, measured against the number of votes counted (20). For example, Senator Tom Harkin (D-IA) voted with the liberal position in all 20 selected votes, so his LQ is 100%.

(3) The votes selected cover a full spectrum of domestic, foreign, economic, military, environmental and social issues. We try to select votes which display sharp liberal/conservative contrasts. We often chose procedural votes: amendments, motions to table, or votes on rules for debate. These votes can reveal true attitudes obscured in the final votes.

STOP OUTSOURCING OUR FUTURE

REGIME CHANGE 2004: POST-ELECTION REPORT

When ADA's "Regime Change 2004" project began in early 2003, it was far from certain that the eventual Democratic Presidential nominee would take a position on trade that supported workers and the environment, or that trade would even be an issue in the 2004 elections. In fact, the candidates themselves were not focused on the decisions they would make on trade in the White House in 2005, should their campaigns be successful. Some of them made general statements on the topic, but it wasn't clear that the trade agenda being negotiated by George W. Bush would be discussed by the candidates – or the public.

That uncertainty changed when opinion leaders and activists in Iowa and New Hampshire were convinced to raise the trade issue with the candidates in various venues, and insist that the candidates respond to specific questions about the decisions they would make in the White House. Iowa and New Hampshire provided us with an extraordinarily important opportunity to educate the candidates, sharpen the debate, and secure specific and meaningful commitments from the candidates — and we did.

Americans for Democratic Action, under the leadership of president emeritus Jim Jontz, began by approaching Labor, farm, environmental, student, and other leaders to persuade them that the next occupant of the White House could make a big difference in our nation's future trade policies. We helped opinion leaders in Iowa and New Hampshire — and later South Carolina, Arizona, New Mexico, Minnesota, Tennessee, Texas, Wisconsin, and Ohio — understand that the next President would make some extraordinarily important decisions about the expansion of NAFTA into the Free Trade Area of the Americas (FTAA), the expansion of the WTO, and other trade agreements.

Phase I of "Regime Change" was successfully completed in the spring of 2004: John Kerry, the Democratic nominee, had taken a clear position against the Bush trade agenda, outlined significant pro-worker and pro-environment "markers" by which he would judge new trade agreements, and pledged a 120-day review of all current trade policies, including the commitment to fix NAFTA.

Phase II of "Regime Change 2004" began in the summer of 2004 by identifying "battleground" states in which voter education about the Bush trade agenda and the distinctions between the candidates on trade might impact the outcome of the November election. Eventually, eight states were chosen and organizers hired in each: Ohio, Wisconsin, Missouri, Iowa, West Virginia, New Hampshire, Maine, and Oregon.

Within these states, 50 communities were selected in which significant job losses had occurred from outsourcing, and where community outreach and education efforts on the Bush trade agenda might make a difference. Eventually, "Stop Outsourcing Our Future" town meetings were held in all 50 communities, with follow-up education and media campaigns in virtually all of these locations.

These town hall meetings were not held in the largest cities, but areas where voters were more susceptible to GOP arguments on social issues, fewer resources were deployed by other organizations, and local economies were less diversified and more manufacturing dependent.

The consequence of these events and activities was extensive media coverage, leafleting, internet outreach, and other communication about trade and outsourcing, helping voters link the policies of George Bush to the loss of good jobs in their communities.

"Regime Change 2004" would not have been possible without the support of the ADA national board members, state AFL-CIO presidents, and organizers cited above, as well as the network of over 2,000 grassroots activists, Labor and other community leaders who worked together to raise the issue of trade and outsourcing with the candidates, the media and the voters. We thank Congressmen Sherrod Brown, Ted Strickland, Nick Joe Rahall, Mike Michaud, and Bernard Sanders and Congresswoman Marcy Kaptur for their role in helping us to carry the message to their constituents and beyond. And, finally, we are enormously grateful to the many international unions whose financial contributions made the project possible.

Next Step: We need to explore immediately what a longer-term public education campaign on the global economy would look like for the key regions of the country that will continue to determine the outcome of Presidential elections for the foreseeable future. We must continue to reach working class voters with information which helps them vote for their own interests, especially those workers who are not union members.

ADA is currently in the process of developing and implementing just such a plan.
