Overview of State Procedures for Selecting Official Participants to the National Convention

The Delegate Selection Plan for Puerto Rico provides for its pledged delegates to be allocated proportionally to presidential preferences based on Senatorial District Caucuses on June 7, 2008.

District-level delegates and alternates will be selected by Senate District Electors in Senate District Caucuses at the Puerto Rico Democratic Assembly on June 21, 2008. Puerto Rico's Democratic Assembly, an equivalent of a State Convention, will select the unpledged add-on delegate, pledged party leader and elected official delegates and at-large delegates and alternate on June 21, 2008. In addition, Puerto Rico's delegation includes unpledged delegates.

The delegation will select the standing committee members and the Delegation Chair at a meeting following the Puerto Rico Democratic Assembly on June 21, 2008. The State Chair will name Puerto Rico's Convention Pages at that time.

Statement of Candidacy and Pledge of Support forms for candidates for delegate and alternate are available from the State Democratic Party. These forms may be available on-line from the state party's website. Many state parties also provide additional information about the selection process and a link to the complete Delegate Selection Plan on their website.

District Level Delegates and Alternates

A majority of each state's delegates are elected from local districts (usually Congressional Districts). Each district level delegate pledges support to a presidential candidate of his or her choice (or "uncommitted"). This is the first category of delegates to be selected. Any Democrat is eligible to run for one of these positions. These delegates are allocated to presidential candidates based on the results of the state's primary or caucus in the respective district. Candidates should refer to the state party's Delegate Selection Plan for information on the number of delegates and alternates to be elected in their specific district.

Filing Requirements for District Level Delegate & Alternate Candidates

File statement of candidacy and pledge of support with Democratic Party Chair.

Party Leaders & Elected Officials (PLEO) Delegates

Democrats eligible for PLEO delegates are big city mayors, statewide elected officials, state legislative leaders, state legislators, and other state, county and local elected officials and party leaders. Candidates for these positions must file a written statement of candidacy and a signed pledge of support for their presential candidate. These delegates are allocated to presidential candidates based on the statewide results of the presidential primary or caucus.

At-Large Delegates and Alternates

This is the final group of delegates chosen. Any Democrat within the state is eligible for one of these positions. Candidates for these positions must file a writer statement of candidacy and a signed pledge of support for their presidential candidate. These delegates are allocated to presidential candidates based on the statewide results of the primary or caucus. At-large delegates help the delegation to reflect the demographics of the state's Democratic Party and competition for these positions is intense.
