





# building safe communities

The National Safety Council has been compiling and analyzing national injury data every year since the 1920s. Data released earlier this year provided mixed reviews of the nation's safety and health in our workplaces, on our roads, and in our homes and communities.

During National Safety Month in June, the Council alerted the nation to an estimated 12 percent increase in the rate of accidental deaths between 1992 and 2005. We warned that, with the number of preventable deaths in 2005 exceeding 113,000, we are on track to surpass the nation's all-time total high of 116,000 accidental deaths in just a few years.

Increases in both the rate and number of unintentional deaths are being driven largely by a dramatic rise in unintentional deaths occurring in our homes and communities. In fact, more than half of all injury-related deaths, and 75 percent of all disabling injuries, occur in and around the home.

While not diminishing our roots and progress in occupational safety, the data demand we make an even greater commitment to our nation's growing need to address safety and health 24/7.

In recent years, the Council has moved to align its initiatives with those areas where we recognize a need to have a greater impact. Our outreach to and promotion of CEOs who "get it," and our Off-the-Job Safety Symposia, for example, have enabled the Council to impress upon business leaders the need for a safety culture that extends well beyond the corporate campus to include the safety and health of employees and their families in all aspects of their lives.

We have implemented strategies that involve greater engagement of the Council's chapters, members, volunteers, and partners at the local, regional and national levels in an effort to have a greater impact on injury data in communities across the U.S.

We entered into discussions with the World Health Organization regarding its international Safe Communities initiative and explored how the National Safety Council could engage and enhance safe communities in our country through the synergy of this outstanding, proven global program.

We are pleased that the World Health Organization has selected the National Safety Council as the WHO Affiliate Safe Communities Support Center for the U.S. Only 10 support centers exist in the world.

We also looked to our leadership — the men and women from businesses and organizations who serve as NSC Board members — for their perspectives on national injury trends.

Today, members of the Council's Board of Delegates, who represent the safety interests of a broad cross section of businesses and industries, also serve on either: the Workplace, Transportation or Home & Community Safety Venue.

Each venue group is charged with identifying issues that transcend individual business and industry sectors. Recommendations for action are then made to the Council for consideration.

With our continuing strong fiscal performance and support from our Board leadership, chapter network, more than 50,000 member organizations, and thousands of volunteers, our vision for a vast network of safe communities across America is becoming a reality.

By working together to build safer and healthier communities, we can reverse current injury trends and, by doing so, save billions of dollars and hundreds of thousands of lives.

# "Not a single person should go home injured from the job, ever."

Chair, NSC Workplace Venue Director of Safety, Environment, Standards Deere & Company Since 1992, the year the nation reached its lowest injury-related death rate, workplace injuries have declined 17 percent.

As employers and safety leaders, we have a substantial responsibility to continue to ensure that the nation's workplaces are safe and that employees have the training and experience they need to perform their jobs safely. The goal is zero injuries.

While occupational injuries have declined substantially, national demographic and cultural shifts are creating new safety and health challenges for employees and employers.

"These are burning issues that have everything to do with company culture," said Laurie Zelnio, NSC Workplace Venue Chair. "Not a single person should go home injured from the job, ever."

Among the issues being examined by the NSC's Workplace Venue:

- The nation's large and growing immigrant workforce, much of which is working in high-risk injury jobs and challenging traditional occupational safety methods.
- Language, literacy, education and cultural differences that require more customized safety training for an enormous but vulnerable segment of the working population
- An aging workforce, which suffers fewer injuries and illnesses than younger workers yet has more serious injuries and illnesses and requires more time off
- Older workers beginning to retire being replaced by younger, more mobile and, as a result, less trained and experienced employees

One-third of the workforce changes jobs every year. Today, it's expected that the average worker will change jobs nine times by the age of 34. This demographic shift affects the SH&E profession, where about 60 percent of the workforce is age 46 or older and 40 percent have 10 years' experience or less, according to *Safety+Health* magazine's 2007 Salary Survey of responding readers.

The Workplace Venue explored this trend last year and identified two radical shifts: an increase in safety and health degree programs that provide graduates with nontraditional administrative and evaluation skills, and more employers who can't or won't invest their resources to support full-time safety and health positions.

"We're wrestling with how to fill the need with the expertise available," said Zelnio.

Workplace Venue delegates are also seeking ways to impress the value of off-the-job safety programs on employers. According to Zelnio, most companies have done a good job at creating a safe workplace. "Now we need to champion off-the-job safety programs that take what we do so successfully in the workplace and apply it so employees can protect their families," she said, adding, "Safety on or off the job is not a single program. It's a journey."

Workplace Venue efforts last year also included a white paper recommending injury prevention initiatives for an aging workforce, identifying the need for cross-cultural injury prevention programs for non-English-speaking workers, and planning how to gain better insight into corporate America's view of safety and health and create effective ways to help them.

Zelnio has her own way of assessing venue priorities. Asking colleagues 'What keeps you up at night?' is a regular discussion-starter for her Workplace Venue meetings.

"No matter what industry you're from, you can answer that question. It makes it easy to come together about safeguarding employees."

### Safety+Health

Among safety and health professionals, the National Safety Council's monthly *Safety+Health* magazine is the preferred source for industry news, trend analysis and best practices. In fact, 86 percent of readers surveyed said *Safety+Health* is most helpful when compared to other industry magazines.

Popular Safety+Health features include: nationally recognized guest columnists, "CEOs Who 'Get It'," the Safety+Health Annual Salary Survey, and the "OSHA Top 10" list.

Winner of American In-house Design Awards for the second consecutive year, *Safety+Health* now reaches 86,000 monthly subscribers.

That's the largest circulation of any publication in the safety industry. In fact, *Safety+Health* circulation has grown more than 192 percent in the past six years. While advertising in the safety publishing market grew 2 percent last year, advertising in *Safety+Health* grew 39 percent, according to IMS Auditor advertising tracking data.

With 42,000 motor vehicle fatalities a year, automobile crashes continue to be the nation's leading cause of preventable death.

It's an issue for employers, communities and families.

The Transportation Venue devoted much of the last year to mapping strategic priorities and platforms to address emerging national safety issues including graduated driver licenses (GDL), elderly drivers, large truck safety and impaired driving. Venue Chairman Stephen Campbell says the effort reinforces the Council's leading role in traffic safety.

"We are laying the groundwork to strengthen the Council's foremost position in national and state-level discussions about safety on our roads and highways," Campbell said.

The National Safety Council continues to be at the forefront of efforts to bring together employers, law enforcement agencies, government groups and traffic safety advocates to improve the nation's driving culture.

In the '60s we introduced the nation's first driver improvement program and created the term and the technique that is Defensive Driving. Today we are the premier source for traffic safety education programs, enrolling 1.6 million drivers annually in Defensive Driving Courses led by more than 7,500 instructors at 2,000 training centers.

Since its original DDC program, NSC has developed 30 specialized drivers' courses including programs for corporate use in loss prevention initiatives, fleet drivers, and as an integral component of employee off-the-job safety programs.

In 1996, we teamed with auto manufacturers, government agencies and insurers to launch the Air Bag and Seat Belt Safety Campaign, focused on saving lives through primary seat belt laws, high-visibility enforcement of belt laws, and having children ride in the back seat.

Widely recognized by the "Click It or Ticket" mobilizations it helped initiate, the campaign is credited with saving an estimated 20,000 lives over 10 years. Air Bag and Seat Belt Safety Campaign founders and funders were honored with the Flame of Life Award at the Council's 94th Annual Congress & Expo in October 2006.

Recently, Council leadership in transportation safety has extended to include teen driver issues. One of our fastest-growing programs is the *Alive at 25* defensive driving curriculum, which has helped train more than 500,000 young drivers. The Colorado State Patrol is one leader in providing *Alive at 25* to local communities. In 1996 this organization taught about 250 students. Today, through its work with more than 150 courts statewide, the Patrol is on pace to teach at least 20,000 students annually.

Teen driver safety is also an area where Council Chapters have excelled at locally implementing national programs. The Safety and Health Council of North Carolina, South Carolina Chapter of the National Safety Council, and the New Jersey State Safety Council each worked extensively with community leaders in 2007 to promote *Alive at 25*.

In South Carolina, Dutch Fork High School held a kick-off event with presentations by NSC and the South Carolina Chapter as well as local leaders and the families of three Dutch Fork students who had died on the road within that school year.

Talks highlighted how *Alive at 25* helped individuals respond to the tragic teen deaths that had scarred their community.

"Images will last in your mind more than a statistic," said one Dutch Fork student who had completed *Alive at 25*.

The NSC's International Symposium convened researchers, policy makers, state and federal officials, and representatives of the auto and insurance industries to discuss the causes of teen driver crashes and how to help prevent them. Symposium sponsors included Geico, State Farm, the U.S. Centers for Disease Control and prevention, the National Highway Traffic Safety Administration, General Motors and Nationwide Insurance.

NSC also teamed with Toyota to produce the "Toyota Challenge," a nationwide series of educational efforts to promote teen driver safety, including the ToyotaTeenDriver.com Web site, high-visibility national advertising and development of "Driving Expectations," a four-hour parent/teen driving curriculum.

The Transportation Venue recently secured NSC representation on the Motor Carrier Safety Advisory Committee of the Federal Motor Carrier Safety Administration. Timing is critical. NSC plans to be a vital ally in the reauthorization of the U.S. Department of Transportation's budget for highway safety programs, Campbell said.

"I am proud and honored to be a part of the Council right now. I am excited to see us do even greater things," Campbell said.

# "We're working to change the nation's safety culture."

The rate of injuries occurring in our homes and communities has risen 30 percent since 1992.

In 2005 an estimated 64,600 unintentional-injury deaths occurred in American homes and communities, or 57 percent of the unintentional-injury deaths that year. Employees and their dependent family members account for more than 60 percent of both injury-related deaths and disabling injuries.

Just as we have come to expect a corporate responsibility for sending employees home safe and healthy at the end of each day, we must now recognize the corporate and social value of having employees come to work as safe and as healthy as they were when they left.

"When people think of the National Safety Council they think of the workplace," said Susie Tesh, Home & Community Venue Chair. "But we are on the cusp of leading the nation forward in home and community safety. We are working to change the nation's safety culture and it's critical we get the word out."

In 2005, the costs of all injuries to society grew to more than \$625 billion nationally, or \$5,500 per household. The cost of employee injuries exceeded \$384 billion with nearly two thirds of that cost attributable to employee injuries suffered while off the job.

"Educating more companies about the importance of caring for their employees, their families, and their communities is the right thing to do," said Tesh. "Employers, too, will see less absenteeism, reduced operational costs and greater efficiency. It's a win-win scenario."

Working to reverse these trends, the National Safety Council hosted its second Off-The-Job Safety Symposium in 2007.

This past year the Council met with representatives from the World Health Organization at our home office in Itasca, Illinois, to advance NSC's formal designation as the WHO Affiliate Safe Communities Support Center for the United States.

The effort entailed conducting site visits to multiple Council chapters. Thanks to the exceptional efforts of two chapters, the Safety Council of the Ozarks and the National Safety Council of the Greater Omaha Area, the cities of Springfield, Missouri, and Omaha, Nebraska, became the 112th and 113th cities to receive WHO Safe Communities designations.

The Council will support Safe Communities America by serving in an advisory and coordinating capacity to help communities determine their safety needs, establish benchmarks for improving community safety and health, and create and foster local safe community coalitions.

"The timing is right. The Council has a great opportunity to make a difference," Tesh said. "But, to be successful, we must map our actions and lead the nation into a new era of safety. While I'm convinced of the importance of our direction, we must locate the data to support certain initiatives we have planned."

Older adult falls are an example of one such pressing public health issue. One-sixth of Americans over 65 years old experience a disabling or fatal fall at a cost of an estimated \$19 billion annually in medical expenses.

To help reduce the incidence, severity and financial impact of fall-related injuries, the National Safety Council partnered with AARP, the National Council on Aging and the Home Safety Council to advocate passage of the Keeping Seniors Safe from Falls Act of 2007.

Introduced to the 110th Congress with support from Senators Enzi (R-WY) and Mikulski (D-MD), the bill passed the Senate within four months. It is now pending approval by the House of Representatives, sponsored by Representatives Pallone (D-NJ) and Hall (R-TX).

Issues surrounding falls will only intensify as our population ages. Yet the Council is optimistic that a federal policy commitment to safeguarding older adults is within reach.

Our ability to help shape local and national policy will further advance in 2008 through at least two initiatives: Safe Communities America and NSC's annual Government Day. Both will help bridge issues of local urgency to Council members and the public with the Council's national advocacy efforts to advance American safety.

# the **business** community



Proving again that safety has no boundaries, for the first time the National Safety Council presented its Robert W. Campbell Award to a company outside of North America. Bahrain Petroleum Company (BAPCO) received the 2007 international award for business excellence through safety, health and environment management, recognized for demonstrating that SH&E is directly linked to its performance, productivity and sustainability. BAPCO President and Chief Executive Dr. Mustafa Al-Sayed accepted the award during the opening session of the NSC's 95th Annual Congress and Expo.

One of the oldest and largest petroleum companies in the Middle East, BAPCO employs 3,200 full-time employees and more than 1,300 contractors. BAPCO devotes an annual budget of \$20 million to SH&E activities

In another "first," the Council presented the 2006 Robert W. Campbell Award to two companies following rigorous assessment of award applicants by an independent panel of reviewers. **Alcan Inc.**, a Montreal-based leader in aluminum and packaging, and DynMcDermott Petroleum Operations Co., a private New Orleans-based firm that manages the U.S. Strategic Petroleum Reserve, both received the award at the Council's 94th Annual Congress and Expo, represented by Alcan Inc. CEO Richard Evans and DynMcDermott CEO Robert McGough.

Co-founded by the Council and ExxonMobil Corp. in 2002, the Campbell Award recognizes businesses that track, measure and document how their SH&E performance improves productivity, profitability and other key business performance metrics.



### **Green Cross for Safety Medal**

The National Safety Council awarded the 2007 Green Cross for Safety Medal to UPS and its CEO and Chairman Michael L. Eskew, recognizing the world's largest package delivery company — also the country's third-largest employer — for its exemplary century-long commitment to workplace safety.

Safety has been part of the UPS leadership philosophy from its beginning, with safety guidelines originally developed for company messengers on bicycles and then for drivers of the Ford Model T.

Today, UPS invests more than \$300 million annually in safety-related training. UPS employees receive more than 1.3 million hours of safety-related training each year.

Green Cross Medal recipients are announced during the Opening Session of the NSC's Annual Congress & Expo and honored at a special recognition dinner that brings together past recipients of the award: DuPont, Liberty Mutual Group, Chrysler Group of DaimlerChrysler, Kenny Construction Company, Ryder Systems Inc., Intel Corporation, and AK Steel Corporation.

# the injury prevention community

The National Safety Council strengthened formal alliances with key federal agencies in FY 2007, enhancing our ability to advance a national safety and health agenda.

The NSC alliance with the Occupational Safety and Health Administration (OSHA), in place since 2003, consolidates resources to improve safety and health in America's general and construction industries, and to provide employers and employees with safety information, guidance and access to training.

The alliance focuses on reducing traffic collisions and related worker deaths and injuries, and providing workplace First Aid, CPR and AED training. It targets small businesses and Hispanic and youth workers with information and strategies for staying safe on the job. The Council also provides emergency response training for a host of employers, ranging from large corporations to local day care centers.

The NSC alliance with the Mine Safety and Health Administration (MSHA), in effect until 2009, supports the development of safety and health programs for the mining industry and educational public outreach. The alliance was renewed at a time when tragedies underscored the need for safety education and new technologies to reduce the rate of accidental deaths in the U.S. mining industry. As a result, the alliance advances the "Stay Out-Stay Alive" public awareness campaign that unites more than 70 federal and state agencies, private organizations, businesses and individuals to promote safe practices around mines.

The Council also worked with top federal safety agencies last year to deliver its injury prevention

messages to employers in the language of senior management and safety, human resources and risk management professionals.

Developed cooperatively with OSHA, MSHA and the National Institute for Occupational Safety and Health (NIOSH), the live 60-minute Internet video conferences among leading safety experts invited listeners to submit questions on topics of workplace safety and health.

Offered to Council members and others in three separate series, broadcast topics included:

### **NSC and OSHA**

- OSHA strategies and actions impacting employee safety and health
- Leading issues in occupational safety compliance and safety and health violations
- Preparing for a pandemic: what employers need to know
- The benefits of OSHA's VPP Status and its benefits for employees and employers

### **NSC and MSHA**

- Mining industry injury and fatality trends
- Training resources for mine safety
- The 2006 Miner Act and new civil penalty provisions

### **NSC and NIOSH**

- The risks of hiring youth and how to protect them from workplace hazards
- Managing, controlling and anticipating safety and health issues associated with nanotechnology

# the sh&e community



The National Safety Council's Annual Congress & Expo is the longest running and largest annual event in the nation dedicated to safety, health and environmental management.

Held in San Diego, the Council's 94th Annual Congress & Expo attracted SH&E professionals from around the world seeking information about leading industry issues and access to national and international experts. It was also the forum for presenting the Councils' Distinguished Service to Safety Awards (DSSA) for lifetime achievements in injury prevention.

The DSSA is the highest honor bestowed on individual safety professionals by the NSC. The eight recipients recognized in at the 94th Annual Congress & Expo were:

# the **emergency care** and **response** community

No one can predict when an emergency will strike. However, we do know that every second counts when it comes to emergency response. About 75 to 80 percent of all out-of-hospital cardiac arrests happen in the home. The National Safety Council estimates that 25 percent of emergency room visits could be avoided if more people were trained in First Aid, CPR and AED. In fact, administering CPR with AED immediately after cardiac arrest can double a victim's chance of survival.

This year, the NSC provided training for 325,000 rescuers through 8,500 authorized trainers at some 1,500 training centers. The Council is also a member of the Department of Homeland Security's Citizen Corps, a national network of organizations and individuals committed to raising awareness about the importance of knowing how and when to respond to an emergency. The Council supports the Department of Homeland Security's National Preparedness Month each September and dedicates a week to emergency preparedness education during the Council's annual June observance of National Safety Month providing vital emergency care information to employers and their employees.



# the **research** community

### **Journal of Safety Research**

The National Safety Council's Research and Statistical Services Department publishes the *Journal of Safety Research* bimonthly, as an interdisciplinary forum for exchange of ideas and data in all areas of safety.

All *Journal* articles are peer reviewed by a distinguished panel of industry experts and researchers. The *Journal* is indexed in 17 databases accessible to scientists and researchers worldwide, including Medline. Over 4,500 international institutions subscribe to the *Journal of Safety Research* and over 56,000 articles are downloaded annually.

Five of the *Journal's* most downloaded articles include:

- The application of the psychological contract to workplace safety
- A challenge to the assumed generalization of prediction and countermeasure for risky driving: Different factors predict different behaviors
- The relationship between employees' perceptions of safety and organizational culture
- Technology and teen drivers
- Safety in shipping: The human element

# the global community ual report

With more than 500 members from 70 countries active in the National Safety Council's International Safety Council, the NSC is having an impact on safety and health well beyond our traditional United States borders.

ISC international activities include numerous partnerships and initiatives and range from Mexico, Brazil, and Argentina, to China, India and the Middle East.

This year we completed a five-year Program to Improve Mine Safety in China, an important collaboration between the governments of China and the U.S. led by the National Safety Council.

The main objectives for the project, which began in 2003, were to develop ideas for improving: the mine rescue response system in China, government enforcement of coal mine safety requirements, and miners' and mine operators' use of safety practices in mines.

While we delivered more than 30 training sessions to nearly 1,800 trainees, participants themselves acknowledged that the lessons learned went beyond technical skills to realizing that a cultural shift has taken place within China's mining industry.

Last year there were more than 4,700 coal-miner fatalities in China. However, mining fatalities through July were down 15 percent compared with a year ago. While that is no consolation to the families and friends of lost miners, it signals progress in one of the most dangerous industries in the world.

This achievement is remarkable and shows it is possible to influence deeply embedded cultural differences and attitudes to save lives.

It is this level of impact that the National Safety Council seeks to achieve in every region of the world.

# celebrating safe communities

The National Safety Council established National Safety Month in June 1996 to increase public awareness of safety and health risks and ultimately decrease the number of people accidentally injured or killed in the workplace, on the road or in their homes and communities.

The annual observance reflects the Council's historical commitment to influencing Americans to adopt and maintain safe and healthy behaviors in all aspects of their lives.

Working with our national chapter and member network, the Council focuses injury prevention outreach during National Safety Month on specific areas of importance to public safety and health. Each week in June the NSC promotes targeted communications addressing safe driving, workplace safety, emergency preparedness, and home and community safety.

The Council promotes its messages through extensive National Safety Month communications outreach including information and materials to help businesses and organizations hold events and activities for their employees and communities.

The Council also promotes National Safety Month online — the National Safety Month Web site attracts more than 85,000 visitors — and through media outreach that in 2007 yielded national segments on NBC Nightly News, CBS Early Show, Fox News Channel, NPR, and more than 170 television placements in 86 media markets reaching an estimated audience of more than 17 million people. More than 100 newspapers, 300 media outlet Web sites and dozens of radio stations carried the National Safety Council's National Safety Month message.

Thousands of businesses, national safety and health advocates, community groups and organizations have come to embrace this national observance as an annual focal point for promoting safety in the summer months and throughout the year.

A 2006 survey of 481 small to mid-size businesses revealed that 70 percent find the Council's annual National Safety Month observance either "valuable" or "extremely valuable" to their own safety programs.

The National Safety Council strives to make our world a safer place. We are proud of our achievements in increasing awareness of safe and healthy practices, and of our efforts to instill a national culture of workplace, transportation, and home and community safety.



# the **nsc** community

The National Safety Council is a 501 (c) (3) nonprofit, charitable, international public service organization dedicated to educating and influencing people to prevent accidental injuries and deaths.

Founded in 1913 and chartered by the U.S. Congress in 1953, the NSC is the only organization promoting safety in the workplace, in transportation, and in homes and communities.

Through the support and collaboration of a national network of 40 state and regional chapters, the National Safety Council has an even greater impact and presence at the local level providing community-based programs and services, trainings, conferences, workshops and consultations as well as a local voice for safety and health advocacy.
