Sec. 3. Financial literacy education in schools.	16
The Mayor shall submit to the Council within 180 days after the effective date of this act	17
a plan for the implementation of financial literacy education in public schools.	18
Sec. 4. Establishment of the Financial Literacy Council.	19
There is established the District of Columbia Financial Literacy Council to assist and	20

advise the Mayor and the Council in promoting the financial literacy of the residents of the	1
District.	2
Sec. 5. Members of the Financial Literacy Council.	3
(a) The Financial Literacy Council shall consist of 9 members, as follows:	4
(1) One member shall be appointed by the Chairman of the Council and shall	5
serve as chairperson of the Financial Literacy Council.	6
(2) One member shall be appointed by the chairperson of the Council	7
committee with oversight of the Department of Insurance, Securities, and Banking.	8
(3) One member shall be appointed by the Chief Financial Officer.	9
(4) Six members shall be appointed by the Mayor and shall be comprised of:	10
(A) One member who shall represent the Department of Insurance,	11
Securities, and Banking;	12
(B) One member who shall represent the District of Columbia Public	13
Schools;	14
(C) Four members who shall be District residents with extensive	15
knowledge of financial institutions, personal finance, and financial literacy programs.	16
(b) Members shall not be compensated for their service on the Financial Literacy	17
Council.	18
(c) Members shall serve for terms of 4 years; provided, that of the initial members	19

(1) Members appointed under subsection (a)(4)(C) of this section shall serve an	1
initial term of 2 years; and	2
(2) Members appointed under subsections (a)(1), (a)(2), (a)(3), (a)(4)(A), and	3

Sec. 6. Duties of the Financial Literacy Council.	5
The Financial Literacy Council shall:	6
(1) Meet at least quarterly;	7
(2) Create and operate under its own rules of procedure;	8
(3) Develop a plan, to be submitted to the Mayor and the Council within 6	9
months after the effective date of this act, for the coordination of the District's various financial	10
literacy efforts;	11
(4) Submit to the Mayor and the Council an annual report and recommendations	12
on the financial literacy status of the District, with the first report and recommendations to be	13
delivered within 12 months of the effective date after this act; and	14
(5) In the first report, the Council shall endeavor to address, among other issues,	15
matters related to District residents' recovery from foreclosure, bankruptcy and consumer rights;	16

(5 6) Submit to the Mayor and Council other reports and recommendations as it	18
considers useful for the promotion of financial literacy in the District.	19

This act shall take effect following approval by the Mayor (or in the event of veto by the	7
Mayor, action by the Council to override the veto), a 30-day period of Congressional review as	8
provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December	9
24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of	10
Columbia Register.	11
