

**The Washington Redskins Season Ticket Wait List  
2008 SEASON TICKET SWEEPSTAKES  
OFFICIAL RULES**

1. **ELIGIBILITY:** Open to residents of Maryland, Virginia, West Virginia, Pennsylvania or Washington, D.C. who are age 18 or older. Employees, officers and directors of Pro-Football, Inc., WFI Stadium, Inc., the National Football League, or any of their respective subsidiaries and affiliates, advertising and promotional agencies and sweepstakes suppliers, including the spouses, members of household and IRS listed dependents of all the above, are not eligible to participate in this sweepstakes.
2. **SPONSOR:** WFI Stadium, Inc. d/b/a The Washington Redskins (“The Washington Redskins” or “Sponsor”)
3. **TO ENTER:** Simply subscribe to the Washington Redskins Waitlist by (1) registering online at [www.redskins.com/waitlist](http://www.redskins.com/waitlist) and completing all required information, (2) calling the Washington Redskins at (301) 276-6050 and providing all required information, or (3) writing to TWR-Waitlist Sweepstakes, 1600 FedEx Way, Landover, MD 20785 and providing your full name, mailing address (including street, city, state, and zip code), daytime and evening phone numbers, age, and email address if applicable. Entries must be received between August 1, 2007 and July 31, 2008 to be eligible for the Grand Prize. One entry per person. The Washington Redskins assumes no responsibility for lost, late, illegible, or misdirected entries. This sweepstakes is void where prohibited, and is subject to all federal, state and local laws. No purchase is necessary.
4. **PRIZES:** One (1) grand prize is available. One entrant (the “Winner”) will receive two (2) Washington Redskins season tickets for the 2008 football season (approximate retail value \$1408) (the “Grand Prize”). The Winner will be determined by random drawing of all eligible entries received. The number of eligible entries received will determine odds of winning. The random drawing will be held on or about August 2, 2008 and shall be conducted under the supervision of Sponsor whose decisions shall be final in all matters. Winner will be notified by mail. Failure by potential winner to respond to such notification within ten (10) days of the date of such notification will result in disqualification of the potential winner and an alternate winner will be selected. In the event the Winner chooses not to accept the Grand Prize or fails to meet the eligibility requirements or comply with these Official Rules, Sponsor shall draw an alternate winner (also referred to as “Winner”) in accordance with the terms herein. Grand Prize is not transferable and may not be substituted or exchanged. Grand Prize is subject to the terms and conditions printed on the tickets and other then applicable Washington Redskins ticket policies (as published on [www.redskins.com](http://www.redskins.com) and/or season ticket invoices). Any expenses relating to the receipt and use of the Grand Prize and federal, state and local taxes and fees applicable in connection with the Grand Prize are the sole responsibility of the Winner. The Grand Prize does not include any rights to parking, post-season games, other events at Sponsor’s facility or any rights to renew tickets for future years.
