Digital Files

- *Digital Files are preferred.
 - *280% maximum print density.
 - *Must be high-resolution: body minimum 266 dpi;
 - *Colors in files should be converted to CMK for bets color cover minimum 300dpi. Results.
 - *Files must be QuarkXPress 6.0 or lower, Adobe Illustrator.
 - *Supply zip disk or CD in Mac format. Adobe Photoshop, Adobe InDesign or high resolution/ print-ready Adobe PDF.
- *One (1) high-resolution proof should be supplied.
 - *All text in these files should be editable.

Film Requirements

- *Film: supply right-reading positives,
- *Body-screen rulings: four color, 133 lines; B/W 120 lines. Emulsion side down, min 3.5 density
- *Supply one (1) match print proof
- * 280% maximum print density.

- **Notes 1. Bleed dimensions include 1/8" bleed for trim.
2. Subtract 1/4" from bleed dimensions for both width and depth for trim size e.g., 8 1/2" x 10 3/4" bleed equals 8 1/4" x10 1/2" trim.
 3. For all bleed ads please keep all live matter 1/4" from final trim on all sides. E.g., 8 1/4" x 10 1/4" live area
