For APS Commission addresses, facsimile and phone numbers and further information including information about the submission of a statement in support of your application for review, please refer to the **Review of Certain Promotion and Engagement Decisions** section of the Gazette. Applications not received within the prescribed time cannot be accepted. It is your responsibility to ensure your application reaches the APS Commission office within the prescribed time.
- While you are welcome to submit your application for review form electronically by clicking the 'email this page' button, you should be aware that the internet is not a secure medium on which to transmit personal information. Your information will not be encrypted when it is sent to us over the internet. If you are concerned about this you may prefer to use an alternative lodgement method.
