I am aware that adventure travel and activities including hunting, whether in civilized or remote areas, by plane, train, automobile, boat, or any other conveyance, or on foot, involves inherent risks of illness, injury, death or loss and damage of property, which may be caused by negligence of others, forces of nature or other causes, known or unknown. I recognise that such risks may be present at any time before, during and after the trip that I am participating in under the arrangements of Reputable Safari Company Ltd. I am also aware that medical services or facilities may not be readily available during the time that I am participating in this trip.

I certify that I have read all of the above and fully understand its contents and the type of risks inherent in such trips.
