### SCHOOLS AND PUPILS IN ENGLAND, JANUARY 2007 (FINAL)

#### INTRODUCTION

This Statistical First Release (SFR) reports information about schools and pupils for the academic year 2006/07, collected in January 2007. It updates provisional information published in the Statistical First Release "Pupil Characteristics and Class Sizes in England" published in April 2007.

Most of the information presented in this SFR has been collected via the Schools' Census. It reports national trends on the number of schools and pupils in England. It gives findings for the number of pupils by age, gender, free school meal eligibility, ethnicity and first language together with a range of class size information.

#### **KEY POINTS**

#### **Pupils**

In January 2007 there was a headcount of 8.1 million pupils in 25,000 maintained and independent schools in England. The full time equivalent (FTE) number of pupils in maintained primary, secondary and all special schools was 7.3 million, down from 7.4 million in January 2006. 91 per cent of pupils were taught in maintained nursery, primary and secondary schools; the majority of the remaining 9 per cent were taught in independent schools.

#### **School Meal Arrangements**

- There has been a slight decrease in the proportion of pupils known to be eligible for free school meals. In 2006 the percentage of pupils in maintained nursery and primary schools known to be eligible for free school meals was 16.0 per cent and this has decreased to 15.9 per cent in 2007. See Notes to Editor 4 and 5.
- In January 2007, 13.1 per cent of pupils in maintained secondary schools were known to be eligible for free school meals. This represents a decrease from 13.6 per cent in 2006. See Notes to Editor 4 and 5.



# **Ethnicity**

• In maintained primary schools the percentage of pupils (of compulsory school age and above) who were classified as minority ethnic origin has increased from 20.6 per cent in 2006 to 21.9 per cent in 2007 – an increase of over one percentage point. A similar trend is apparent in secondary schools with 16.8 per cent of pupils classified by minority ethnic groups in 2006 increasing to 17.7 per cent in 2007. These changes may be due in part to an improvement in the completeness of the data held by schools – there has been a decrease in the percentage of pupils who were unclassified by ethnic group in both primary and secondary schools. # First Language

• In January 2007 the percentage of pupils in primary schools (of compulsory school age and above) whose first language is known or believed to be other than English was 13.5 per cent, which represents an increase of one percentage point when compared with last year. The same trend is apparent in secondary schools where the proportion of pupils whose first language is known or believed to be other than English increased by one a percentage point from last year to 10.5 per cent in 2007.

#### **CLASS SIZES**

# **Key Stage 1 Classes in Maintained Primary Schools**

• The average size of Key Stage 1 classes (including Reception) taught by one teacher has remained the same as last year at 25.6. Comparisons with 2006 should bear in mind a change in reporting between 2006 and 2007. See Notes to Editor 8-10.

# **Key Stage 2 Classes in Maintained Primary Schools**

• The average size of Key Stage 2 classes taught by one teacher is 27.2, a slight decrease from last vear.

#### **Overall Primary**

- In January 2007, the average size of classes (taught by one teacher) in primary schools was 26.2 which represents a slight decrease from 26.3 a year earlier.
- The percentage of pupils in large primary classes has decreased by almost a percentage point from last year to 14.4 per cent. This represents a decrease of 1.9 percentage points in the five years since 2003, when 16.3 per cent of pupils in primary schools were in classes of 31 or more pupils.

# **Classes in Maintained Secondary Schools**

- A decrease is evident in the average size of classes taught by one teacher in secondary schools, from 21.5 in January 2006 to 21.2 in January 2007.
- The percentage of pupils in classes of 31 or more pupils has decreased from 11.3 per cent in January 2006 to 11.0 per cent in January 2007.

# **PUPILS WITH SPECIAL EDUCATIONAL NEEDS (SEN)**

- In January 2007 some 229,100 (or 2.8 per cent of) pupils across all schools in England had statements of SEN, a slight fall when compared to last year.
- The percentage of pupils with statements of SEN placed in maintained mainstream schools (nursery, primary, secondary) was 57.2 per cent, down 1.5 percentage points from the previous year.
   Corresponding increases were seen in the proportion of pupils with statements of SEN placed in other school types, most notably in maintained special schools (up 1.1 percentage points to 36.0 per cent).
- In 2007 there were some 1,333,400 pupils with SEN without statements representing 16.4 per cent of pupils across all schools. This is an increase from 15.7 per cent a year earlier. Contrary to the pattern for pupils with statements of SEN, the incidence of pupils with SEN without statements is greater in primary schools (17.7 per cent) than in secondary schools (16.2 per cent).

#### **NOTES FOR EDITORS**

#### **Data collection**

1. This SFR contains information about school and pupil characteristics together with information on classes as taught during a single selected period of the school day. This information is derived from the Schools' Census (SC) returns made by schools to the Department in January.

# **Formatting**

2. Pupil numbers shown in the tables are rounded to the nearest 10, therefore totals may not always equal the sum of their component parts.

#### **Academies**

3. Readers should note that in January 2006 there were 27 Academies while in January 2007 there were 46 Academies. Therefore, care must be taken by readers who compare figures in this SFR with figures from previous SFRs to make sure that the coverage is aligned.

#### Free school meals

- 4. Prior to 2001, the numbers eligible for a free school meal were those pupils who had, or whose parents had, satisfied the relevant authority that they were receiving Income Support (IS) or income based Jobseekers Allowance (IBJSA) or support provided under Part 6 of the Immigration and Asylum Act 1999. From 2001 onwards this definition was modified to include only pupils where parents had indicated that they wished their child to have a free meal and had confirmed benefit receipt with the LA or school.
- 5. Under changes to the tax credit system introduced in April 2003, children in families receiving the Child Tax Credit (CTC) rather than IS or IBJSA would not have been entitled to receive a free school meal. As a result, for 2004 SC, the entitlement for free school meals was extended to 'non-working' families who have an amount of income that extinguishes their IS or IBJSA benefit, who are receiving support via CTC, but are working fewer than 16 hours per week and thus not in receipt of Working Tax Credit (WTC). The majority of these families would have received IS or IBJSA prior to 6 April (and accordingly their children a free school meal). As a result of this change to entitlement, these children continue to be eligible for free school meals.

# **Ethnicity**

6. Those pupils who have been classified as belonging to an ethnic group other than White British are defined as Minority Ethnic.

# English as an additional language

7. "First Language" is the language to which a child was initially exposed during early development.

#### Class sizes

- 8. The School Standards and Framework Act 1998 placed a duty on LAs and schools to limit the size of infant classes for five, six, and seven year olds taught by one teacher to 30 or fewer pupils. The limit became a statutory responsibility from September 2001. The Education (Infant Class Sizes) Regulations 1998 allow the limit of 30 to be exceeded in limited circumstances. This allows certain types of children to be treated as "excepted pupils" for the purposes of ascertaining whether or not the class size limit has been exceeded. Schools reporting large infant classes from January 2006 were contacted by the DCSF to establish the detailed reasons; the same information is not available for all such schools in previous years.
- 9. Following the outcome of a review into the presentation of class size statistics, slightly revised versions of the class size tables are included (Tables 11 and 13 in the provisional SFR 16/2007, now Tables 7a and 7b in this SFR). These make clearer the break in the time series caused by revised guidance on the reporting of large classes in January 2007 compared with January 2006. A small number of schools continued to report data on classes with 'excepted activity'. The revised guidance asked schools to select a period, on which their class size data are based, when infant classes are engaged in academic activity rather than on excepted activities (such as assembly PE/Games or Music, Singing, Drama, Watching TV or Listening to the Radio). The Department also clarified, in guidance, the limited circumstances in which pupils may be admitted as exceptions to the infant class size limit (excepted pupils). This has led to more accurate reporting of unlawfully large classes in primary schools. The key points are:
  - a. children with statements of special educational needs who are admitted to the school after the normal admission round;
  - b. children moving into the area outside the normal admission round for whom there is no other available school within a reasonable distance. From February 2007, legislation has required admission authorities to get local authority confirmation that a child falls into this category before admitting them as a permitted exception. This means that the LA will need to check whether there are places available for the child at any other school within a reasonable distance of their home:
  - c. children admitted outside the normal admission round because the person responsible for making the original decision recognises that an error was made in implementing the school's admission arrangements and that a place should have been offered;
  - d. children admitted where an admissions appeal panel upholds an appeal;
  - e. from February 2007, where the child is looked after and the local authority which is the corporate parent either (as admission authority) decides to admit the child to one of its community or voluntary controlled school, or directs another admission authority to admit the child outside the normal admissions round.

10. In 2003 Reception classes were returned alongside Nursery classes as Foundation Stage for the first time. In Table 7a Reception classes have been included in Key Stage 1 numbers for 2003 and later to produce coverage as close as possible to that available for previous years.

# **Special Educational Needs**

- 11. Arrangements for identifying and providing for children with SEN are set out in Part IV of the 1996 Act (and, prior to this, the 1981 and 1993 Education Acts). New rights and duties have been introduced by the SEN and Disability Act 2001 (SENDA). A Code of Practice, issued in 1994, supported the rights and duties in the 1996 Act. A new SEN Code of Practice was introduced in January 2002. All LAs, schools and early years settings must have regard to it.
- 12. The new Code of Practice replaced the five stages with School/Early Years Action, School/Early Years Action Plus and Statements of SEN. The effect of this change has been to reduce the number of pupils recorded as having SEN without statements. Numbers of children with SEN without statements reported in 2003 and later are not directly comparable with earlier years.
- 13. In 2004 information was collected from schools on pupils at School Action Plus and those pupils with statements of SEN about their main or primary need and, if appropriate, their secondary need.
