CATEGORY A

- 1. **a Drivers Licence**: a current licence or permit issued under law of a State or Territory or equivalent authority of a foreign country for the purpose of driving a vehicle that contains a photo of the person; or
- 2. a Passport issued by the Commonwealth. This must be current or, less than two years expired
- 3. a Passport or Similar Document Issued for International Travel that:
 - contains a photo and signature of the person
 - is issued by a foreign government, United Nations or an agency of the United Nations AND
 - is written in English
- 4. **a Card Issued under a Law of a State or Territory** for the purpose of proving the person's age which contains a photo (e.g. a Proof of Age Card)

CATEGORY B

- a Birth Certificate or birth extract issued by a State or Territory; or

a Notice

- (a) issued to an individual by a local government body or utilities provider within the preceding three months

 - e.g. a Rates Notice from your Local Council

*Certified copy: means a document that has been certified as a true copy of an original document by one of the following persons:

- A Justice of the Peace
- An officer with two or more continuous years of service with one or more financial institution
- A person enrolled on the roll of the Supreme Court of a State or Territory, or the High Court, as a legal practitioner;
- An officer with, or authorised representative of, a holder of an Australian financial services licence, having two or more continuous years of service with one or more licensees
- A police officer
- A judge
- A magistrate
- A CEO of a Commonwealth court
- A registrar or deputy registrar of a court
- An agent of Australia Post in charge of supplying postal services
- A permanent employee of Australia Post (for at least two years) employed in an office
 A finance company officer with two or more continuous years of service with one or more finance companies
- A member of the Institute of Chartered Accountants in Australia, CPA Australia or the National Institute of Accountants with two or more years of continuous membership

In order for your ID to be accepted, it must be certified and the certifier is to state that the document is a certified copy of an original and then provide their details, such as: name, address, phone number and under what category of "certifier" they fall. We cannot accept a fax of a certified copy.
