

Official Rules
“The Daria Lost Art Sweepstakes”

1. NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

2. **Entry Period:** “The Daria Lost Art Sweepstakes” (the “Sweepstakes”) commences at 12:00:01 PM (ET) on April 20, 2010 and ends at 11:59:59 PM (ET) on May 30, 2010 (the “Sweepstakes Period”). All entries must be received by 11:59:59 PM (ET) on May 30, 2010.

3. **Eligibility:** This Sweepstakes is open to legal residents of the 50 United States and District of Columbia. Entrants must be at least 18 years of age or older at time of entry. Entrants who have not yet reached the age of majority in the jurisdiction in which they reside will need to obtain permission from their parent/legal guardian in order to enter Sweepstakes. Employees and their immediate families (*i.e.*, parents, spouse, children, siblings, grandparents, step parents, step children and step siblings) of MTV Networks, a division of Viacom International Inc. (“MTVN” or “Sponsor”) and its affiliated companies, sponsors, subsidiaries, advertising agencies and third party fulfillment agencies, and their respective agents, employees, officers, directors, successors and assigns (collectively, with MTVN, the “Released Parties”) are not eligible to enter Sweepstakes. In the event of a dispute over the identity of an entrant who has entered online, the authorized subscriber of the e-mail account used to participate in the Sweepstakes at the actual time of entry will be deemed to be the entrant. The authorized account subscriber is defined as the natural person who is assigned an e-mail address by an Internet access provider, online service provider or other organization (e.g. business, education institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Entrants may enter as often as they wish but there is a limit of one (1) Grand Prize per person. All entries submitted in accordance with these Official Rules shall be hereinafter referred to as “Eligible Entries”. All entries become the property of MTVN and will not be acknowledged or returned. MTVN will make up to two (2) attempts over the 48 hour period following Grand Prize Winners selection to contact the potential Grand Prize Winners via the telephone number(s) provided on his/her entry form. If any potential Grand Prize Winner cannot be reached during the 48 hour period in which he/she is called (no messages will be left on answering machines or voicemail systems) the potential Grand Prize Winner will be disqualified and an alternate Grand Prize Winner will be selected from among the remaining Eligible Entries received.

6. **Grand Prize Winner Verification:** Each potential Grand Prize Winner must prove eligibility, including, without limitation, proof of age and residence within two (2) days of being notified as the potential Grand Prize Winner. In the event of

non-compliance by any potential Grand Prize Winner such potential Grand Prize Winner shall be disqualified and all privileges otherwise due as the Grand Prize Winner shall be terminated and an alternative potential Grand Prize Winner may be chosen from among all of the remaining Eligible Entries received in MTVN's sole discretion. The approximate retail value ("ARV") of each Grand Prize is \$87.99 and is subject to change based on current market conditions at time of Grand Prize fulfillment.
