

HOW TO APPLY

- Before February 1, visit www.scu.edu/lawapply and complete our online application. If you prefer a paper version, you can download a PDF from us at that address, or give us a call at the number on the back cover.
- 2. You'll also need to submit a personal statement—it helps give our admissions committee a more complete picture of you and your experiences.
- 3. Letters of recommendation are optional, but strongly encouraged, and you can submit them through the Law School Data Assembly Service (LSDAS) (see www.LSAC.org). NOTE: Students who obtained their bachelor's degree from outside of the United States must instead register for JD-CAS (also available on the LSAC web site).
- 4. Take the Law School Admission Test no later than February prior to the year you plan to enroll (see www.LSAC.org).
- Subscribe to LSDAS and have your transcripts sent directly to the Law School Admission Council (LSAC).
- 6. If you are accepted, we will need an official transcript from your undergraduate institution showing the date your degree was awarded.

SPECIAL ADMISSION POLICY DIVERSITY OUTREACH

We are one of the most diverse law schools in the nation because we understand society's need for lawyers from all backgrounds. We work to identify, recruit, enroll, and provide academic support to ethnic minority applicants and others who show the potential to succeed.

EARLY ACTION PROGRAM

If you submit your application by November 1 and your admission file is complete by November 30, you'll have our decision by late December. Early action admission is non-binding—you simply need to make a tuition deposit by April 1 if you decide to enroll.

ADMISSION TO ADVANCED STANDING OR TRANSFER STUDENTS

If you have successfully completed one year of study at another law school accredited by the ABA, you may apply to transfer to Santa Clara Law (visit www.scu. edu/lawapply for our online application). We usually reserve 10-20 seats each year for the strongest transfer candidates, and our decisions are based heavily on your prior law school performance. To apply, please submit

- An official transcript from your undergraduate degree-granting school
- An official transcript from your law school
- A letter from your dean saying you are in good standing and eligible to return
- Your LSDAS report sent directly from LSAC

To enroll in the fall, please apply by July 1; for the spring semester, please apply by November 1.

LOANS

Most law students are eligible to borrow up to \$20,500 through the federal Stafford Loan Program. Students can borrow additional federal funds up to the cost of attendance through the Federal Grad PLUS Program.

EMPLOYMENT

We want you to focus on your studies, and so we discourage full time students from working, at least during your first year. (If you must work, we ask that you don't work more than 10 hours a week.) Parttime, on-campus employment based on financial need (Federal Work Study) is available after the first year. Additional on-campus and off-campus opportunities are available to help pay tuition costs, too.

FELLOWSHIPS AND SCHOLARSHIPS

- Dean's Fellowships—up to full tuition based on academic achievement
- Law Faculty Scholarships—need-based partial tuition awards
- Emery Law Scholarships—merit-based partial tuition awards
- Public Interest and Social Justice Scholarships partial tuition awards based on demonstrated passion for public interest work
- Numerous Endowed Scholarships—both needand merit-based

HOW TO APPLY FOR FINANCIAL AID:

- Complete the FAFSA (www.fafsa.ed.gov), and be sure to select Santa Clara University School of Law (our code is 001326) as one of the schools to receive your information.
- On your Santa Clara Law application, be sure to check the box indicating you would like to be considered for a scholarship.
