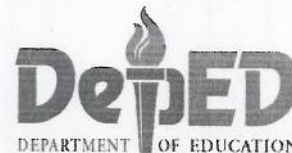



GUIDELINES FOR DISPOSAL OF AIRCRAFT

1. Submission of sealed bid proposal shall be on per aircraft model.
2. After all bid offers have been submitted, the committee will open and read publicly each offer in the presence of the Commission on Audit representative. Bid prices will be projected on screen.
3. Result of the sealed canvass will be announced after all offers have been read. There may not be an award if the highest bid price offered does not meet the floor price.
4. After being proclaimed by the BAC on Disposal, the winning bidder is required to immediately post a bid bond in cash equivalent to ten percent (10%) of the bid price offered and submit his copy of Mayor's Permit, DTI Registration immediately. Should the winning bidder failed to immediately submit the bid bond, the award will be recommended to the second highest bidder.
5. The bid bond shall be returned only after the items have been completely removed/hailed within the prescribed ten (10) working days from the date of receipt of award. DepED reserves the right to award the items/lot to the second lowest bidder if the highest bidder defaults on his responsibility.
6. DepED reserves the right to reject any or all bids, to waive any formal requirement therein and to accept any or all other offers that may be considered advantageous to DepED.



INSTRUCTION TO BIDDERS

1. All bidding participants must bring a copy of Mayor's Permit / DTI Registration
2. Award shall be made to the highest bidder, who, upon proclamation after the opening of sealed bid proposal that he is the awardee, must:
 - Post a bid bond equivalent to ten percent (10%) of the total bid offered, which must be paid in cash and shall be returned only after the items have been completely removed/hailed within the prescribed period.
 - Pay the whole amount of the bid in cash upon receipt of Notice of Award
 - Remove/haul the item/s at own expense within ten (10) working days from receipt of Notice to Proceed otherwise, DepED shall charge a storage fee of ten percent (10%) of the bid price per day of delay in removing the items
3. Failure to comply with any provision in item 2 shall cause the forfeiture of the winning bidder's bond and the cancellation of the award in favor of the Department of Education without further proceedings.
4. Sealed bids shall be accepted by the BAC on Disposal and shall be publicly opened in the presence of a representative from the Commission on Audit
5. The Department of Education reserves the right to reject any or all bids, to waive any formal requirement therein, and to accept any or all other offers that may be considered advantageous to DepED. The decision of DepED shall be final and binding.
