- 3. A special license plate is to be displayed on the rear of the vehicle for which it is issued. The regular license plate may be kept inside the vehicle and produced upon request by law enforcement.

A special license plate may be transferred to another vehicle upon the owner's submission of a completed **Request to Transfer Form** (OTC Form 783-A) to the Motor Vehicle Division, Special License Plate Section.
