1. *Memorial Yahrzeit*

With G-d's help there will be a memorial Yahrzeit for Rabbi Meir Kahane

3. *Donations for Kahane Chai Legal Defense Fund*

As many know the state department has put an innocent party, Kahane Chai, on the terrorist list. This absurd and evil act was not challenged in court for a number of years due to the tremendous cost of litigation. Finally someone has stepped up to the plate and taken on the case. Attorney Kenneth Klein opened the legal challenge in the Washington D.C. Circuit Court of Appeals.

To date Mr. Klien has done the following:

- a. Filed dozens of motions over **the past three years.**
- b. Forced the state department to deliver an 'administrative record' which details the supposed terrorist activity of Kahane Chai. *It took over a year for that record to finally be delivered.*
- c. Responded to the State Department with evidence showing the inaccuracies and inconsistencies within their record. (The court had ordered the state department to accept evidence and to make a 'de novo' review of the record which would now include the responses submitted by Mr. Klein.)

- d. Filed a full legal brief with the court. This brief details the contradictions, inaccuracies and outright falsehoods in the government's administrative record.
- e. Received a response brief from the government.
- f. Filed a reply to the government brief.
- g. On September 8, 2006, Mr. Klein made oral arguments in front of a panel of three justices from the D.C. court of appeals: Sentelle, Ginsburg, and Williams.

This took over a thousand hours of work by Mr. Klein! He has done excellent work without demanding large fees. But he is owed a significant amount of money for this work and cannot continue without getting paid.

Update!! The court has just – October 17, 2006 - rejected Mr. Klein's petition! It is not over! This case is expected to be presented before the full court and it might have to reach the Supreme Court. This must be fought until the end!! In addition to this, there are a number of other legal battles that must be fought.

Please donate as much as you can for this effort.

An effect of having any group wrongly placed on a list is to frighten other groups and other people from speaking and educating. This is why we must get involved – this designation directly affects everyone's right to express the truth, and has a chilling effect, invoking fear in those who are innocent.

All money collected for this purpose will be forwarded to the appropriate parties with no expenses deducted.

When you send your donation, simply include a separate piece of paper indicating the purpose of your donation so that it will be designated appropriately.
