#### **Identify and Share Best Practices**

The NGA Center evaluates public policy innovations and provides governors with practical solutions through:

- Published research reports, policy analyses, issue briefs, and a variety of other materials examining today's most pressing issues;
- Policy workshops, seminars, academies, and cross-state learning labs;
- Challenge grants awarded to states to build pioneering policy agendas or improve existing policies by implementing best practices.

### **Provide Tailored Technical Assistance**

The NGA Center uses comprehensive information on best practices, on-site problem analysis, and trusted advice from colleagues across the country and in-house policy experts to:

- Analyze state challenges with governors' policy and program staff;
- Produce confidential, quick-response memoranda on specific policy requests;

# **OUR EXPERTISE**



## ECONOMIC, HUMAN SERVICES & WORKFORCE DIVISION

focuses on best practices, policy options, and service delivery improvements across a range of current and emerging issues, including economic development and innovation, workforce training, employment services, research and development policies, and services for children, youth, low-income families, and people with disabilities.



### EDUCATION DIVISION

provides information on best practices in early childhood, elementary, secondary, and postsecondary education. Specific issues include common core state standards and assessments: teacher effectiveness; high school redesign; science, technology, engineering, and math (STEM) education; postsecondary education attainment. productivity, and accountability; extra learning opportunities; and school readiness.



### ENVIRONMENT, ENERGY & TRANSPORTA-TION DIVISION

identifies best practices and provides technical assistance on issues including clean energy for the electricity and transportation sectors; energy, transportation, and infrastructure financing; building a modern energy workforce and related industries; transportation and land use planning; and clean up and stewardship of nuclear weapons sites.



## HEALTH DIVISION

covers a broad range of health financing, service delivery, and coverage issues, including state options under federal health reform, quality initiatives, costcontainment policies, health information technology, state public health initiatives, and Medicaid.



### HOMELAND SECURITY & PUBLIC SAFETY DIVISION

supports governors' homeland security and criminal justice policy advisors. This work includes supporting the Governors Homeland Security Advisors Council (GHSAC). Issues include emergency preparedness, interoperability, cyber-crime and cyber-security, intelligence coordination, emergency management, sentencing and corrections, forensics, and justice information technology.

# **OUR IMPACT**

### **Raising the Bar for Education**

Recognizing the nation's competitiveness relies on an education system that can adequately prepare youth for college and the workforce, the NGA Center and the Council of Chief State School Officers produced the Common Core State Standards, which define the knowledge and skills students should gain in grades K-12 to graduate high school fully prepared for college and work. The NGA Center is now working with states as they implement the standards—raising the bar for education across the country. The NGA Center also continues to produce policy guides for governors on key aspects of education reform and hosts policy academies and cross-state meetings to help states advance science, technology, engineering, and math education, improve teacher quality, reduce high school dropout rates, and increase college completion.

#### Creating an Accessible and Cost-Effective Health Care System

Over the past decade, states have been taking steps to improve the delivery of health care services. However, health care costs have continued to rise to a point that risks our nation's economic competitiveness. Additionally, the federal health care reform law promises to expand coverage to many million more Americans, making it more important than ever for states to find and implement effective policies to bend the cost-curve. The NGA Center is helping states understand their options under federal health reform and providing resources that enable states to continue to be innovators in health care delivery. Through policy workshops, publications, and online forums, the NGA Center is at the forefront of helping states design policies that improve the quality and cost-effectiveness of health care services.
