Order 2010 Notice is hereby given that Portsmouth
City Council has made the Order referred to above in this notice in pursuance of a decision of the Council made on 23 March 2010 that:

- having had regard to government advice as required by the Local Government and Public Involvement in Health Act section 93(4) and 93(5), section 100(4), and having considered representations made as part of the review, including the views of parish councillors and the results of a non-binding poll of electors, and the city council being satisfied that there are satisfactory arrangements in place to engage local communities following the abolition of the Town Council, the City Council is of the view that there is clear and sustained local support for the Southsea Parish to be abolished and the Southsea Town Council be dissolved on 23 April 2010:
- (ii) that the City Council's decision be advertised and given effect in accordance with law and that the reasons to be given for abolition are that the City Council has considered the views expressed in response to the governance review including those of town councillors and the result of a nonbinding poll, and have concluded that the governance of the parished area is better served without the existence of Southsea Town Council, a view with which a majority of Town Councillors agree. The city council believes that there is clear and sustained local support for this action;
- (iii) that the City Council offers to hold any property or assets of any type, of the Town Council, remaining after its dissolution for the benefit of the Southsea Town Council area and will apply the provisions set out in the Local Government (Parish and Parish Council) (England) Regulations 2008 to the extent that they are applicable
