<u>CHAPTER 1 – STANDARD REQUIREMENTS</u>

1.1 EVENT TITLE, DATE & VENUE

1.1.1 The Event will be known as the "L&H 500" hereinafter referred to as "the Meeting" which will also comprise Race 19 of the 2011 V8 Supercars Championship, ("the VCS"), and will be held at the Phillip Island Grand Prix Circuit, Phillip Island, Victoria on the 16–18 September 2011.

1.2 ORGANISATION & STATUS

- 1.2.1 The Meeting will be held under the International Sporting Code of the Federation Internationale de l'Automobile (FIA), the V8 Supercars Operations Manual ("the Rules"), any applicable National Competition Rules of the Confederation of Australian Motor Sport Ltd (CAMS) which are not in conflict with the Rules, the Supplementary Regulations, any Further Supplementary Regulations or instructions and any Bulletins issued.
- 1.2.2 The Meeting will be a Major National Meeting.

1.5 ENTRIES

1.5.1 Competitors must have completed the *2011 V8 Supercars Series Registration Form* or a 2011 V8 Supercars Wild Card Registration Form.

1.5.2 No change of Drivers will be accepted later than 1700 (AEST) on Thursday 15 September 2011 unless exceptional circumstances, as determined by the Series Stewards, warrant a change after that time.

1.6 V8 SUPERCARS RACES

1.6.1 For this Meeting the start procedure will be as follows:

- 1.6.1.1 Qualifying Race 1 and Qualifying Race 2 will be in a Sprint format
- 1.6.1.2 Race 19 will be in an Endurance format
- 1.6.2 While the place getters of each Qualifying Race of this Meeting will be awarded Championship points according to Rule D15.4.3, the finishing positions of "The L&H 500", will be the finishing positions at the end of Race 19, regardless of the total number of points accumulated by any Driver pairing.

1.7 ACCESS TO CIRCUIT

- 1.7.1 Teams will be permitted to enter the Paddock from 1000 on Thursday 15 September 2011.
- 1.7.2 Teams will be permitted to unload from 1300 on Thursday 15 September 2011.
- 1.7.3 The set up of the V8 Supercars Paddock Area will be at the direction of the AOM.
- 1.7.4 No cars are permitted in the V8 Supercars Paddock Area from 0700 on Thursday 15 September 2011. All cars will only be permitted to park in the circuit car park.

1.8 ACCREDITATION CARDS (PASSES)

- 1.8.1 The Series Accreditation Cards will be recognised by the Organisers.
- 1.8.2 Each Entry will receive 4 x Team car passes.
- 1.8.3 Each Caterer will receive 1 x transit car pass.

1.9 TYRE FITTING

1.9.1 Control Tyre fitting will commence from 1000 on Thursday 15 September 2011 at the Dunlop facility located in the V8 Supercars Paddock Area.

CHAPTER 2 – SUPPLEMENTARY REQUIREMENTS

2.1 DOCUMENT VERIFICATION & SCRUTINEERING

2.1.1 Document Verification for all Competitors that need to change or add any details contained in their 2011 Series Registration Form will be conducted from 0830 to 1000 on Friday 16 September 2011 at the V8 Supercars Transporter.

2.2 BRIEFINGS

- 2.2.1 A briefing for **all Competitors Team Managers** will be held at **1730** on Thursday 16 September 2011 in the Administration Building located immediately behind the V8 Supercars Paddock.
- 2.2.2 A briefing for **all Competitors and Drivers** will be held at **1730** on Friday 16 September 2011 in the Administration Building located immediately behind the V8 Supercars Paddock.
- 2.2.3 A **Refuelling Safety Briefing** will be held at **1800** on Friday 16 September 2011 in the Administration Building located immediately behind the V8 Supercars Paddock. Attendance for the following Team personnel is compulsory for Wildcard Entries and optional for all other Entries:
 - 2.2.3.1 The refuelling hose operator
 - 2.2.3.2 The fire extinguisher operator
 - 2.2.3.3 The deadman handle operator
 - 2.2.3.4 The Team Manager

NOTE: The above personnel must attend at the time for, and for the duration of, their relevant briefing/s (Rule D4), unless excused by the Series Stewards in exceptional circumstances.

2.3 FINAL DRIVER PAIRINGS

- 2.3.1 All Teams must nominate their final Driver pairings for Race 19 in writing to the Operations Manager by no later than 1730 on Friday 16 September 2011.
- 2.3.2 All Teams must nominate their Qualifying Race 1 Driver and Qualifying Race 2 Driver nominations in writing to the Operations Manager by no later than 1730 on Friday 16 September 2011.
- 2.3.3 Final Driver nominations will not be published until the time detailed in 2.3.1.

2.4 PRACTICE

- 2.4.1 All Drivers are permitted to drive in Practice Part 1.
- 2.4.2 Only Co-Drivers are permitted to drive in Practice Part 2.
- 2.4.3 All Drivers are permitted to drive in Practice Part 3, 4 and 5.

2.5 QUALIFYING

- 2.5.1 Qualifying will be made up of two (2) twenty minute sessions. One (1) for the Driver nominated to drive in Qualifying Race 1 and the other for the Driver nominated to drive in Qualifying Race 2
- 2.5.2 The Car with the highest accumulated points from Qualifying Race 1 and Qualifying Race 2 will be awarded Pole Position for the L&H 500 (Race 19)
- 2.5.3 If in the event of two or more Cars score equal accumulated points from Qualifying Race 1 and Qualifying Race 2 the grid positions for Race 19 will be determined by allocating positions in order of the results of Qualifying Race 2.

2.6 RACE GRID POSITIONS

- 2.6.1 Subject to Rule D6 and Supplementary Regulation 2.5, the grid position for Qualifying Race 1 and Qualifying Race 2, will be determined from the Qualifying sessions as detailed in 2.5.1 above.
- 2.6.2 Race 19 on Sunday the grid will be determined by a combined points score from Qualifying Race 1 and Qualifying Race 2.
- 2.6.3 For the purposes of 2.6.2 above only, non-finishers will be allocated points in Qualifying Races 1 and 2. Non-finishers will not be allocated Championship points.

2.7 PIT STOPS

Qualifying Races 1 and 2

- 2.7.1 There will be one (1) Pit Stop for each Car which must be completed in either Qualifying Race 1 or Qualifying Race 2 during which a minimum or two (2) Tyres must be changed.
- 2.7.2 Rule D12.2.1.1 will apply for Qualifying Race 1 and 2.
- 2.7.3 The Pit Stop, as required in 2.7.1, must be not be commenced until the leading Car has completed **lap 5**.
- 2.7.4 Should the SC boards and flags be displayed before the Leader completes lap 5, no Car is permitted to commence the Pit Stop until the leading Car has completed five (5) laps after the SC boards and flags have been withdrawn, or as otherwise determined by the Stewards.
- 2.7.5 If there is a further SC intervention during the five (5) laps after the SC boards and flags have been withdrawn, but prior to the revised Pit Stop opening, the Race Director will decide if the Pit Stop opening will be amended and any changes to the previous advice will be notified to Competitors.
- 2.7.6 After the leader has completed the required number of laps, a Car, except for the lead Car, must cross the Control Line on the Race Track before it can enter the Pit Lane to commence a Pit Stop for Tyres.
- 2.7.7 Any decisions made by the RD in regard to the above will be final and are not subject to Protest.

2.8 ADDITIONAL SIGNALLING POINT

2.8.1 In addition to the flag signals shown at the Control Line, the following flag signals will be displayed from Flag Point 11 on Drivers Left: The Black Flag and the Black Flag with Orange Disc (Mechanical Flag).

2.9 TEAM RADIO FREQUENCIES

- 2.9.1 Any Competitor that has changed its radio frequencies from those nominated on its 2011 Series Registration Form must notify RaceComms by 1700 on Monday 12 September 2011.
- 2.9.2 Teams must also provide their telemetry radio modem network frequencies, and any associated addressing and channel hopping patterns to RaceComms by 1700 Monday 12 September 2011. It will not be permitted to change any Telemetry frequencies during the Meeting without permission.
- 2.9.3 Radio Aerials or masts are not permitted to be fixed to the Pit Lane side of the garage complex.

2.10 PENALTY FOR FALSE START

2.10.1 The penalty for a false start will be a 10 second time Penalty served at the completion of a Car's first Pit Stop or another penalty as otherwise determined by the Stewards.

2.11 TRANSPORTER DEPARTURE AFTER THE MEETING

2.11.1 Unless otherwise advised by the AOM, no Team Transporter will be permitted to leave the circuit precinct prior to 1900 hours on Sunday 18 September 2011.

2.12 DRIVER IDENTIFICATION

2.12.1 For this Meeting all Cars and Drivers must be fitted with their Driver Identification units as supplied by V8 Supercars.

2.13 DRIVER WEIGHING

- 2.13.1 Drivers that have not competed in a Race of the 2011 V8 Supercars Championship will be required for weighing by the CTM at 0930 on Friday 16 September 2011.
- 2.13.2 Drivers will be required to be fully attired for weighing in accordance with Rule D23 Apparel Requirements.
- 2.13.3 All weighing will take place at the V8 Supercars weigh scales located in the Pit Lane Garage 32.

2.14 USE OF REFUELLING TOWERS

- 2.14.1 In addition to those times detailed in Schedule D6, Refuelling Towers are permitted to be used during the Warm-up, after the Car is in Pit Lane immediately prior to the start of Race 19 and during Race 19. During these times all Team members in Pit Lane must comply with the requirements of D23.3.
- 2.14.2 Parallel parking in Pit Lane is mandatory during the Warm-up.

2.15 FUEL FLOW RESTRICTOR

2.15.1 The Fuel flow restrictor referred to in Schedule D6 Part 4 will be the Endurance Race Restrictor for this Event.
