# DOING ALL WE CAN TO PROTECT SERVICES AND J

BACK in December 2010, the government's Comprehensive Spending Review (CSR) reduced our government grants by 8.8% for 2011/12 and 2012/13, meaning we were one of the top ten worst hit council's in the

As part of the budget cuts, we had to save £1.9million last year and nearly another £1million in this financial year. But that is not the end of the doom and gloom as more government grant cuts are expected for 2013/14 and 2014/15, meaning times are only going to get tougher.

Unlike many other authorities across the country who have cut services and jobs, we have always stated these are our main priorities and we aim to protect them. The impact on our front line services has been minimal and apart from two compulsory redundancies as part of our Strategic Alliance with North East Derbyshire Council we have minimised the impact on employees.

One year into the funding cuts and we are on target with our savings strategy.

Cabinet Member for Corporate Resources, Councillor Duncan McGregor said, "These are tough and testing times for local councils – like it is for everybody else. The reductions in our grants and the economic problems mean we have to plan and budget more carefully as more people are relying on our services.

"We all have to make decisions that we sometimes do not like or totally agree with, but we have got to make them if we are to continue looking after our residents, our employees and the services we are responsible for. We cannot just hide and do nothing so it is vitally important that our plans are robust and can be adapted to meet these pressures whilst still delivering good quality services – and we believe we have these plans in place."

Our savings strategy is not just about making cuts and spending less. It is also about making the most out of our assets by renting out space,

increasing income streams and where appropriate selling some of our assets to lessen the pressure on what we have got to save over the next few years.

"We have embarked on a strategy of maintaining services to the public as our top priority, supported by managing our financial position through natural wastage, joint working, vigorous control of the cost of supplies and services and reducing management costs. While it would be foolish to say that this will prevent pain for local residents and employees we are working hard to minimise such pain," added Councillor McGregor.

# Council Tax Freeze for 2<sup>nd</sup> Year Running

AS PART of our commitment to saving you money, we froze our remaining 90 pence going to the County Council, the Police and proportion of the council tax bills for the second year running. The freeze is intended to help local families through these tough economic times and not add to their daily household bills.

Council Leader, Councillor Eion Watts said "Despite cuts to the government grants we receive, we are determined that front line services will not be affected as we do not feel it is fair that our residents should suffer or feel the pain through no fault of their own. The plans we have in place show we are planning for the future, that we are a responsible Council and that we can continue to deliver our services to meet the needs of our residents."

Bolsover District Council is the billing authority, but only receives around 10 pence of every pound of Council Tax collected, with the Fire authorities and Town and Parish Councils.

# HOW ARE WE MAKING THE SAVINGS?

SAVING £1.9million in a year is no mean feat, but last year we managed this with minimal affect on front line services and people's jobs. Below are just a few examples of how we achieved this:

#### **Strategic Alliance**

As part of our Strategic Alliance with North East Derbyshire District Council we have already achieved half, some £750,000, of our three-year savings target.

This has been achieved partly by appointing a joint senior management team (Chief Executive, Joint Directors and Joint Assistant Directors), better procurement of goods and joining up services.

### **Vacancy Management**

Whenever an employee leaves their post, whether it be for another job or they have simply transferred to another post in the Council, then we put a recruitment freeze on

their post.

It is then up to the individual department to make a strong business case to have this vacancy filled. By undertaking this method we anticipate to save approximately £250,000 during 2012/13.

#### **Service Reviews**

As part of our Strategic Alliance we are looking at how we can join services together to offer better value and more cost effective services to our residents. We are currently undertaking a service review between our Environmental Health teams and our Garage and Fleet services which will generate approximately £150,000 in savings during 2012/13.

#### **Pay Awards**

For the past three years local government workers have had a pay freeze and we have decided that any proposed national pay awards for employees will be removed. This will save in the region of £100,000 in 2012/13.

### **Review of budgets**

As part of our stringent budget revisions we have been looking at non-employee budgets with a view to reducing non-essential expenditure. This has resulted in just over £200,000 being saved on a recurring basis Cabinet Member for Corporate Resources, Councillor Duncan McGregor said, "Whilst we have done a great deal of good work, we need to do more. We are continually looking at what budgets are being spent and where we can streamline or do things better for less money."

### **Rent Increases**

COUNCIL tenants across the District have seen their rents rise by 9%, after we were told by the government that our rents need to be in line with other housing providers.

We are required to set our dwelling rents in accordance with the Government's national social rent policy in order that rents in the council housing sector are in line with those charged by housing associations.

This means that formula rents are subject to a Government prescribed increase of RPI plus 0.5% each year (i.e. the September 2011 RPI of 5.6% plus 0.5%). But because our rents have traditionally been one of the lowest in Derbyshire this means our increase had to be 9%.

Cabinet Member for Housing Councillor Management Keith Bowman said, "We do realise this increase is unwelcome but due central government funding arrangements we have to increase our rent if we are to maintain our housing stock at the standard which is rightly expected by our tenants. We're not going to get to a point where our housing estates are suffering just because we did not take our responsibilities seriously and ducked making these decisions."

The average rent increase for our 5,000 properties is £6.14 (over a 48 week period).

### n Court....

BELOW is a summary of the court action we have taken against individuals who have broken the law since January 2012. More detailed information on each case can be found on our website www.bolsover.gov.uk

### January 2012

Dennis Rye Ltd, who was prosecuted and fined £2,000 for two offences of illegally burning large piles of waste in Tibshelf saw both convictions upheld on appeal.

Back in November 2010 and January 2011, the property developer contravened the Environmental Protection Act 1990 for burning waste illegally and causing a statutory nuisance.

The appeal was held at Derby Crown Court and the judge upheld both convictions. Although the fine for the first offence was left unchanged at £1,000, the second was reduced to £500 as it was considered a lesser offence and would have caused less smoke nuisance. However, the judge awarded us an extra £2,750 in court costs relating to the appeal.

### February 2012

Mrs Kimberley Jayne Turner (27) of Arran Court, Tibshelf claimed over £2,200 in benefits she was not entitled to and was successfully prosecuted.

Mrs Turner was charged with failing to declare to our Benefits department that her partner had started work in January 2011. Mrs Turner, who had entered a not guilty plea to the charge at an earlier date, was found guilty and was convicted under Section 112(1A) of The Social Security Administration 1992 to claiming Housing and Council Tax Benefit of over £2,200 between January and June 2011 to which she was not entitled.

She was given a Community Order requiring her to undertake 60 hours unpaid work over the next 12 months and also ordered to pay costs of £250 to be repaid at £5 per week and repay the amounts of benefit she should not have received.

### March 2012

Tanya Jane Downes (22) from Langwith has been served with a two-year Anti Social Behaviour Order (ASBO) by North East Derbyshire and Dales Magistrates Court.

Tanya was issued with the Order due to her behaviour in and around Langwith and Whaley Thorns. She had consistently been seen drinking with a large group of younger teenagers and become loud, abusive and threatening.

She had also become prominent and been seen at the site of a number of deliberate fires in the area, laughing and shouting at fire fighters when they arrived and tried to put the fire out.

The Order expires on 26th March 2014.

### May 2012

Helen Read (35) of Rhodes Cottages, Clowne was found guilty of claiming over £5,000 in benefits she was not entitled to.

Mrs Read had earlier pleaded guilty to failing to declare she was working at a care home from May 2010 whilst claiming Income Support and Council Tax Benefit, in breach of Section 112 (1A) of The Social Security Administration Act 1992.

She received a Community Order requiring her to complete 140 hours unpaid work and was ordered to repay costs of £100 at £5 per week. She will also have to repay all the benefits she was not entitled to.

#### May 2012

Marion Slaney (53), formerly of College View, Clowne failed to declare she had £20,000 worth of capital whilst claiming benefits and was successfully prosecuted.

Mrs Slaney pleading guilty and was convicted under Section 112(1A) of the Social Security Administration Act 1992. She was fined £100 and in addition ordered to pay costs of £100 and a £15 victim surcharge. She was overpaid Income Support, Housing Benefit and Council Tax Benefit totalling £2,625 and repaid this amount prior to attending Court.

### **Retraction and Apology**

In the last edition of our Intouch newspaper we stated that Glapwell resident Mr Michael Bonson had been found guilty of failing to clean up after his dog had fouled on a grass verge near the highway.

Mr Bonson has subsequently appealed to the Crown Court and the offence of dog fouling was overturned on 3rd February 2012. However the conviction for failing to give his particulars to the dog warden was upheld.

The information we had at the time of going to print was correct, however, we would like to apologise to Mr Bonson for any distress this has caused him.








### **Torchbearers**

8,000 inspirational people will carry the Olympic Flame as it journeys across the UK.

These have been chosen by the London Organising Committee of the Olympic Games (LOCOG) and will carry the torch for approximately 300 metres each.

One of the torchbearers who will carry the flame through Bolsover is Kaylet Smedley from Brimington. Aged 79, the last thing she thought she would be doing at her age is running with the Olympic Torch in her hand through Bolsover and here is her story.

Kaylet was nominated to be a torchbearer over a year ago by Elizabeth Mulcahey, a teacher at New Bolsover Primary School, for the amazing work she does as chairperson of the Derbyshire branch of the Leukaemia and Lymphoma Research Fund since 1965. Kaylet started the branch following the death of her son Andrew from Leukaemia, who was just eight years old. Throughout the past 47 years Kaylet has been constantly involved in raising money and finding new ways to help fight this disease.

Despite her advancing years she remains a vigorous organiser and an inspiration to her team of volunteers. And we must all take time to think how many competitors and spectators at the 2012 Olympic Games are alive today because of her efforts?

The first Kaylet knew about being nominated was last December when Elizabeth rang her to say that she had been accepted subject to scrutiny of her documents – to say she was shocked was understatement.

"The closest I thought I would get to the Olympics was settling down on the settee with my husband to watch it – I really didn't expect to be a part of it," said Kaylet. "It is a bit surreal to be honest,

and at first it seemed like a dream. But it is a huge honour and a great privilege to have been chosen and I am really looking forward to it now. I have got my family and friends and all the school children from New Bolsover coming to cheer me on and it will be a really special day."

# How can we benefit you?

ARE YOU getting all the benefits you are entitled to? Whether you have lost your job, had your income reduced or simply struggling to meet those never ending bills, the time has never been better to look at what you can claim you may be surprised!!

One of the first things you should check is to see if you can claim housing or council tax benefits. There are a number of ways in which you may be eligible to claim benefit including a 25% discount on your Council Tax if you live alone or a reduction in your rent.

Here are some of the benefits you may be able to claim:

- Rent Rebate This is paid directly onto the rent account of eligible tenants living in our properties.
- Rent Allowance This is paid to eligible residents living in privately rented accommodation, including lodgers, boarders, sub-tenants and residents of mobile homes.
- Council Tax Benefit This is paid to eligible residents who are liable to pay see if you can claim any benefits that you maybe entitled to.

- Council Tax on their property. It is paid by reducing the annual Council Tax bill by any amount of Council Tax Benefit due.
- Second Adult Rebate (SAR) This is a type of Council Tax Benefit (sometimes referred to as 'Alternative maximum Council Tax') for residents who have a second adult (or adults in some cases) in the property on a low income. The benefit is based on the Second Adult(s) income and the general idea is that it substitutes any discount the liable person has lost due to the second adult being in the property.
- Local Housing Allowance (LHA) LHA is a simplified Housing Benefit system for people on benefits or low incomes who rent from private landlords. LHA is based on the number of bedrooms people are allowed under the scheme, not how much their rent is. The number of bedrooms allowed depends on who lives with the tenant.

HAVE money worries led you to borrow money without any paperwork? If you have, it's almost certain that whoever lent it to you is a crook, charging a rate of interest that is nothing short of extortion.

That's why we have teamed up with 2Shires Credit Union to offer local residents a better and more cost effective solution.

2Shires Credit Union are a community savings and loan cooperative, where members pool their savings to lend to one another and help to run the union. Established in June 2000 as Worksop & District Credit Union, their main aim is to help people to save what they can and borrow only what they can afford to repay. They offer two types of loans:

SAVER loans are available to those who have been saving regularly with them for a minimum of eight weeks. The interest rate is only 12.7% APR, but if it is a first loan the amount that can be borrowed is limited to 1½ times the level of savings.

SMART loans are available to non-savers at an interest rate of 26.8% APR.

2 Shires Credit Union will only lend to those who can afford to make repayments, so all SMART loan applicants need to produce proof of income and expenditure.

There are no hidden charges for early repayment with either loan.

# **Public Notice – Standards Committee Hearing for** Councillor D. Kerr (Ward Member for Whitwell)

ON 22ND JULY 2011 a formal complaint was made alleging that Councillor Duncan Kerr had brought Bolsover District Council into disrepute by making the statements he had made.

At its hearing on 1st May 2012, the Standards Committee found that Councillor Kerr did not produce any evidence to substantiate the statement giving the impression that it is the that the Leader perpetuated a climate of fear or indeed that a climate of fear existed. There was therefore no foundation to the claim in the statement.

The Panel noted that no attempt was made to correct the impression given at the Council meeting or immediately thereafter by Cllr Kerr.

Cllr Kerr also gave the impression

that the Council has a very poor relationship with its employees. However, the Panel decided this was not the case and were aware that there are other mechanisms available for employees to give opinions.

In other statements Cllr Kerr made a clear linkage to Doncaster, which has had proven cases of corruption, clearly corruption meaning of rotten that was intended in his statements. The use of the word scandalous only goes further to give this impression.

Cllr Kerr was found to have breached

The Standards Committee decided that the Council should censure Cllr Kerr in respect of his failure to comply with the code of conduct.

Paragraph 5 of the District Council code states: "You must not conduct yourself in a manner which could reasonably be regarded as bringing your office or authority into disrepute."

A second allegation was that Cllr Kerr had failed to treat Cllr Eion Watts the Council's Leader, with respect by making certain statements. The Chair of the Standards Committee stated that comments made by Cllr Kerr failed to treat Cllr Watts with respect and were inappropriate, but were not disrespectful. Cllr Kerr was found not to have breached the code in this

Councillor Kerr is a member of Bolsover District Council. Cllr Kerr has the right to appeal the decision to the President of the First Tier Tribunal.
