

ARTICLE 24

TEXT OF ARTICLE 24

1. In order to ensure prompt and effective action by the United Nations, its Members confer on the Security Council primary responsibility for the maintenance of international peace and security, and agree that in carrying out its duties under this responsibility the Security Council acts on their behalf.

2. In discharging these duties the Security Council shall act in accordance with the Purposes and Principles of the United Nations. The specific powers granted to the Security Council for the discharge of these duties are laid down in Chapters VI, VII, VIII and XII.

3. The Security Council shall submit annual and, when necessary, special reports to the General Assembly for its consideration.

INTRODUCTORY NOTE

1. Under Article 24, the Members of the United Nations confer on the Security Council primary responsibility for the maintenance of international peace and security. The primary responsibility of the Security Council is also reflected in Article 11(2), which provides that questions on which action is necessary shall be referred to the Security Council by the General Assembly, and in Article 12(1), which, together with Articles 10, 11(2) and 14, limits the authority of the General Assembly in respect of any dispute or situation while the Security Council is exercising the functions assigned to it by the Charter.

2. As indicated in the *Repertory* and its *Supplements Nos. 1 to 5*, examination of the practice of United Nations organs in respect of a Charter provision as broad as Article 24 has to be confined in scope. This study has therefore focused on the practice of the Security Council. The practice of the General Assembly in connection with the maintenance of international peace and security has been primarily dealt with under the Articles on the functions and powers of the General Assembly.¹

3. The present study consists of a general survey, an analytical summary of practice and two annexes. Explicit and implicit references to Article 24 in decisions and deliberations of the Security Council and the General Assembly which did not give rise to any constitutional discussion are dealt with in the general survey. The constitutional discussions pertaining to the general responsibility of the Security Council for the maintenance of international peace and security, as distinct from its specific powers under Chapters VI, VII, VIII and XII, are included in the analytical summary of practice under the heading "Question of the scope of the primary responsibility of the Security Council under Article 24".² For reasons explained in the *Repertory* and its *Supplements Nos. 1 to 5*, there are two annexes. Annex I contains a chronological list of questions considered by the Security Council under its responsibility for the maintenance of international peace and security. Annex II consists of a tabulation of various measures provided for in resolutions and other decisions adopted by the Security Council in connection with questions considered under that responsibility. As indicated in previous *Repertory* studies, the headings in the tabulation have been devised for convenience of presentation and no constitutional significance should be attached to the inclusion of any particular decision under any given heading.

I. GENERAL SURVEY

A. Article 24 (1) and (2)

4. During the period under review, explicit references were made to Article 24 in two resolutions³ of the Security Council in connection with the situation between Iran and Iraq. Article 24 was implicitly referred to in two resolutions adopted by the Council in connection with the situation in Afghanistan⁴ and the situation in the occupied Arab territories,⁵ respectively. In both cases, the Security Council decided to call an emergency special session of the General Assembly⁶ to examine the question under review because the "lack of unanimity of its permanent members" had prevented it from "exercising its primary responsibility for the maintenance of international peace and security". Implicit references to Article 24 were also made in Security Council resolutions in connection with the question of South Africa,⁷ a complaint by Angola against South Africa,⁸ the situation in the occupied Arab territories,⁹ and the question of Namibia,¹⁰ in a statement by the President,¹¹ in two notes issued by the President,¹² as well as in draft resolutions on the situation in Kampuchea¹³ and in connection with the letter dated 22 December 1979 from the representative of the United States of America addressed to the President of the Security Council,¹⁴ which either failed of adoption or were not pressed to the vote.

5. Following the adoption of resolution 514 (1982), the representative of the Islamic Republic of Iran submitted a letter¹⁵ to the Secretary-General in the annex of which an explicit reference to Article 24(2) is contained. In connection with the situation in the region of the Falkland Islands (Islas Malvinas), explicit references were made to Article 24 in letters addressed to the President of the Security Council by the representatives of Argentina and the United Kingdom of Great Britain and Northern Ireland, respec-

tively.¹⁶ Article 24 was also explicitly invoked in two other communications to the Security Council.¹⁷

6. In the deliberations of the Security Council in connection with the situation between Iran and Iraq, one representative cited¹⁸ Article 24(1) in full, emphasizing that the Security Council could not abdicate its responsibilities under the Charter and that the discharge of its duties was compatible with the mission undertaken by the Organization of the Islamic Conference. Explicit and implicit references to Article 24 were also made during discussions of the Security Council in connection with the complaint by Angola against South Africa;¹⁹ the letter dated 22 December 1979 from the representative of the United States addressed to the President of the Security Council;²⁰ the situation in Afghanistan;²¹ the situation in the occupied Arab territories;²² the situation between Iran and Iraq;²³ the situation in the region of the Falkland Islands (Islas Malvinas);²⁴ the situation in the Middle East;²⁵ the complaint by Lesotho against South Africa;²⁶ the situation between Libya

and the United States;²⁷ the situation in Namibia;²⁸ the situation between Libya and Sudan;²⁹ and attacks by Iran on commercial ships en route to and from the ports of Kuwait and Saudi Arabia.³⁰

7. There was no explicit reference to Article 24 in the resolutions of the General Assembly. Numerous resolutions contain provisions which might be seen as implicit references to Article 24, but their adoption did not give rise to a constitutional discussion.³¹

8. In the deliberations of the General Assembly, Article 24 was referred to explicitly and implicitly in connection with various items.³² During the emergency special sessions held during the period under review, several representatives commented³³ on the respective powers of the Security Council and the General Assembly with respect to the maintenance of international peace and security.

9. At its sessions held from 1979 to 1984, in accordance with the mandate given to it by the General Assembly,³⁴ the Special Committee on the Charter of the United Nations and on the Strengthening of the Role of the Organization examined various proposals on the question of the maintenance of international peace and security, but no constitutional discussion arose with respect to Article 24.

B. Article 24 (3)

10. Article 24(3), in conjunction with Article 15(1), places upon the Security Council the obligation to submit annual and, when necessary, special reports to the General Assembly. During the period under review, the Security Council submitted its thirty-fourth through thirty-ninth annual reports, as well as special reports³⁵ with respect to the admission to the United Nations of new Member States.

11. The accepted procedure with regard to the preparation of annual reports continued to include the following stages: (a) formulation of the first draft by the Secretariat;³⁶ (b) circulation of that draft as a confidential document among the members of the Security Council; (c) discussion of proposals for changes and submission of observations at a closed meeting of the Council; and (d) full approval at a closed meeting of the Security Council, following which the annual report of the Security Council was published as a document of the General Assembly and submitted to the General Assembly for its consideration.

12. As in previous years, the General Assembly did not debate the substance of the annual reports submitted by the Security Council but adopted resolutions taking note³⁷ of them.

II. ANALYTICAL SUMMARY OF PRACTICE

- **A. Question whether the authority of the Security Council is limited to the exercise of the specific powers laid down in Chapters VI, VII, VIII and XII**
- **B. Question of the bearing on the primary responsibility of the Security Council of proposals to refer a matter to the General Assembly**
- C. Question of the scope of the primary responsibility of the Security Council under Article 24**

1. DECISION OF 11 JANUARY 1979 IN CONNECTION WITH THE TELEGRAM DATED 3 JANUARY 1979 FROM THE DEPUTY PRIME MINISTER IN CHARGE OF FOREIGN AFFAIRS OF DEMOCRATIC KAMPUCHEA TO THE PRESIDENT OF THE SECURITY COUNCIL

13. In the deliberations of the Security Council on the adoption of the provisional agenda for its 2108th meeting, on 11 January 1979, a discussion arose concerning the inclusion in the agenda of the item entitled "Telegram dated 3 January 1979 from the Deputy Prime Minister in charge of Foreign Affairs of Democratic Kampuchea to the President

of the Security Council (S/13003)".³⁸ One representative asserted³⁹ that "the events which have occurred in Kampuchea are the internal affair of the people of that country and should not be subject for consideration in the Security Council". The Security Council was viewed as being "in a strange situation which [was] in contradiction with its important and responsible role within the United Nations system". The decision to consider a communication from a regime which had been overthrown was seen as an attempt "to prod the Council towards intervention in the internal affairs of Kampuchea".⁴⁰ Another representative further stressed⁴¹ that the decisions adopted at the 2108th meeting of the Council "were not in the spirit of nor in conformity with Article 24". The Council had "no competence to deal with a question which [was] an internal problem of a State and, thus, [did] not pertain to the maintenance of international peace and security as provided for in the Charter". His Government could not therefore accept "that in the present case the Council was acting on its behalf".

14. On the other hand, one representative held⁴² that, "[i]n accordance with the Charter of the United Nations and the provisional rules of procedure of the Security Council, any Member State [had] the right to ask for a Council meeting to consider major issues threatening international peace and security. And the current question of Kampuchea's being subjected to massive aggression from outside [was] precisely a question of this nature". Another representative also invoked⁴³ "the right of every Member State to seek action from the Council whenever it feels that it is in need of such action", adding that "[i]t would have been an abdication of responsibility on the part of the Council had it not met to consider the situation in Cambodia". The view was also expressed⁴⁴ that "the Council, if it is to discharge its responsibilities under the Charter, must display its readiness to hear complaints such as that made in document S/13003. If the Council does not do so, it cannot make a determination on the merits of each case and it cannot fulfil its responsibilities".

2. DECISION OF 3 APRIL 1982 IN CONNECTION WITH THE SITUATION IN THE REGION OF THE FALKLAND ISLANDS (ISLAS MALVINAS)

15. In resolution 502 (1982) of 3 April 1982, the Security Council demanded a "cessation of hostilities" and a "withdrawal of all Argentine forces from the Falkland Islands (Islas Malvinas)".

16. In a letter⁴⁵ dated 1 May 1982, the representative of Argentina contended that, in launching attacks against the Falkland Islands (Islas Malvinas), the United Kingdom sought "to arrogate to itself powers, which, under Article 24 of the Charter, were granted by the States Members of the United Nations to the Security Council for the discharge of its primary responsibility for the maintenance of international peace and security, thus thwarting effective implementation of a Council resolution sponsored by the United Kingdom itself". The representative of the United Kingdom, in a letter⁴⁶ dated 4 May 1982, maintained that, while it was true that the Member States had conferred upon the Security Council the primary responsibility for the maintenance of peace and security, Article 24 must be read together with Article 51. It was a "misreading of the Charter to assert ... that the United Kingdom is not entitled to exercise its right of self-defence by reason of the terms of Article 24 when Argentina persists in its refusal to carry out the demands of resolution 502 (1982)".

17. In the subsequent deliberations of the Security Council, the representative of Argentina reiterated the position of his Government.⁴⁷ One representative asserted⁴⁸ that "[t]he Council [had] the obligation and the exclusive competence to adopt necessary measures for the fulfilment, in all its aspects, of resolution 502 (1982), which the Council itself [had] adopted, and it [could] not accept unilateral actions against specific provisions of that resolution, even if, without its authorization, allegedly aimed at the fulfilment of the Council's decision." Other representatives held similar positions.⁴⁹ The representative of the United Kingdom, on the other hand, noting that resolution 502 (1982) had "proved insufficient to bring about withdrawal" of the Argentine armed forces, insisted⁵⁰ that his country was "fully entitled to take measures in exercise of its inherent right of self-defence". That view was shared by other representatives.⁵¹

3. DECISION OF 17 AUGUST 1984 IN CONNECTION WITH
THE QUESTION OF SOUTH AFRICA

18. In the deliberations of the Security Council in connection with the adoption of resolution 554 (1984) of 17 August 1984, the representative of South Africa asserted⁵² that constitutional arrangements within his country were an internal affair, "beyond the ambit of this or any other organ of the United Nations". The Organization's founders had intended that the Council should deal with issues of international peace and security, and the discussion of South Africa's Constitution had "nothing to do with international peace or security". It was further maintained⁵³ that "only the people of South Africa [could] determine their future" and that it was "not for outsiders to prescribe solutions, nor to determine the validity or otherwise of internal arrangements". The position was also held⁵⁴ that the Security Council was "not the appropriate forum in which this matter should be considered". The fact that racial discrimination was enshrined in the Constitution of South Africa did not withdraw the matter from United Nations scrutiny, as the Members of the United Nations had pledged themselves through the Charter to promote human rights and fundamental freedoms. However, under Article 24, no issue was posed which was appropriately within the purview of the Council. On the other hand, it was asserted⁵⁵ that the Coun-

cil was called upon to discharge its responsibilities in the matter brought before it because "South African persistence in maintaining its racist system, and even in trying to refine it through the so-called constitutional proposals," were a "cause of the tensions in southern Africa, with their consequent negative effects on international peace and security". It was further contended⁵⁶ that it was incumbent on the Council to declare the so-called constitution and the so-called elections null and void as they represented "a flagrant violation of the Charter".

19. In its resolution 554 (1984), the Security Council, *inter alia*, declared "that the so-called 'new constitution' is contrary to the principles of the Charter of the United Nations, that the results of the referendum of 2 November 1983 are of no validity whatsoever and that the enforcement of the 'new constitution' will further aggravate the already explosive situation prevailing inside apartheid South Africa"; rejected and declared as null and void "the so-called 'new constitution' and the 'elections' to be organized ... for the 'coloured' people and people of Asian origin as well as all insidious manoeuvres by the racist minority regime of South Africa further to entrench white minority rule and apartheid"; and declared "that only the total eradication of apartheid and the establishment of a non-racial democratic society based on majority rule, through the full and free exercise of universal adult suffrage by all the people in a united and unfragmented South Africa, can lead to a just and lasting solution of the explosive situation in South Africa".⁵⁷
