Trade has been and will continue to be vital to both the economies of the Kingdom of Denmark, and the Republic of Turkey. Since the times of the Vikings, who were the first Danes to reach Constantinople (Istanbul), Danes have been travelling around the world and trade has been an important part of their activities. Turks also have proud trading traditions since ancient times. The end of the Silk Road in Bursa is clear evidence hereof.

Trade between our two countries can be dated centuries back. In 1756 Denmark and The Ottoman Empire signed a treaty on commerce and friendship, which paved the way for closer ties – both human and commercial – between our two people. And trade and friendship has been flourishing since then. Numerous Danes have over the years been warmly welcomed in Turkey. One of the more illustrious visitors was Hans Christian Andersen who in 1840-41 during one of his travels through Europe also reached Istanbul. In "A Poet's Bazaar" he describes the bustling activity in the city, all the merchandise being sold in the streets and the warm hospitality with which the inhabitants of Istanbul received him.

It is therefore with great enthusiasm that the Danish business delegation has been looking forward to this visit to Turkey. The purpose is to establish new and strengthen already existing trade relations between our two countries. It is, however, also our objective to meet the Turkish people, learn about their life and experience the vibrant business environment of Turkey as well as to get a firsthand impression of the important results of the on-going reform process.

The Danish business delegation will focus mainly on the fields of energy, environment, health, and the medical industry. We will present Danish achievements in these sectors and through dialogue with Turkish authorities and business people – try to identify new areas of cooperation that will benefit both our nations. We are very grateful for the kind assistance of the Turkish authorities in arranging this visit.

I am confident that my visit together with this important business delegation will further strengthen the ties between the Kingdom of Denmark and the Republic of Turkey.

Danimarka Prensi Majesteleri Joachim'in Önsözü

Ticaret hem Danimarka Kraliyetinin hem de Türkiye Cumhuriyetinin ekonomileri açısından her zaman hayati olmuştur ve böyle olmaya da devam edecektir. Constantinople'a (İstanbul'a) ilk ulaşan Danimarkalılar olan Viking'ler zamanından bu yana Danimarkalılar dünyanın dört bir tarafını dolaşmış ve faaliyetlerinin önemli bir bölümünü de ticaret oluşturmuştur. Türklerin de ilk çağlardan beri devam etmekte olan gurur duydukları bir ticaret gelenekleri vardır. İpek Yolu'nun Bursa'daki son bulması bu hususun kesin bir kanıtıdır.

Ülkelerimiz arasındaki ticaret yüzyıllarca geriye dayanmaktadır. 1756'da Danimarka ve Osmanlı İmparatorluğu arasında bir ticaret ve dostluk anlaşması imzalanmış ve böylece halklarımız arasında hem insani hem de ticari açıdan daha yakın bağların oluşmasına yol açılmıştır. O zamandan beri de dostluk ve ticaret gelişmektedir. Yıllar boyunca çok sayıda Danimarkalı Türkiye'de çok sıcak karşılanmıştır. Bu ziyaretçilerin önemli bir örneği, Avrupa'da yaptığı seyahatlerden birinde, 1840-41 yıllarında İstanbul'a gelen Hans Christian Andersen'dir. "Bir Şairin Çarşısı" adlı eserinde şehirdeki telaşlı faaliyet ve koşuşmayı, sokaklarda satılanları ve İstanbul halkının gösterdiği sıcak misafirperverliği anlatmaktadır.

Bu nedenlerle Danimarka iş heyeti Türkiye'ye yapılacak bu ziyareti büyük bir hevesle beklemekteydi. Amacımız ülkelerimiz arasındaki yeni ticari ilişkiler kurmak ve halen mevcut olanları daha da güçlendirmektir. Ancak, Türklerle tanışmak, onların hayat tarzı, Türkiye'deki canlı iş ortamı ve devam eden reform süreci hakkında ilk elden bilgi edinmek de amaçlarımız arasındadır.

Danimarka iş heyeti özellikle enerji, çevre, sağlık, ve tıbbi sanayi alanlarına odaklanacaktır. Bu sektörlerde Danimarka'nın başarı ile yaptıklarını sunacağız ve Türk makamları ve iş adamları ile kurulacak diyalog yolu ile de hem Türk hem de Danimarka uluslarının yararlanabileceği yeni işbirliği alanları oluşturmaya çalışacağız. Bu ziyaretin hazırlanmasında Türk makamlarının nazik yardımlarına müteşekkiriz.

Son yıllarda Danimarka ile Türkiye arasındaki ticari ilişkiler büyük ölçüde gelişmiştir. 2002 yılında Danimarka'nın Türkiye'ye olan ihracatı 291 milyon ABD Dolarına ve Türkiye'den ithalatı da 325 milyon ABD Dolarına çıkmıştır. 2003 yılında ise bunun daha da arttığına tanık olduk. Ancak ikili ticari ilişkilerde mevcut olan muazzam potansiyelin harekete geçirilmesi halinde bu miktarların daha çok artması mümkündür.

Ülkelerimiz arasındaki ticari ilişkileri daha da yakınlaştırmak üzere Danimarka son 5 yıl boyunca Türkiye'de bir dizi ticari faaliyetler düzenlemiştir. Bunlardan belli başlı iki tanesi 1999 ve 2001 yıllarında yer alan resmi ticaret heyetlerinin ziyaretleridir. Her iki faaliyet de işbirliğini arttırma konusunda ciddiyetlerini sergileyen Danimarka ve Türk şirketlerinin ilgi odağı olmuştur.

Bu üçüncü ticaret heyetinin ziyaretine katılım düzeyi Danimarkalı şirketlerin hem kısa hem de uzun vadede Türkiye pazarında gördükleri büyük imkanların bir göstergesidir. Bu promosyonda yer alan Danimarka şirketleri uzmanlık alanları ve 'know-how' açısından uluslar arası ün yapmış olup sanayi ekipmanlarından, yenilenebilir enerji, farmasötik maddeler, gıda işleme makineleri, nakliye ve lojistik ve tüketici mallarına kadar çok geniş bir yelpazede kendi alanlarında ürün ve hizmet sunma imkanına sahiptirler.

Türkiye'nin ilerideki AB üyeliği perspektif açısından da, devamlı artma eğilimindeki ekonomik etkileşim daha da güçlenecektir. Danimarka iş heyetinin başında Majesteleri Danimarka Prensi Joachim'in bulunması da Danimarka ile Türkiye Cumhuriyeti arasında her alanda mevcut iyi ilişkileri vurgulamaktadır.

Danimarka İş Heyetinin Ankara ve İstanbul'u ziyaretlerinin ülkelerimiz arasında pek çok yeni ve her iki taraf içinde yararlı iş ilişkilerinin kurulmasına ve böylece ortak amacımız olan ikili ticaret ve işbirliğinin genişletilmesine yol açacağına olan güvenim sonsuzdur.





Facts about Denmark

Geography and Government

Denmark is a constitutional monarchy in Northern Europe with 5.3 million inhabitants. Denmark consists of the peninsula of Jutland and af a great number of islands, of which Funen and Zealand - on which the capital of Copenhagen is situated - are the biggest ones. Denmark is bordering the Baltic Sea and the North Sea and the climate is temperate with mild winters and cool summers. The location gives Denmark a relatively large coastline of 7,300 km and a land boundary of 68 km to Germany.

Denmark has a total area of 42,400 sq. kms. The Kingdom also includes the Faeroe Islands and Greenland - the world's largest island - in the North Atlantic. Both the Faeroe Islands and Greenland have home rule with an elected council and are represented in the Danish parliament.

Primeminister Anders Fogh Rasmussen (Denmark's Liberal Party) leads a coalition government with The Conservative People's Party. The most recent election for the parliament (Folketinget) was held on 20 November 2001. Under the constitution, elections for the parliament must be held at least every fourth year.

Denmark and the surrounding world

Denmark is a small open economy, and our welfare depends on our ability to trade goods and services with the surrounding world. The highly specialised Danish enterprises simply require bigger markets than the Danish domestic market. And this goes the other way around as well. Imported commodities are seen everywhere in Danish stores. International companies are both well represented and well received in Denmark.

Denmark is well integrated in the global economy and plays an active role in the global political institutions. The Nordic countries are important co-operation partners. However, the membership of EU is the most important element in Danish foreign policy. Denmark joined the EEC on 1 January 1973 together with the UK and Ireland.

Denmark is a member of NATO and participated in UN's establishment in 1945. Denmark has taken part in over half of the UN peace-keeping operations and is one of the few countries in the world to donate 1% of GDP to the work of international development.
