CONSOLIDATED TABLE OF TREATIES

VOLUMES 1—125

This table lists, in chronological order according to the date of signature, the treaties and other international agreements referred to in the decisions reported in volumes 1-125 of the *Annual Digest* and *International Law Reports*. It has not been possible to draw a useful distinction between treaties judicially considered and treaties which are merely cited.

In the case of bilateral treaties, the names of the parties are given in alphabetical order. Names of countries follow contemporaneous usage except in the case of small spelling changes (e.g. Roumania/Romania) where modern usage is adopted throughout. Multilateral treaties are referred to by the name by which they are believed commonly to be known, e.g. Treaty of Versailles. References to texts of treaties have been supplied wherever possible, including usually at least one reference to a text in the English language.

The full titles of the abbreviated references will be found in the list of abbreviations and sources at p. ix. For an index to the treaties by subject, see p. 315.
