The Kerrier (Parishes) Order 1985

Made5th February 1985

Coming into Operation -

for the purposes described

in article 2(1)10th February 1985

for all other purposes1st April 1985

Whereas the Kerrier District Council, acting pursuant to section 48(8) of the Local Government Act 1972 (a), has made recommendations to the Local Government Boundary Commission for England for proposals about parishes in the district: And whereas in consequence of those recommendations the Commission has seen fit, pursuant to sections 47, 48(9) and 51(1) of that Act, to make proposals to the Secretary of State:

And whereas more than six weeks has elapsed since the proposals were made:

And whereas the Secretary of State has decided to give effect to those proposals with a modification:

Now, therefore, the Secretary of State, in exercise of his powers under sections 51(2) and 67(4) and (5) of that Act and of all other powers enabling him in that behalf, hereby makes the following order:-

Title and commencement

1. - This order may be cited as the Kerrier (Parishes) Order 1985.
2. - (1) 10th February 1985 is hereby specified as the day on which this order shall come into operation for any purpose set out in regulation 4(1) (coming into

operation of order) of the Regulations.

(2) For all other purposes, this order shall come into operation on 1st April 1985.

Interpretation

3. - In this order -

"the boundary maps" means the 16 maps (duly numbered for reference) which are issued by the Department of the Environment as "Maps of the Kerrier (Parishes) Order 1985";

"county electoral division" means an electoral division of the county of Cornwall;

"the district council" means the Kerrier District Council;

"district ward" means a ward of the district of Kerrier;

"the former urban district" means the former urban district of Camborne - Redruth;

"new parish" means a parish created by article 4,5 or 6 of this order;

"new parish council" means a parish council established by article 8 of this order; and

"the Regulations" means the Local Government Area Changes Regulations 1976 (a).

Creation of new parishes from unparished area

4. - (1) There shall be created from the unparished area of the former urban district eight new parishes, to be named as indicated below, and consisting of the correspondingly-named areas shown outlined in red on the relevant boundary maps mentioned in relation thereto.

(2) In consequence of paragraph (1), -

(a) the area marked DW1 on boundary map 13 shall be transferred from the district ward of St Day and Lanner to that of Redruth South;

(b) the area marked DW2 on boundary map 13 shall be transferred from the district ward of Redruth South to that of St Day and Lanner;

(c) the boundaries of the St Day and Lanner county electoral division shall be altered so as to coincide with those of the identically-named district ward as revised by (a) and (b) above;

(d) the boundaries of the Illogan North and Illogan South county electoral divisions shall be altered so as to coincide with those of the identically-named district wards;

(e) the boundaries of the county electoral divisions mentioned below shall be altered so as to coincide with those of the relevant district ward mentioned -

(3) The eight parishes created by paragraph (1) shall form part of the East Penwith petty sessional division, and of the Western Cornwall coroner's district.

New parish of Gweek

5. - (1) There shall be created a new parish of Gweek, consisting of the area hatched red on boundary map 1, which comprises -

- (a) that part of the parish of Wendron marked D3;
- (b) that part of the parish of Mawgan-in-Meneage marked D4; and
- (c) that part of the parish of Constantine marked D5.

The new parish shall form part of the Helston and Kerrier petty sessional division, and of the Western Cornwall coroner's district.

(2) There shall be created a new district ward of Constantine and Gweek consisting of the area of the parishes of Constantine and Gweek as altered or created by this order. It shall be represented by one district councillor. The Constantine district ward shall cease to exist.

(3) The boundary between the county electoral divisions of Budock and Wendron shall be altered so that the whole of the new parish of Gweek falls within the Budock division.

New parish of Porthleven

6. - (1) There shall be created a new parish of Porthleven, consisting of the area hatched red on boundary map 9, which comprises -

- (a) that part of the parish of Helston marked D2; and
- (b) that part of the parish of Sithney marked D1.

The new parish shall form part of the Helston (Porthleven and Sithney) county electoral division, of the Helston and Kerrier petty sessional division, and of the Western Cornwall coroner's district.

(2) The area mentioned in paragraph (1)(b) shall be transferred to the Porthleven district ward, so that the area of that ward coincides with the area of the new parish.

Other transfers between parishes

7. Areas shall be transferred between parishes in accordance with the Schedule to this order. Each part of a parish named in column (1) marked as indicated in column (2) on the boundary map referred to in column (3) shall be transferred to the parish shown in column (4). Where there is mentioned in relation to any area -

- (a) a parish ward in column (5);
- (b) a district ward in column (6);
- (c) a county electoral division in column (7) -
that area shall also be transferred to that ward or division.

New parish councils

8. - (1) There shall be a parish council for the new parishes mentioned below. Where parish wards are named, the relevant new parish shall be divided into the wards so named, the areas of which are shown by broken red lines on the boundary maps mentioned in article 4(1). The number of parish councillors for each new parish or new parish ward shall be the relevant number indicated below.

(2) Any person who is -

(a) in office immediately prior to 1st April 1985 as a parish or town councillor for an area mentioned below; and

(b) resident in the relevant new parish mentioned in relation to that area;

shall cease to represent that area, but shall be a councillor of that new parish until the fourth day after the ordinary day of election of councillors in 1987.

(3) Elections of parish councillors (other than of those mentioned in paragraph (2)) for the new councils shall be held on such day before 1st April 1985 as the returning officer shall appoint. The persons elected shall come into office on 1st April 1985, and shall retire on the fourth day after the ordinary day of election of councillors in 1987.

(4) The annual meeting of each new parish council for 1985 shall be held in April 1985 and shall be convened by the proper officer of the district council.

(5) The first assembly of the parish meeting for any new parish shall be convened by the proper officer of the district council. At any such first assembly held before the annual meeting of the parish council, the parish meeting may appoint a person to take the chair, and that person shall have, for the purposes of that meeting, the powers and authority of the chairman.

Town council of Helston

9. - (1) The Porthleven ward of the town of Helston shall be abolished, and the remaining town wards of Helston North and Helston South shall each be represented by 6 town councillors. Additional councillors for those two wards shall be elected on such day prior to 1st April 1985 as the returning officer shall appoint, shall come into office on 1st April 1985, and shall retire on the fourth day after the ordinary day of election of councillors in 1987.

St Gluvias parish council

10. For the purposes of the 1987 parish elections, and as from the fourth day after the ordinary day of election of councillors in that year, the number of parish councillors for St Gluvias shall be increased from 8 to 10.

Expenses of new parish councils

11. In the year beginning on 1st April 1985, the district council shall levy rates in each new parish named below, and make payments to the new parish council, as if the new parish council had issued a precept to the district council requiring the payment of a sum equal to the product of a rate of the amount in the pound, calculated on the total rateable value of the parish as set out in the valuation list at the beginning of that financial year, specified below in respect of the parish.

12. For the purposes of regulation 40(1)(b) of the Regulations, any reference to the area of the former urban district shall be construed as a reference to the parishes of Camborne, Carharrack, Carn Brea, Illogan, Lanner, Portreath, Redruth, and St Day.

EXPLANATORY NOTE

(This note is not part of the order.)

This order concerns parishes in the district of Kerrier.

It -

(a) creates eight new parishes from the area of the former urban district of Camborne - Redruth, to be called -

Camborne	Lanner
Carharrack	Portreath
Carn Brea	Redruth
Illogan	St Day;

(b) creates two new parishes of Gweek and Porthleven from parts of other parishes;

(c) transfers areas between existing parishes.

The map forming part of this note (page 12) gives a general guide to the areas affected as from 1st April 1985.

Prints of the detailed boundary maps, which form part of the order and are referred to in article 3, may be inspected at the offices of the district council, and may be purchased from the Department of the Environment's Map Library, 2 Marsham Street, London SW1.

The approximate area, population and rateable value of the new parishes will be:-

Areas of new parishes named in bold italics

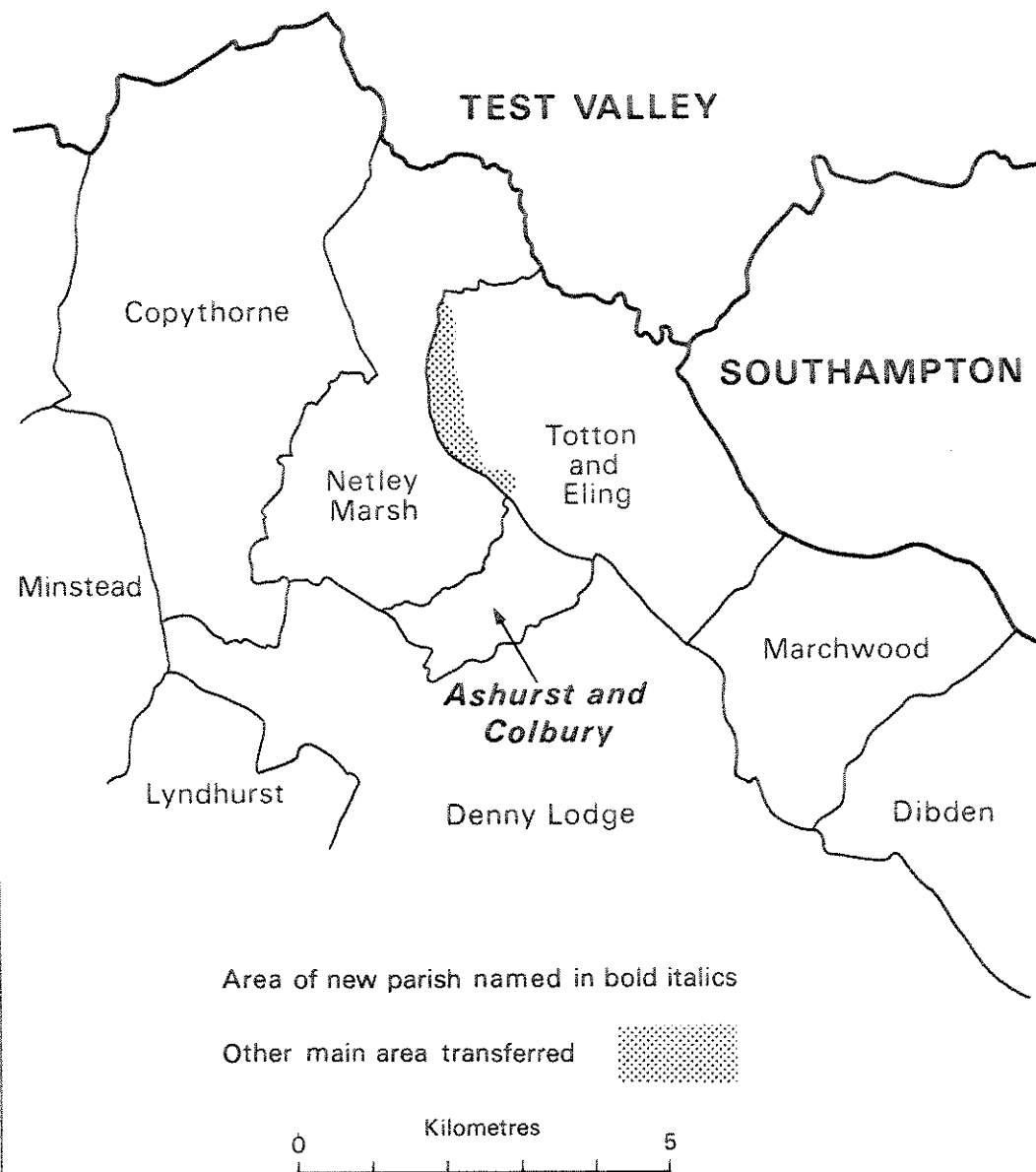
