Complying with contractual prerequisites is made easy

Contract Communicator is unique in that it supports specific contract types (currently FIDIC and NEC). The concepts of these contracts are programmed into Contract Communicator so it knows what needs to be done, by whom and when. You are guided and reminded throughout various complex contractual processes.

Detect trends or problem areas

Powerful reporting facilities help you recognize particular problems as well as efficiencies on your projects. Instead of the project team preparing reports, you can view on-demand reports at any time, giving you up to the minute insight.

Features

Claims Manager

When invoked, the claims manager guides and advises authorized users through the entire claims process. The claims manager monitors timebars and reminds users in advance when action is required. Stakeholders are kept in the loop with regards to risk events and their associated claims' statuses via e-mail and/or SMS.

Key features

- Guides stakeholders through FIDIC and NEC claims processes from beginning to end, no previous knowledge of these contracts is required
- · Monitors and reminds of timebars
- Records all relevant details of individual claims processes
- All claims must be substantiated with items from the risk register
- Records details of sought and granted extensions and automatically adjusts sections (FIDIC) or key dates (NEC)
- Captures supporting documentation.

Site Diary

The site diary captures information from one or several site locations and disseminates information effectively to the necessary stakeholders. The site diary is greatly enhanced by innovative risk triggers which monitor data input and recognize contractual risks, e.g. rain days, standing time, etc. Detected risks are automatically added to the risk register.

Key features

- Captures: general information; resources on site; standing time; information received
- Advanced search facilities to track down deliveries, visitors, meetings, weather conditions and resources on site
- Risk triggers alert stakeholders when contractually significant circumstances are detected
- Immediate dissemination of site diary data to relevant stakeholders.

Risk Event Register

A "risk event" is a potential source of delay or unforeseen expense. Examples include: inclement weather, delays in receiving information, etc. The risk register is designed to request relevant information from the project team at the correct time. The cause and effect is captured, communicated and tracked on an on-going basis, allowing management to make informed decisions timeously and to ensure that any resulting contractual claims can be dealt with professionally and in a legally proper manner.

Key features

- Captures: cause; effect on resources; effect on progress; effect on programme; relevant correspondence
- Generates contractually correct notices
- Immediately alerts stakeholders of new risks via e-mail and/or SMS.

Requirements Schedule

A planning/collaboration tool which allows stakeholders to add items they require from other parties (e.g. access, drawings, free-issue materials, etc.). The requirements schedule monitors all parties' requirements, reminds parties via e-mail or SMS at appropriate times and tracks the fulfillment status of all requirements. When a requirement is not fulfilled on time the requirements schedule advises parties as to the appropriate course of action to take.

Key features

- Manages items you require and items required of you
- Sends e-mails on your behalf reminding other parties in advance of your requirements
- Monitors fulfilment and advises you of appropriate action when requirements are not fulfilled.

Library

It is imperative on any sizeable project to maintain proper records of all documentation as well as an accurate database of when such documents were created, received or sent. The Contract Communicator library is a robust document management system which facilitates the aforementioned. The library is populated by using the other components of Contract Communicator - documents/photos/videos are attached to risk events, site diaries, requirements, etc. and simultaneously loaded into the library for archiving and easy searching/retrieval.

Kev features

- · Captures: documents; photos; videos
- · Searchable by: keyword; uploader; date range
- Documents from the library can easily be attached to site diaries, risk events, notices, claims or requirements.

Reporting Services

The reporting services module offers an ever increasing array of customizable reports consisting of charts and tabular output. Cross-project reporting is available which greatly assists management in identifying problem projects and comparing projects side by side.
