This is important not only during tax season, but also at any time investors want to review their portfolios.

# Standardizing on the Adobe Flash Platform and the Adobe Digital Enterprise Platform

To provide clients with access to rich, highly interactive online services, Investment Café chose the Adobe Flash Platform and the Adobe Digital Enterprise Platform to build and deliver the Investment Café Reporting System. The dynamic system offers clients an intuitive solution that makes it easy for fund sponsors to disseminate information online to prospects during the fundraising process and to investors when the fund communicates and sends capital account statements, capital call letters, tax documents, and distributions.

While the company initially developed earlier versions of its reporting application in Adobe ColdFusion\*, Investment Café today has transitioned application development to Adobe Flex Builder" to take advantage of a richer environment. The enterprise rich Internet application (RIA) developed in Flex Builder enables investors and fund sponsors to securely log in to the application with a web browser, see pertinent information about a fund in real time, and generate detailed documents delivered as Portable Document Format (PDF) files.

Investment Café initially evaluated multiple development environments before deciding to expand its solutions on the Adobe Flash Platform. "The Adobe Flash Player is ubiquitous and doesn't require any special downloads or extra costs for our users," says Levey. "We can count on the Flash Player to let us reach investors with dynamic, timely information and still work within the confines of corporate security policies and firewalls."

For Investment Café, another advantage to using the Adobe Flash Platform is seamless support for PDF, an accepted financial industry standard for sharing and collaborating on documents.


## Making client services more efficient, secure, and reliable

The Investment Café Reporting System is focused on making fund sponsors more productive by automating a comprehensive set of processes associated with fund administration, particularly in the area of reporting, calling capital, and fund raising. The Adobe Flash Platform and the Digital Enterprise Platform enable this by supporting the delivery of integrated, easy-to-use functionality in the system.

For example, Investment Café delivers functionality that makes delivering capital call letters much more efficient, faster, and less error-prone. Traditionally, accountants, fund managers, and assistants worked many long hours to manually create, print, and deliver capital call letters.

The manual processes can be costly and stressful because there are many opportunities for mistakes. Every letter has to be personalized to reflect each investor's commitment level, and for security and privacy reasons, no letter can be accidentally sent to another investor. To further complicate the process, investors have a complex matrix of requirements, sometimes having multiple addresses and depending on the information being delivered, might want to receive it via the postal service, FedEx, fax, or e-mail.

The Investment Café system lets fund sponsors disseminate information online such as capital account statements, capital call letters, tax documents, and distributions. The combination of the Adobe Flash Platform and the Adobe Digital Enterprise Platform lets investment professionals generate and deliver highly personalized investor letters securely, and in minutes instead of hours or days. Its Contact Management application provides a rich, visual interface for updating client information or initiating service requests.

We also minimized risks by automating processes and eliminating many of the chances for human errors," says Levey.

Today, to initiate the capital call letter process, investment managers use the rich client interface developed using Flex Builder to identify each investor to receive a capital call letter, who at the investment firm needs to receive the file, where to send it, and via which method. The system automatically transfers the request using the Data Services capabilities in the Adobe Digital Enterprise Platform. Based on the requests, personalized and accurate capital call letters are generated and converted to PDF using PDF Generator capabilities in the Adobe Digital Enterprise Platform.

Using the interactive client interface that was developed using Flex Builder, investment managers can then complete the process by easily dragging-and-dropping the PDF files to onscreen icons for mailing, faxing, or e-mailing materials. "With Adobe solutions, we transformed time-consuming manual workflows into highly efficient automated processes that greatly improve staff productivity and client services," says Levey.

# Rich experiences, seamless integration across systems

The same streamlined processes benefiting the updated capital call process is evident in Investment Café's other applications. Its Contact Management application, for example, brings new ease to fund administration, providing managers with a richer, more visual interface for updating client information or initiating service requests, such as mailing holiday cards to investors.
