The Tourism Child-Protection Code of Conduct ([www.thecode.org](http://www.thecode.org)) is the only internationally accepted framework that can help your company effectively crack down on the sexual exploitation of children. To date, over 1,000 companies around the world have signed the Code -- including major hotel chains like Wyndham Worldwide Corporation, Hilton Worldwide, Accor, and Carlson Companies -- and I urge your property to be the next to join them. If you are a member of these brands, you can also receive training.

Putting an end to this abuse is important to me and I believe your company is in a unique position to make a difference in a very effective and visible way. I will follow up on your decision and this will be affecting my travel purchases in the future.
