## **Meeting Summary**

55<sup>th</sup> Olympic Board Meeting 30 April 2012 GCR1, DCMS

#### **Minutes:**

The minutes, actions and meeting summary from the Olympic Board meeting on 24 January were agreed.

#### **Performance Report:**

The Olympic Board noted the good progress that continues to be made across the programme, including:

- 27 January: Six months to go to the Olympic Opening Ceremony marked by the handover of the Olympic Village from ODA to LOCOG.
- o 15 February: First test event held on the Olympic Park Basketball invitational tournament
- 16 19 February: UCI Track Cycling World Cup held at the Velodrome
- o 18 February: Games Maker induction training begins.
- o 20 February: LOCOG take temporary ownership of the Olympic and Paralympic Sailing Village in Portland.
- o 28 February: Giant Olympic rings launched on the River Thames.
- o 19 March: Olympic Torchbearers and torch relay street route announced
- 22 March: TeamGB and ParalympicsGB kit unveiled.
- o 3 April: Construction of the Water Polo Arena complete.
- o 18 April: Conclusion of final IOC Coordination Commission visit to London
- o 23 April: Torch relay dress rehearsal held between Leicester and Peterborough.
- o 26 April: Full programme announced for London 2012 Festival
- o 27 April: Launch of Uniform Distribution and Accreditation Centre

#### Athlete preparations:

TIM REDDISH informed the Board that ParalympicsGB preparations were progressing well, with about 80 athletes selected so far and plans to have British representation for every sport and discipline, making the largest British team to ever take part in the Paralympics. The CHAIR provided an update on TeamGB on behalf of the BOA, noting that preparations were progressing well.

#### **Torch Relay Readiness:**

PAUL DEIGHTON updated the Board about preparations for the forthcoming Olympic Torch Relay, due to take place between 19 May and 27 July 2012. A readiness assessment had been circulated to the group in advance of the meeting, providing a comprehensive overview of each domain's status and the major risks, which were mainly around disruptive protest and large crowds. A dress rehearsal in April covered the relay stage between Leicester and Peterborough, and showed that the various organisations involved in organising and delivering the relay were working well together. The relay generated large crowds despite the lack of publicity.

#### **Communications Strategy:**

JACKIE BROCK-DOYLE and GODRIC SMITH presented the communications strategy for the last 100 days to the Board. Challenges remain about ensuring lasting pride in the Games and about striking the right tone at a time of economic difficulty. Messages about legacy in particular needed to be kept simple and consistent in order to maintain momentum. It was noted that LOCOG will look to consolidate and use existing milestones and events to further promote London 2012 over the next 100 days. Recent testing of integrated Games-time communications structures had been successful.
