2011 Highlights

Advocacy

- Supreme Court ruling: The Supreme Court of the United States ruled in June, 2011 that video games are entitled to the same First Amendment protections as other forms of art and expression. The IGDA had a key role in filing an amicus brief in this case.
- Amazon: The IGDA spoke out against Amazon's revised policies that allowed the company to change the pricing on developers' games without permission, among other things.
- SOPA/PIPA: After widespread outcry on the basis of free speech and restricting creativity, the Stop Online Piracy Act (SOPA) and Protect IP Act (PIPA) were postponed from approval in the U.S. Congress.

Leadership Forum

The 5th annual IGDA Leadership Forum organized by the Production SIG was held in October 2011 in Los Angeles, California.
