




CAMP MISSION STATEMENT

Youth On the Go is a camp designed for campers that have outgrown Camp Pine Tree and are seeking more age appropriate activities. Hercules is acclaimed as the mightiest hero of all time after he defeats the many-headed Hydra, the screeching Stymphalian Birds, and the Big Bad Boar. EXTENDED CARE OPTIONS



BEFORE CARE Ages 3-14

Before Care is an extended-day offering available to children enrolled in a City of Greenbelt summer day camp. It is offered from 7:00am until the beginning of the camp day, and is lightly structured. The before care area for each camp is located in the building where the individual camp is being held.

FEES: \$50 per two-week session

\$25 per one-week session

AFTER CARE

After care is available to participants in any of the Greenbelt Recreation Department summer camps. Lightly structured activity and free play areas are supervised by camp staff and a nutritious snack will be provided. See table below for the aftercare details for each camp.

Clay at the End of the Day

For campers who are interested in pottery and ceramic arts, these classes offer an alternative to traditional after-care. Campers ages 6-9 will learn hand-building and decoration techniques, creating sculpture and pottery. Children ages 11 to 14 will receive an introductory course in the use of the potter's wheel. Ten-year-old campers may participate in either class, according to their experience and abilities. Children may be picked up in the Community Center Multipurpose Room (201) at 5:15pm. Inside tip: learning to throw pots on the wheel is great fun, but also challenging - even for adults! The process requires strength, fine motor control and concentration. Youth wheel classes are a great opportunity for students who can maintain focus for extended periods of time, who are receptive to instruction and who are resilient in overcoming mistakes.

REGISTRATION PROCEDURES FOR DAY CAMPS

Camp Registration procedures are outlined below.

CAMPER REGISTRATION FORMS ARE AVAILABLE in this brochure or online at www.greenbeltmd.gov. Forms also may be picked up at the Greenbelt Youth Center and the Greenbelt Community Center during all facility hours. We recommend that you fill out the forms at home where you have access to necessary information such as medication data, date of last tetanus shot, and emergency contact numbers.

COMPLETED REGISTRATION FORMS can be submitted by mail, by fax, or in person. Forms will be accepted from Greenbelt residents* beginning on February 4 and from non-residents beginning on February 19. Mail-in registrations and faxed registrations will be dated and entered accordingly. Camper registration forms will be accepted on an ongoing basis until all slots are filled. At that point, interested persons' names will be placed on a waiting list. Those persons will be contacted in the order in which names were taken if/when a slot becomes available.

- * GREENBELT RESIDENCY: In order to qualify to receive the resident rates as listed in this brochure, you MUST provide CURRENT proof of Greenbelt residency in the form of a driver's license, MVA change of address form with a driver's license, or a lease. If you are unable to provide one of these documents at the time of registration, you will be charged the non resident rate.

A **DEPOSIT** of \$50 per child/per camp session is required at the time of registration for SUMMER Camp sessions. SPRING CAMP and Spring Circus Camp payment is due in full at time of registration.
