Best practices

Consolidate your Software Assurance coverage and save money.

If you are a customer with multiple Microsoft licensing agreements, you may need to manage various Software Assurance expiration dates—we understand that at times this makes it difficult to track versions and control your budget.

You may be eligible to consolidate your multiple agreements into a single Volume Licensing agreement. This consolidation enables you to reduce the overall number of agreements you must manage and track, thereby reducing the risk of allowing your Software Assurance coverage to lapse in the future.
