II. Declare Election Results of April 9, 2013 Election

A tabulation of votes cast for Lincoln Land Community College Board of Trustee candidates for Trustee District 1, Trustee District 2, Trustee District 3, Trustee District 4, Trustee District 5, Trustee District 6 and Trustee District 7 in the April 9, 2013 election, as submitted by the applicable county election authorities, has been completed by Vice President Vertrees. A summary tabulation by county and candidate, along with an analysis by precinct and candidate, within each Trustee District, is on file in the Vice President of Administrative Services office.

• to proclaim that a total of <u>48,730</u> voters requested and received ballots for the consolidated election for seven members of the Board of Trustees for Trustee Districts 1, 2, 3, 4, 5, 6 and 7 held on April 9, 2013, and to certify that <u>Justin Reichert</u> from Trustee District 1 received <u>2003</u> votes, <u>Dennis Shackelford</u> from Trustee District 2 received <u>3537</u> votes, <u>Kent Gray</u> from Trustee District 3 received <u>4922</u> votes, <u>Wayne Rosenthal</u> from Trustee District 4 received <u>7848</u> votes, <u>Jeff Fulgenzi</u> from Trustee District 5 received <u>5663</u> votes, <u>Craig Findley</u> from Trustee District 6 received <u>6677</u> votes and <u>Jerry Wesley</u> from Trustee District 7 received <u>5806</u> votes; and

certify <u>Kent Gray</u>, <u>Jeff Fulgenzi</u>, <u>Craig Findley</u> and <u>Jerry Wesley</u> as having been elected to serve four-year terms as members of the Lincoln Land Community College Board of Trustees and <u>Justin Reichert</u>, <u>Dennis Shackelford</u> and <u>Wayne Rosenthal</u> as having been elected to serve six-year terms as members of the Lincoln Land Community College Board of Trustees.
