

Panelists Named to History Fund Review Committee Panel to Recommend Recipients of Grant Funds for Local & State Projects

COLUMBUS—The Ohio Historical Society is pleased to announce the Ohioans who will serve on the panel to evaluate History Fund grant applications and make recommendations to award over \$100,000 in funding for local and state history projects.

The <u>History Fund</u> is a competitive matching grants program that is one of four "tax check-off" funds found on Ohio's income tax forms. Grant funds are available thanks to the nearly 16,000 Ohioans who voluntarily contributed an average of \$8 per person to the History Fund in 2013 (tax year 2012), the second year of operation for this new program.

"There is real demand for this program. The History Fund has received 64 applications for \$788,000 in grant requests," said Andy Verhoff, History Fund Grant Manager for the Ohio Historical Society. "Our panelists' experience and recommendations will help the Society support outstanding projects. We hope great projects plus high demand for grants will inspire more "tax check-off" and History Fund support in 2014," he continued. The panel will hold its meeting at the Ohio History Center in Columbus January 15- 16 at which it will make funding recommendations. The meeting is open to the public. The Ohio Historical Society serves as the administrator of the History Fund and cannot apply for grant funds. Recipients of History Fund grants will be announced on Statehood Day, February 27, 2014. Project may begin as early as May 2014 (allowable project duration is 12-24 months).

ABOUT THE HISTORY FUND

Also known as the "tax check-off," the History Fund was developed to support the preservation and sharing of Ohio's heritage by funding local, regional, and statewide projects, programs, and events related to the state's history. It was created in the state's two-year budget that was signed into law by Gov. John R. Kasich on June 30, 2011. The legislation allowing for the change in state tax forms was initially brought to the General Assembly by former State Rep. Kathleen Chandler (D-Kent) in 2005. State Rep. Randy Gardner (R-Bowling Green) reintroduced in 2011 before it was enacted in the state budget. On previous year's state IT-1040 tax return forms, Ohio residents have had the option of donating to causes such as wildlife conservation, nature preserves, scenic rivers, and the protection of endangered species. The History Fund joined these programs on the 2011 Ohio tax form and will be on future tax forms, providing Ohioans with a simple way to help preserve their state's history.
