JERUSALEMA May 25-A girl friend's 20-year-old photo of Adolf Eichmann was reported today to have trapped the alleged Nazi killer of 6 infilien Jews.

The report appeared in Davar, the newspaper of Premier David Ben Gurion.

It said Israeli intelligence agents followed up 100 tips before finding Eichmann and identifying him from the old photo.

Davar said the hunt was started by Asher Ben-Nathan. now director-general of the Defense Ministry, when he was acting for the Jewish underground organization Hagana at the end of Werid War II.

He obtained from Eichmann's girl friend the only clear photograph of him. Although it was 20 years old. it left little doubt of his ideatity when he was traced.

#### Watched for Baby-Face

Intelligence hogonts were told to watch for a baby-face. with a slightly twisted lower lip, effeminate features, 2 high forehead and receding

They shadowed him for a long time before arresting him, studying his habits, work and daily routine.

The shock of capture shattered him, the paper said, and it was some time before he recovered enough to talk to his captors.
